- "(3) Any amount standing to the credit of the-
- (a) House of Assembly of the State; and
- (b) Judiciary;

in the Consolidated Revenue Fund of the State shall be paid directly to the said bodies respectively; in the case of judiciary, such amount shall be paid directly the heads of the courts concerned."
