INTRODUCTION

At the commencement of the 7th National Assembly in 2011, the House of Representatives under the leadership of the Speaker, Rt. Hon. Aminu Waziri Tambuwal adopted a Legislative Agenda to enable the House deliver on their legislative goals, which included passage of priority reform bills. This publication provides information on the progress of bills introduced to the 7th House of Representatives beginning June 2011 up until May 2015 when the 7th National Assembly officially winds down. It details the status of the bills and the actions taken on each. It is hoped that this document will be a useful reference material for incoming Members of the 8th House of Representatives and members of the public.

POLICY AND LEGAL ADVOCACY CENTRE (PLAC)

Explanation of Terms

“Sponsor(s)” refers to the legislator or group of legislators who supported or introduced a particular bill before the House. Bills may also be sponsored by the Executive and introduced by the Leader of the House

“Debate on General Principles” a debate on the general principles of a bill occurs during the second reading where the significance or relevance of the bill is highlighted and arguments marshaled by the sponsor to convince other members to support the passage of the bill.

“Committee(s) Referred” means the Special, Standing or Ad-hoc Committee of the House that a bill is forwarded to for more legislative input and to report back to the House within a given time frame.

“Date Reported out of Committee” refers to the date a Committee’s Report in respect of a bill is formally listed in the Order Paper of the House and presented at plenary by the Chairman of the Committee for consideration by the House. The report could include proposed amendments and other recommendations on the bill.

“Conference Reports Adopted” Conference Reports emanate from a Conference Committee set up by both Chambers of the National Assembly to harmonise differences in a bill which has been passed by both Chambers but with some differences.

“Adjourned Consideration” this may happen during a clause-by-clause consideration of a Committee’s report respecting a particular bill before the Committee of the Whole House. Where such considerations could not be concluded on a particular day, it may be adjourned to another legislative day.

“Adjourned Debate” this means that the deliberation or argument on the general principles of a bill could not be concluded on the day the debate commenced but had to be continued on another day.

“Bill Negatived” a negatived bill is one, which is being rejected by majority of lawmakers or which fails to pass through the second reading stage

“Bill Withdrawn” means the sponsor of the bill, for reasons have decided to discontinue with the process of a bill’s passage. Where this happens, the House would stop further consideration of the bill

“Report on Bill Laid On Table” refers to the presentation for consideration before the House, the Report of the Committee to which a bill was referred for further legislative input after being passed for second reading

“Yet to be Reported out of the Committee” this means that the Committee to which a bill was referred for further input has yet to report back to the House its observations or recommendations on the bill
