**REPORT OF THE CONFERENCE COMMITTEE ON THE FEDERAL
CAPITAL TERRITORY HOSPITALS MANAGEMENT BOARD
(ESTABLISHMENT, ETC.) BILL, 2019 (SB 69)**

1:0 INTRODUCTION

The Federal Capital Territory Hospitals Management Board (Establishment, Etc.) Bill, 2016 originated from the House of Representatives. It was passed on 1st June, 2016 and transmitted to the Senate for concurrence.

The Senate passed the Bill on Wednesday, 12th July, 2017 with difference. Consequently, a Conference Committee was constituted in the Senate on Thursday, 20th July, 2017 to reconcile the areas of differences, which appeared essentially in one (1) clause of the Bill.

The purpose of the Conference Committee was to harmonize the area of difference that was observed in the two versions of the Bill passed by both Chambers, and make appropriate recommendations for adoption by the two Chambers.

Clause 17:

Clause 17(b) deals with the expansion of the departments of the board from ten (10) to twelve (12) departments. After extensive deliberation, the Conference Committee adopted the Senate version. The Senate version expanded the scope of the departments to include Cardiovascular and Orthopedic departments.

4:0 RECOMMENDATION

The Conference Committee hereby recommends for adoption and passage into law, the harmonized version of the Bill and recommendation as follows:

"That the Senate do consider and adopt the Conference Report on a Bill for an Act to provide for the Establishment of the Hospitals Management Board of the Federal Capital Territory and for matters connected therewith, 2019 (SB 69)"
