CONFERENCE COMMITTEE REPORT ON A BILL FOR AN ACT TO AMEND THE AGRICULTURAL CREDIT GUARANTEE SCHEME FUND ACT 2016

1.0 Introduction

The Bill seeks to amend the Agricultural Credit Guarantee Scheme Fund Act, CAP. A11, Laws of the Federation of Nigeria, 2004 to enhance the Capital base, expand the coverage, increase the size of the loanable Fund, give more powers to the Board; and for other related matters, 2017. A Conference Committee was announced in plenary on Tuesday 1st November, 2016 and Thursday 17th November, 2016 for the Senate and House of Representatives respectively to harmonize the differences in the Bill.
