- (a) A Bill for an Act to Amend the Child's Rights Act, Cap. C50, Laws of the Federation of Nigeria, 2004 to Provide for the Eligibility of Foreigners, whether Resident or Non-Resident in Nigeria as well as Nigerian Citizens not Resident in Nigeria to Adopt a Child, and to include the Prohibition of Sale of Alcohol by or to a Minor, Prohibit the Purchase of Alcohol for a Minor, Grant Police the Right to Confiscate Alcohol found in Possession of a Minor; and for Related Matters (HBS. 456 and 604) (*Hon.
