Matter of Urgent Public Importance (Standing Order VIII, Rule 46) Urgent Intervention in the Devastating Hurricane that Violently Stormed with very Strong Winds Destroying over 200 Houses and Farm Produce in Gamawa Federal Constituency of Bauchi State: Hon. Mohammed Garba Gololo (Gamawa Federal Constituency) introduced the matter and prayed the House to:

- (a) consider and approve the matter as one of urgent public importance; and
- (b) suspend Order VIII, Rules 46 (3) and 49 to allow debate on the matter forthwith.

Urgent Intervention in the Devastating Hurricane that Violently Stormed with Very Strong Winds Destroying over 200 Houses and Farm Produce in Gamawa Federal Constituency of Bauchi State:

The House:

Notes that a devastating Hurricane violently stormed some communities in Gamawa Federal Constituency with very strong wind destroying over 200 houses, farm produce and has impacted negatively on the people;

Also notes that some communities in Gamawa Federal Constituency are without shelter amidst rainfall as a result of this strong Hurricane storm;

Aware that the majority of the indigenes and residents of the affected communities have become homeless and seeking refuge as their Houses are destroyed;

Informed that the extent of destruction is in excess of \(\frac{14}{100}\) million;

Concerned that this situation could destabilize and jeopardize the livelihood of the indigenes and their economic activities;

Desirous of alleviating the suffering and losses of the affected communities; and ensuring that such disaster does not re-occur;

Resolves to:

- (i) Commiserate with the affected communities;
- (ii) urge the National Emergency Management Agency (NEMA) to urgently provide relief and support to the affected communities; and
- (iii) mandate the Committees on Works, and Environment and Habitat to visit the communities and to investigate the cause of the Hurricane and recommend a permanent solution to the House within six weeks (Hon. Mohammed Garba Gololo Gamawa Federal Constituency).

- (ii) urge the National Emergency Management Agency (NEMA) to urgently provide relief and support to the affected communities; and
- (iii) mandate the Committees on Works, and Environment and Habitat to visit the communities and to investigate the cause of the Hurricane and recommend a permanent solution to the House within six weeks (HR. 06/2016).

Also notes that the proven Coal reserves so far in Nigeria total about 639 million metric tons while the inferred reserves sum up to 2.75 billion metric tons, and presently, the Nigeria's Coal Industry has 4 existing mines, namely Okpara and Onyeama Underground Mines in Enugu State, Aba surface mine in Kogi State and Owukpa underground mine in Benue State, in addition to more than 13 undeveloped Coal fields;

Aware that Coal has many important uses, the most significant of which is in electricity generation as around 7.1 billion tons were used worldwide in 2010, for that purpose; and its share as the biggest single source of energy for electricity production is growing;

Concerned that there has been an un-ending fall in electricity generation which worsened on Thursday, 24 March, 2016 when there occurred a total system collapse at exactly 1.00 p.m., when the nation went to ground zero, with all the Distribution Companies (DISCOs) receiving zero MW allocation from the System Operator;

Also concerned that this never-ending fall in electricity generation has been attributed to vandalism of gas pipelines and the on-going difficulty in the downstream oil industry is also impacting negatively on the power sector which is strategic for increasing the competitiveness of the Nigerian economy;

Observes that greater investments of resources in the power sector would ultimately result in improvement of the economy and therefore well-being of the nation;

Cognizant that considering the prevailing situation, power sector initiative cannot be done with the desired big bang without the Federal Government providing leadership in a sustainable way;

The House:

Notes that the Federal Government had recently conceptualized and undertaken a centenary city development project which was allegedly piloted by the Office of the then Secretary to the Government of the Federation;

Concerned that the centenary city project was marred with irregularities which may have cost the Federal Government and Federal Capital Development Administration Billions of Naira of revenues and loss of thousands of hectares of land;

Resolves to:

Mandate the Committee on Federal Capital Territory to undertake an investigation to determine whether the centenary city project was carried out in accordance with the extant laws, rules and in the best interest of Nigeria, and report back to the House within one month for further legislative action (Hon. Timothy Golu — Paskshin/Kanke/Kanam Federal Constituency).

Debate.

Resolved to:

Mandate the Committee on Federal Capital Territory to undertake an investigation to determine whether the centenary city project was carried out in accordance with the extant laws, rules and in the best interest of Nigeria, and report back to the House within one month for further legislative action (HR. 08/2016).

14. Need for an Improved Funding for the Amnesty Programme and a Suitable Strategic Plan to End Militancy in the Niger Delta

Motion made and Question proposed:

The House:

Notes that the incidents of militancy in the Niger Delta between 2006 and 2009 cut Nigeria's oil production by more than a quarter to around 1.6 mbd;

Also notes that as a result of the militancy, the late President UmaruYar'Adua introduced the Amnesty Programme in 2009 where about 30,000 militants who had sabotaged oil facilities for years laid down their arms and embraced the amnesty programme;

Aware that the peace achieved as a result of the 2009 Amnesty Programme brought about a rebound in oil output from around 1.6 mbd to about 2.8 mbd, resulting in higher oil revenues for Nigeria;

Worried that the \$\frac{\text{\text{N}}}{20,000,000,000,000.00} proposed by the Federal Government for the Presidential Amnesty Office in 2016 budget is lower than the \$\frac{\text{\text{\text{\text{N}}}}{55,824,488,493.27} proposed by the Presidential Amnesty Office and the amount is grossly inadequate to sustain the payment of stipends to 25,000 ex-agitators, pay in-training allowances, tuition fees and other commitments;

Also worried that this massive cut from the proposed \$\frac{1.55}{1.55}.824,488,493,27\$ of the Amnesty Office has threatened the sustainability of the amnesty programme and this has led to a resurgence of militancy as the militants are being owed arrears of stipends which has in turn led to slump in oil production which fell to 1.76 mbd in February, 1.68 mbd in March and 1.62 in April, according to the International Energy Agency;

Concerned that an explosion caused by acts of militancy forced Chevron Corporation to close a near-shore valve platform that had been handling 35,000 b/d of crude;

Also concerned that Shell Petroleum Development Corporation declared a force majeure on exports of Bonny Light crude after the Nembe Creek Trunk line was damaged by militants and the closure affected 75,000-78,000 b/d of crude;

Disturbed that acts of militancy in February led to a marine pipeline cut flow through the important Forcados Crude Oil Terminal by as much as 250,000 b/d;

Also disturbed that on 22 May, 2016, militants bombed the Tebidaba to Brass pipeline belonging to the Nigerian Agip Oil Company at Ikienghenbiri community in Southern Ijaw Local Government Area of Bayelsa State for the second time in one week;

Observes that the attacks, which have also targeted gas infrastructure in the region, have also impacted negatively on electricity output in the form of thermal power stations that are reliant on gas to power their turbines;

Also observes that the incessant attacks on oil facilities has led to Nigeria losing its place as Africa's largest oil producer because its oil output has fallen to a 22-year low of 1.4 million barrels per day against the budgetary target of 2.2mbpd, and by 1 June, 2016, it was about 990,000 barrel per day;

Resolves to:

- Urge the Federal Government to formulate a sustainable plan to end militancy in the Niger Delta rather than the confrontational approaches so far adopted; and
- also urge the leadership of the House to interface with the Federal Government with a view to assisting in securing the additional \frac{1}{25},824,488,493.27 shortfall for the Amnesty Office (Hon. Ekpenyong Essien Ayi Calabar South/Akpabuyo/Bakassi Federal Constituency and 29 Others).

(iii) Leave out all the words in Prayer (ii), and insert as follows instead thereof: "Urge the Federal Government to make available the shortfall of ₹35,824,488,493.27 to enable the Amnesty office pay the Ex-militants" (Hon. Oluwole Oke — Obokun/Oriade Federal Constituency).

Question that the amendment be made — Agreed to.

Worried that the ₹20,000,000,000.00 proposed by the Federal Government for the Presidential Amnesty Office in 2016 budget is lower than the ₹55,824,488,493.27 proposed by the Presidential Amnesty Office and the amount is grossly inadequate to sustain the payment of stipends to 25,000 ex-agitators, pay in-training allowances, tuition fees and other commitments;

Also worried that this massive cut from the proposed \$\frac{155}{824}\$,488,493,27 of the Amnesty Office has threatened the sustainability of the amnesty programme and this has led to a resurgence of militancy as the militants are being owed arrears of stipends which has in turn led to slump in oil production which fell to 1.76 mbd in February, 1.68 mbd in March and 1.62 in April, according to the International Energy Agency;

Concerned that an explosion caused by acts of militancy forced Chevron Corporation to close a near-shore valve platform that had been handling 35,000 b/d of crude;

Also concerned that Shell Petroleum Development Corporation declared a force majeure on exports of Bonny Light crude after the Nembe Creek Trunk line was damaged by militants and the closure affected 75,000-78,000 b/d of crude;
