The House:

Notes that as part of the campaign by the Indigenous People of Biafra (IPOB) for the actualization of Biafra Republic, Biafra Agitators called on their people to come home and shut down major towns in the South East on May 30, 2017;

Disturbed that Sixteen Northern Youth groups rose from a joint meeting in Kaduna on the 6th of June and gave Igbo residing in their states up to October 1, 2017 to vacate the region days after the shutting down of major towns in the South East;

Also disturbed that in its reaction, the Movement for the Actualization of Sovereign State of Biafra (MASSOB) said it received with gladness the "quit notice" and urged the Igbo to return home immediately;

Concerned that the two calls create alarming twist which is ominous and dangerous for the good health of Nigerians;

Also Concerned that this motion is not interested in the merit or demerit of Biafra, nor is it interested in apportioning blame on those who made the two unpatriotic calls; rather this is only concern for the nation's leaders to immediately intervene to stop these agitations from resorting to violence that may consume the entire nation, and for the National Assembly and

the Presidency to wade into the issue by dialogue with the protagonist of "come and leave our land" and the "return home immediately" groups to avoid damage to our collective nationhood;

Aware that all Nigerians especially the Ibos have enormous amount of investment allover the country! the two calls will lead to loss of trillions of Naira, dislocation of the lives of people who have lived in different parts of Nigeria for several decades because peoples cannot carry their houses, properties, business and families from their abode in a short frame of time;

Also aware that while people have the right to their views and decisions about their lives, as an institution of government, the National Assembly must rise to the occasion we find ourselves and put an end to the confusion that is brevving by appealing to both parties to withdraw their demands in order to avoid loss of lives, especially those of innocent children, women and the feeble who are not part of the problem;

Resolves to:

- (i) condemn in strong terms the stance of the sixteen Northern Youth groups and IPOB on the issue and call on both parties to rescind their decision; and
- (ii) call on the Federal Government to wade into the issue on time to avoid the loss of lives and properties that the actualization of the parties' threat may occasion (*Hon. Oghene Emma Egoh — Amuwo Odofin Federal Constituency*).

Need to Investigate and Halt the Illegal Mining Activities in Kampani-Zurak in Wase LGA of Plateau State:

The House:

Notes the policy thrust of the current Administration in terms of economic diversification, blockage of leakages in sources of government revenues and fighting corruption in all its manifestations;

Also notes that Mining sector is a viable alternative source of revenue for government to create jobs, boost investment and promote socio-economic development;

Informed that the illegal mining activities occurring in Kampani Zurak of Wase LGA of Plateau State has resulted in serious environmental degradation of the communities through the abandonment of mining pits which expose the communities to different toxic wastes. This has led to loss of farmlands and other means of subsistence for the community and also resulted in loss of billions of Naira in government revenue;

Also informed that Community Development Agreements (which are required by Section 116 of the Nigerian Minerals and Mining Act, 2007, to ensure the protection and socio-economic development of the host community where mining activities are conducted) are usually not entered into with the host community because of the illegal nature of these mining activities;

Aware that some of these illegal miners are aided and protected by some unscrupulous security agents from the police and army who turn a blind eye to their activities and even give them cover;

Appreciate that Honourable Speaker, Rt Hon. Yakubu Dogara took time out of his tight schedule to visit the mining communities of Kampani-Zurak thereby acquiring a first-hand information of the dire nature of these activities and drawing public attention to it;

Also appreciate the commendable effort of the Governor of Plateau State, His Excellency, Simon Lalong, in stemming the activities of these illegal miners;

Disturbed that if these illegal miners and the security agents that aid them are left unchecked, the communities will continue to suffer serious environmental hazard, poverty and untold hardship due to the destruction of their farmlands and other means of sustenance;

Also disturbed that such illegal mining if left unchecked will continue the massive loss of revenue for the country thereby shortchanging the nation's commonwealth;

Resolves to:

- (i) urge the Honorable Minister of Mines and Steel Development, the Honorable Minister of Defense, Office of the National Security Adviser and the Inspector General of Police to ensure the evacuation/sealing-off, arrest and prosecution of all illegal miners from Kampani-Zurak in Wase LGA of Plateau State;
- (ii) also urge the above security agencies to investigate and review the deployment schedule of Security agents in Plateau State Commands and Kampani Zurak to be specific in order to forestall connivance from some Security agents;
- (iii) further urge the creation of a Special Task Force to check illegal mining activities in Kampani-Zurak in Wase LGA of Plateau State;
- (iv) still urge the Federal Ministry of Environment to investigate and assess the level of environmental degradation caused in Kampani Zurak by the activities of these illegal miners with a view to reclaiming and restoring the natural environment and saving the people from toxic impacts of these activities;
- (v) again urge the Federal Ministry of Power, Works and Housing, on the need for an immediate Construction of Jarmai-Bashar-Zurak-Andame (in Karim Lamido LGA of Taraba State) road, and Langtang-Wase-Bashar Road to ease movement of resources by those engaged in lawful and legal mining activities and to further check smuggling by illegal miners;

- (vi) mandate the Committees on Legislative Compliance, Mines and Steel, Army, Defense, Police Affairs, Intelligence, Environment and Habitat, and Works to monitor the implementation of these resolutions and report progress to the House within two (2) weeks (*Hon. Ahmed Idris — Wase Federal Constituency*).

12. **Call for Reconstruction of Dilapidated Parts of Okpella-Auchi-Ekpoma-Benin Federal Highway**

The House:

Notes that the Federal Highway that runs through Okpella to Benin is a major artery that cuts across the three Senatorial Districts of Edo State and links the North, East and Western parts of Nigeria;

Aware that the deplorable state of the highway has been the major cause of vehicular accidents which has led to the loss of many lives and destruction of properties worth millions of Naira and is also affording criminals opportunity to kidnap motorists;

Also aware that when the road was in good condition, it used to take less than an hour to travel from Okpella to Benin, but now, it takes at least four hours to cover the same distance, if there is free flow of traffic;

Concerned that with the on-set of the rainy season, the road is likely to worsen or even some parts cut off, with the resultant effects of more accidents and destruction of properties, and also motorists having to spend longer hours due to traffic jam;

Resolves to:

- (i) urge the Federal Roads Maintenance Agency (FERMA) to commence reconstruction of the road; and
- (ii) mandate the Committee on FERMA to ensure implementation and report back in three (3) weeks for further legislative action (*Hon. Johnson Egwakhide Oghuma — Etsako East/Etsako West/Etsako Central Federal Constituency and 8 others*).

Agreed to.

13. Need to Provide Potable Water, Medications, and other Relief Materials for the Internally Displaced Persons (IDPs) in Banki Town, Bama Local Government Area of Borno State:

Motion made and Question proposed;

The House:

Notes that Banki town is one of the gateway of international trade and had been a centre of commerce for decades but, it was turned into a battle ground by the Boko Haram terrorists who occupied the area for nine months before they were dislodged by the military aided by the civilian joint task force members;

Also notes that the insurgency in the north-east zone created over two million Internally Displaced Persons (IDPs) from various states in the zone and Banki town alone accounted for over one hundred thousand of them;

Aware that in the last three weeks, over fifteen thousand Internally Displaced Persons (IDPs) voluntarily returned to Banki town, while over five thousand of them were forced to leave the Cameroon by the Cameroonian Government and given their large number, the International Committee of Red Cross (ICRC), the Medecins Sans Frontiers, Doctors Without Borders and other non-governmental organisations that have been rendering assistance to the IDPs are overstretched in meeting their needs and demands;

Also aware that it is not all the Internally Displaced Persons (IDPs) currently in Banki town that are from Banki as a substantial number are from all the surrounding areas of Andara, Kumshe, Kote, Bomari, Walasa, Gulumba and Zanageri Kash Kash, which are in the Sambisa axis in Bama Local Government Area;

Cognizant that despite accommodating over one hundred thousand Internally Displaced Persons (IDPs), the town has only one bore hole that provides water and sometimes it takes the Internally Displaced Persons (IDPs) the whole day queuing and at times, ending up without getting water;

Also cognizant that due to poor sanitation, lack access to potable water and proper medications, and poor feeding, there is an outbreak of epidemic diseases, thirst and hunger among the Internally Displaced Persons (IDPs) in Banki town;

Concerned that majority of those vulnerable Internally Displaced Persons (IDPs) are women and children, along with some elderly people, who were recently rescued by gallant troops and civilian Joint Task Force members from long period of captivity during which they were traumatized, tortured and even assaulted in many forms;

Resolves to:

- (i) urge the National Emergency Management Agency (NEMA), the Presidential Committee on the North East Initiative, the Victim Support Fund Team (VSF Team), the National Commission for Refugees, and other Government related bodies to urgently provide medications and other relief materials to the Internally Displaced Persons (IDPs) in Banki town, Bama Local Government Area, Borno State;
- (ii) also urge the Federal Ministry of Water Resources to drill bore holes so as to provide potable water for them; and
- (iii) mandate the Committees on Internally Displaced Persons (IDPs), Refugees and Initiatives on North East Zone, and Water Resources to ensure compliance (*Hon. Mohammed Nur Sheriff — Bama/Ngala/Kalabalge Federal Constituency and 8 others*).

Agreed to.

Also notes that the activities of those criminal syndicates have assumed a wider dimension in and around communities in Chikun/Kajuru Federal Constituency and have impacted adversely on the socio-economic lives of the people as they can no longer move freely to transact their legitimate businesses for fear of being kidnaped;

Recalls that on Friday, 2 June, 2017, one Mrs Sara Amos, her son Jesse and a family member, Mr Isaac Michael were kidnaped in Kagurdna-Kakau community and in their escape bid with the victims, the kidnappers killed a member of the local vigilante team named Yakubu Adamu and are now demanding for the sum of 20 million Naira as ransom for their release;

Also recalls other incidents of kidnaping of several other people, some of whom were released after ransom was allegedly paid while others are still being held in expectation of ransom;

Concerned that the activities of the kidnappers are becoming nightmarish for the people who can no longer go to their farms freely, with the obvious consequences of shortage of food that will result in hunger and untold hardship;

Resolves to:

- (i) urge the Inspector-General of Police to direct the Commissioner of Police, Kaduna State to constitute a search team for the rescue of the victims in custody of these criminal syndicates;
- (ii) also urge the Chief of Army Staff, the Chief of Air Staff and the Inspector-General of Police to form a joint task force to comb the area, apprehend and ensure the prosecution of these criminals; and
- (iii) mandate the Committees on Police Affairs, Army, and Air Force to ensure compliance and report back in three (3) weeks for further legislative action (*Hon. Yakubu Umar Barde — Kajuru/Chikun Federal Constituency*).

Debate.
