A Bill for an Act to Authorize the issue from the Statutory Revenue Fund of the Nigeria Customs Service, the Total Sum of ₦80,640,598,088.72 (Eighty Billion, Six Hundred and Forty Million, Five Hundred and Ninety-Eight Thousand, Eighty-Eight Naira, Seventy-Two Kobo) only, of which the sum of ₦44,023,409,385.40 (Forty-Four Billion, Twenty-Three Million, Four Hundred and Nine Thousand, Three Hundred and Eighty-Five Naira, Forty Kobo) only, is for Personnel Cost, the sum of ₦12,541,558,539.02 (Twelve Billion, Five Hundred and Forty-One Million, Five Hundred and Fifty-Eight Thousand, Five Hundred and Thirty-Nine Naira, Two Kobo) only is for Over Head Costs while the Sum of ₦24,076,000,000.00 (Twenty-Four Billion, Seventy-Six Million Naira) only is for is for Capital Expenditure for the Year Ending on 31 December, 2017 (HB.1096) (Leader) — *Second Reading.*

MOTION

2. **Need to Encourage the Use of Indigenous Languages in the Nation's Educational Institutions:**
Hon. Mark Terseer Gbillah:

The House:

Notes that language is a symbol of cultural identity and heritage and that Nigeria has over two hundred and fifty (250) local languages but English is the official language;

Aware that the educational curriculum makes the study of foreign languages compulsory in primary and secondary schools but our indigenous languages are not accorded the same status;

Also aware that the Curriculum from the National Universities Commission makes it compulsory for Financial/Business courses to have two foreign languages components with effect from September 2017;

Concerned by the primacy of place the nation's educational curriculum accords foreign languages by compelling institutions, including primary, secondary and tertiary to teach them, thereby promoting foreign rather than indigenous languages;

Resolves to:

- (i) urge the Federal Ministry of Education, the Nigerian Educational Research and Development Council (NERDC) and the National Universities Commission (NUC) to replace foreign languages with indigenous languages where they had been made compulsory in courses other than language courses/ degrees and make foreign languages optional for students pursuing Financial/Business degrees; and
- (ii) mandate the Committees on Basic Education and Services and Tertiary Education and Services to ensure implementation and report back in six (6) weeks for further legislative action.

A Bill for an Act to Authorize the issue from the Statutory Revenue Fund of the Nigeria Customs Service, the Total Sum of ₦80,640,598,088.72 (Eighty Billion, Six Hundred and Forty Million Five Hundred and Ninety-Eight Thousand, Eighty-Eight Naira, Seventy-Two Kobo) only, of which the sum of ₦44,023,409,385.40 (Forty-Four Billion, Twenty-Three Million, Four Hundred and Nine Thousand, Three Hundred and Eight-Five Naira, Forty Kobo) only, is for Personnel Cost, the sum of ₦12,541,558,539.02 (Twelve Billion, Five Hundred and Forty-One Million, Five Hundred and Fifty-Eight Thousand, Five Hundred and Thirty-Nine Naira, Two Kobo) only, is for Over Head Costs while the Sum of ₦24,076,000,000.00 (Twenty-Four Billion, Seventy-Six Million Naira) only, is for is for Capital Expenditure for the Year Ending on 31 December, 2017 (HB.1096):

Clause 1: Issue from the Statutory Revenue Fund of the Nigeria Customs Service, the Total Sum of ₦80,640,598,088.72 (Eighty Billion, Six Hundred and Forty Million, Five Hundred and Ninety-Eight Thousand, Eighty-Eight Naira, Seventy-Two Kobo) only for the Year Ending on 31 December, 2017.

- (i) The Comptroller-General of the Nigeria Customs Service shall by warrant pay out of the Statutory Revenue Fund of the Service during the year ending on 31 December, 2017, the sums specified by the warrants not exceeding in the aggregate ₦80,640,598,088.72 (Eighty Billion, Six Hundred and Forty Million, Five Hundred and Ninety-Eight Thousand, Eighty-Eight Naira, Seventy-Two Kobo) only, from the Statutory Revenue Fund of the Nigeria Customs Service for the year 2017.
- (ii) The amount mentioned in subsection (i) shall be appropriated to heads of expenditures as indicated in the schedule to this Bill.
- (iii) No part of the amount above mentioned shall be released from the Statutory Revenue Fund of the Nigeria Customs Service after the end of the year mentioned in the Schedule to this Bill.

Clause 2: Release of Fund from the Nigeria Customs Service.

All amounts appropriated under this Bill shall be released from the Statutory Revenue Fund of the Nigeria Customs Service only for the purposes specified in the Schedule to this Bill.

- Clause 3: Virement.**
In the event that the implementation of any of the projects intended to be undertaken under this Bill cannot be completed without Virement, such Virement shall only be effected with the prior approval of the National Assembly.
- Clause 4: Release of Funds for Implementation.**
The Comptroller-General of the Nigeria Customs Service shall ensure that Funds appropriated under this Bill are released as at when due, provided that no funds for any Quarter of the Fiscal year shall be deferred without prior waiver from the National Assembly.
- Clause 5: Quarterly Report.**
The Comptroller-General of the Nigeria Customs Service and the Directorate of Treasury, Nigeria Customs Service shall immediately upon the coming into force of this Bill furnish the National Assembly, on a Quarterly basis, the status of the records of the Service and Statutory Account.
- Clause 6: Waiver not to incur expenditure.**
Where due to revenue short-fall, amount appropriated under this Bill cannot be funded, the Service shall seek from the National Assembly a waiver not to incur such fund.
- Clause 7: Due Process Certification.**
The Department of Government charged with the responsibility of certifying that due processes have been complied with in the processing of implementation of projects shall ensure that all processes of approval are completed within the specified period as provided for in the Public Procurement Act.
- Clause 8: Interpretation.**
For the Purpose of this Bill, the term:

"Service" means the Nigeria Customs Service

"Schedule" includes the detailed estimates of expenditure attached hereto
- Clause 9: Short Title.**
This Bill may be cited as the Nigeria Custom Service Statutory Appropriation Bill, 2017.
