

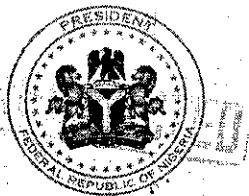

5. Matter of Urgent Public Importance (Standing Order Eight, Rule 4)

Need to Investigate the Illegal Deductions in the Salaries of Government Workers, Particularly, the Nigeria Police Force:

Hon. Jarigbe Agom Jarigbe (*Ogoja/Yala Federal Constituency*) introduced the matter and prayed the House to:

- (a) consider and approve the matter as one of urgent public importance; and
- (b) suspend Order Eight, Rule 4 (3) to allow debate on the matter forthwith.

Question that the matter be considered as one of urgent public importance — Agreed to.

Question that the House do suspend Order Eight, Rule 4 (3) to enable it debate the matter forthwith — Agreed to.

Need to Investigate the Illegal Deductions in the Salaries of Government Workers, Particularly, the Nigeria Police Force:

The House:

Notes that most modern societies have been seized by criminals, not even Nigeria is free of crime, hence, the establishment of the Nigeria Police Force, which has played a major role in administering law and order in the society;

Informed that most Officers, for a period of three months have not received their salaries and the only official explanation given by the Police Authorities, is that the fault was from operators of the Integrated Payroll and Personnel Information System (IPPIS);

Also informed that for so many years now, no officer could say with certainty how much he earns in a month as salary because their salaries are paid in piecemeal, with massive deductions some going as much as 50% of the actual salary;

Worried that the Nigeria Police is demeaned, neglected and rejected because they have no union to enable them agitate for a better condition of service in spite of the increasing risks they face at work;

Also worried that their deplorable condition of service which has remained unconducive to productive enterprise has, on several occasions, led to loss of lives to vicious and daring criminal;

Disturbed that if the Police is subjected to this kind of inhuman treatment in their place of work by IPPIS or the Police authority, then their morale will highly be affected and they would be forced to compromise on their job in order to have additional income to fend for the various needs of their families and thus cannot have the strong will to fight corruption in its entirety;

Concerned that if urgent steps are not taken to stop this indiscriminate and illegal deductions from salaries of the Police Officers, corruption cannot be completely eradicated and fighting crime in the society would not be achieved by the Nigeria Police.

Resolves to:

Set up an *Ad-hoc* Committee to investigate all matters relating to illegal deductions in the salaries of the Nigeria Police Officers by the Integrated Payroll and Personnel Information System (IPPIS) and report back within four (4) weeks for further legislative action (*Hon. Jarigbe Agom Jarigbe — Ogoja/Yala Federal Constituency*).

Debate.

Agreed to.

The House:

Resolved to:

Set up an *Ad-hoc* Committee to investigate all matters relating to illegal deductions in the salaries of the Nigeria Police Officers by the Integrated Payroll and Personnel Information System (IPPIS) and report back within four (4) weeks for further legislative action (**HR. 202/05/2018**).

Motion made and Question proposed, "That the House do receive the Report of the Committee on Customs and Excise on the issue from the Statutory Revenue Fund of the Nigeria Customs and Excise, the Total Sum of ₦103,534,789,767.23 (One Hundred and Three Billion, Five Hundred and Thirty-Four Million, Seven Hundred and Eighty-Nine Thousand, Seven Hundred and Sixty-Seven Naira, Twenty-Three Kobo) only, of which the Sum of ₦49,305,913,212.62 (Forty-Nine Billion, Three Hundred and Five Million, Nine Hundred and Thirteen Thousand, Two Hundred and Twelve Naira, Sixty-Two Kobo) only, is for Personnel Costs, while the Sum of ₦14,204,950,941.05 (Fourteen Billion, Two Hundred and Four Million, Nine Hundred and Fifty Thousand, Nine Hundred and Forty-One Naira, Five Kobo) only, is for Overhead Costs, and the sum of ₦40,023,925,613.56 (Forty Billion, Twenty Three Million, Nine Hundred and Twenty-Five Thousand, Six Hundred and Thirteen Naira, Fifty-Six Kobo) only is for Capital Projects for the Service of the Nigeria Customs and Excise, for the Financial Year Commencing from 1 January and Ending on 31 December, 2018 " (*Hon. James Abiodun Faleke — Ikeja Federal Constituency*).

Agreed to.

Motion made and Question proposed, "That the Joint Sitting of the National Assembly do resolve into a Close Session" (Hon. Femi Gbajabiamila — House Leader) — *Agreed to.*
