# REPORT OF THE SENATE COMMITTEE ON INEC ON THE SCREENING OF NOMINEES AS RESIDENT ELECTORAL COMMISSIONERS FOR THE INDEPENDENT NATIONAL ELECTORAL COMMISSION (INEC).

### **1.0 BACKGROUND**

The Committee requested and received from the Special Adviser to the President on National Assembly Matters the following documents of the nominees:

- 1. Curriculum Vitae
- 2. Clearance from Department of Security Service
- 3. Police Report
- 4. Code of Conduct Acknowledgement Slip
- 5. Other Relevant Certificates

## 4.0 SCREENING OF THE NOMINEES:

The nominees appeared before the Committee on Wednesday, May 10 – Thursday, May 11 2017 and also on Monday, May 15, 2017 for the screening in the Hearing Room 221, Senate New Wing, National Assembly Complex. The screening of the nominees by the Committee was carried out in batches.

## 4.1 FINDINGS:

In line with the provisions of section 14 (1) and section 14 3(a) of the Third Schedule of the Constitution of the Federal Republic of Nigeria 1999 (As Amended), the Committee studied the Curriculum Vitae of the Nominees along side other relevant documents and subsequently invited them in persons for the screening. The findings of the Committee on the nominees are as follows:

## 4.1.1 PROFESSOR GODWILL OBIOMA – ABIA STATE

He was born on 12<sup>th</sup> December, 1953. He hails from Bende LGA in Abia State. A Mathematics Education and Evaluation professor and internationally renowned education expert with particular emphasis on Public policy.

He holds several national and international positions which include:

- Member of the Board of Trustees of the prestigious, International Association of Educational Assessment representing the African Region (2014-2016)
- A one-time President of the Governing Council of UNESCO International Bureau of Education in Geneva (2013 – 2016)
- Fellow of the globally recognized institute of Professional Managers Association based in London (2011)

As the Director of Monetary and Evaluation in the then National Primary Education Commission, he participated in a nation-wide teacher's salary verification exercise that resulted in the saving of the sum of four Hundred and Nineteen Million Naira (N419,000,000) only for the Federal Republic of Nigeria in 1994.

#### 4.1.3 NWACHUKWU ORJI- EBONYI STATE

He was born on 16th November, 1977. He hails from Onicha Local Government Area of Ebonyi State. He obtained his Primary School Certificate from Army Children's Primary School, Anambra in 1988, He also had his West African School Certificate from Army Day Secondary School Awkwunau, Enugu in Enugu State. The members also appreciated his positive responses to the questions put forward to him, therefore, the Committee finds him suitable for the job.

He was born on 18<sup>th</sup> December, 1964 in Enugu State. ## 5.0 **OBSERVATION:**

The 27 nominees referred to the Committee for screening were cleared by the relevant security agencies: the Police, the Department of Security Service and the Code of Conduct Bureau.

#### 6.0 **RECOMMENDATION:**

After a thorough scrutiny of all the relevant documents of the nominees, members of the Committee were satisfied with the qualifications, experiences and suitability of 15 nominees in the first batch, while the remaining 12 nominees are still undergoing screening by the Committee. Therefore, the Committee recommends that the Senate do confirm the appointments of:
