1. The Railway Loan (International Bank) Act, Cap. R2, Laws of the Federation of Nigeria, 2004 is repealed.

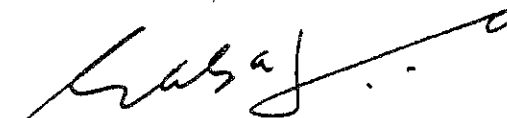
