**1.0 INTRODUCTION**

The Senate at its sitting on Wednesday 7<sup>th</sup> February, 2018 referred read the **Bill For An Act To Prohibit The Use of Chemical Weapons And Other Matters Connected Therewith (Establishment, etc.) Bill, (SB.585) 2018**, the second time for an accelerated passage and referred same to the Senate Committee on Science and Technology, for further legislative Action.

## **OBJECTIVES:**

- A. The Bill seeks to prohibit the development production and use of Chemical Weapons in Nigeria, establish a National Authority for the effective implementation of Chemical and Biological Weapons Convention in Nigeria and make provision for related matters.
- B. All Parties signatory to the Chemical and Biological Weapon Convention are required to establish or designate a National Authority that will serve as the National focal Point to ensure effective coordination as spelt out in the Chemical and Biological Weapons Convention protocol.
- C. (i) To ensure the domestication of the CWC and BTWC, which Nigeria had signed and ratified;
  - (ii) To host Stakeholders Meetings on Chemical / Biological Weapons Quarterly;
  - (iii) Industrial Visitation/Inspection of Chemical Industries holds twice a year (for annual declaration to the OPCW)
  - (iv) CWC Technical/Experts Meeting to hold quarterly;
  - (v) Training of Personnel of The Authority (NAC&BWC);
  - (vi) Attendance of the OPCW Executive Council Meeting and annual meetings in the Hague, Netherlands and also a regional level meeting in Africa;
  - (vii) To attend the United Nations General of Assembly (UNGA) on issues of CWC and BTWC under general disarmament;
  - (viii) Payments of Annual Contribution and Subvention of OPCW & BTWC.

## **GAINS & BENEFITS TO NIGERIA**

- (i) Since Nigeria signed and ratified the convention in 1993 and 1999 respectively, she has been a regular member of the OPCW Executive Council (Out of the 190 state parties that have signed and ratified the convention, only 41 members are in the membership of the Executive Council representing others).

- (ii). Nigeria is the Present Chair of open headed working Group on Terrorism. A Nigerian is presently the Legal Adviser of the organization for the prohibition of Chemical Weapon (OPCW).
- (iii). Numerous Nigerian Scientist enjoyed technical assistance/ training from the OPCW capacity training e.g. The Nigerian Customs, NAFDAC, Universities and Research Institutes.
- (iv). A Nigerian Was A Member of the OPCW Scientific Advisory Board for Seven Years.

In view of the numerous advantages and gains derivable from implementation of The national/ domestic legislation of CWC especially the access to any form of Protection and assistance from international community/ donor agencies in the possible event of threat of Chemical Weapons.

### **METHODOLOGY**

In carrying out this assignment, the Committee adopted the following methodology:

- i. Held several meetings.
- ii. Conducted a Public Hearing on 20<sup>th</sup> February 2018 in order to get views and input from stakeholders and the general public.
- iii. Consulted with legal draftsmen and other experts in the field.

The following participants were present at the Public Hearing and made contributions:-

### **3.0 STAKEHOLDERS OBSERVATIONS**

Stakeholders contributed immensely in favour of the Bill and recommended modifications and redrafting in some sections of the Bill. Consequently, an interministerial committee was set up to re-scrutinize the bill and submit its recommendations to the committee. The committee took note of the observations and treated it accordingly.

### **4.0 COMMITTEE RECOMMENDATION**

Following the clause by clause consideration of the Bill, the committee recommended as follows -:

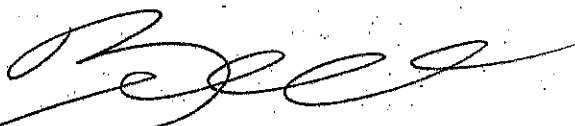
We therefore recommend that the Senate of the Federal Republic of Nigeria do consider and pass this bill as amended.

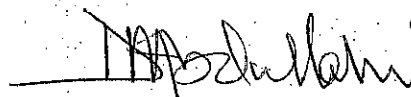
On behalf of all the Members of the Committee, I wish to express our gratitude to the Senate for giving us the opportunity to serve in this regard.

The Bill seeks to prohibit the development, production, transfer and use of chemical, *biological and toxin* weapons in Nigeria, establish a National Authority for the effective implementation of the Chemical *and Biological* Weapons Conventions in Nigeria.
