**REPORT OF THE COMMITTEE ON A BILL FOR AN ACT TO PROVIDE FOR THE ESTABLISHMENT OF THE SCHOOL OF MINES AND GEOLOGICAL STUDIES, GUYUK, ADAMAWA STATE, 2018 (SB. 706).**

**INTRODUCTION:**

Mr. President you may wish to recall that the Senate at its sitting on Wednesday, 5<sup>th</sup> December, 2018 referred the above Bill sponsored by Senator Ahmad A. Moallahyidi to the Committee for further legislative input. The Bill seeks to establish the School of Mines and Geological Studies, Guyuk. The Committee held a Public Hearing on Thursday, 13<sup>th</sup> December, 2018 to get public and stakeholders input.

The Committee as well as the participants agreed with the intentions of the Bill. Participants were all in agreement that the establishment of the School of Mines and Geological Studies will provide the needed skilled manpower for the mining sector.

**COMMITTEE'S FINDINGS:**

The Committee found out that the country's mineral and mining sector is facing serious manpower challenges at all levels. The challenge is more serious in Northern Nigeria where there is only one Institution that specialized in the mineral and mining studies at Jos, Plateau State.

Guyuk is endowed with large deposit of limestone, gold, gypsum, coal among other minerals. The establishment of the Institution at this location is therefore idea and will benefit the people of the area.

The Adamawa State Government has pledged to provide the necessary infrastructures for the take-off of the Institution.

The School of Mines and Geological Studies, Guyuk, Bill is divided into 25 sections and contains 3 Schedules.

#### **COMMITTEE'S RECOMMENDATIONS:**

The Committee recommends as follows

- (i) Sections 1 – 24 should be retained as in the bill
- (ii) The Long and Short Titles of the bill should be retained and
- (iii) The Schedule of the bill should be retained

#### **CONCLUSION:**

The Committee recommends that the Senate of the Federal Republic of Nigeria do approve its recommendations accordingly. The Committee wishes to express its profound gratitude to the entire Senate for its usual support.
