The Senate:

Notes that the North-East Development Commission (establishment, etc) Bill 2017 was passed by the National Assembly and transmitted to the President C-in-C on 12th January, 2017 for assent;

Aware that the National Assembly withdrew the Bill on 7th of February, 2017 after some issues which borders on constitutional prescriptions were observed;

Aware that there is no defined procedure on the reconsideration of Bills Passed by the National Assembly, transmitted to the President for assent and later withdrawn;

Notes that Order 1 (b) of the Senate Standing Orders 2015 as amended states that "in all cases not provided for hereinafter or by session or Order practice of the Senate, the Senate shall by resolution regulate its procedure;

Desirous to effect the amendments in the explanatory memorandum, arrangement of Sections- Part iv (S.13 & S. 20), Long Title, Section 2,5,7,10,12,13,14,15,16,17,19,20,25 and 26 of the Bill,

Accordingly resolves to:

- ii. *Resolve* into the Committee of the Whole to consider the Amendment.
