## 1. Withholding of Assent.

Senate Leader

*The Senate:*

*Recalls that the President C-in-C had signified the withholding of his assent on the following Bills pursuant to Section 58(4) of the Constitution of the Federal Republic of Nigeria 1999 (as amended):*

- i. Petroleum Industry Governance) Bill, 2019; and
- ii. Companies and Allied Matters Act 1990 (CAP C20, LFN 2004) (Amendment) Bill, 2019;

*Notes that the rationale for withholding the assent borders on the observation of Mr. President on some clauses in the Bills;*

*Aware that a Technical Committee of the Senate had worked on Mr. President observations and have re-drafted the affected Clauses;*

*Relying on order 88(b)(c) of the Senate Rule,*

*Accordingly resolves to:*

*Refer the Bills to the Committee of the Whole for consideration and passage.*

## 2. Committal of National Tobacco Regulation Bill, 2019

*The Senate:*

*Recalls that the National Tobacco Act was passed by the National Assembly in 2015;*

*Notes that Section 39 (1) and (2) of the National Tobacco Act 2015 empower the Minister to make regulations for the effective implementation of the Act;*

*Aware that the Minister of Health in exercise of the power conferred on him by section 39 (1) and (2) of the Act, transmitted the National Tobacco Regulation 2019 to the National Assembly for consideration and approval;*

*Aware also that the House of Representatives has concluded work on the regulation and transmitted same to the Senate for concurrence,*

*Accordingly resolves to:*

*Refer the National Tobacco Regulation 2019 to the Committee of the Whole for consideration and passage.*
