CONSIDERATION OF A BILL

1. A Bill for an Act to authorize the issue from the Consolidated Revenue Fund of the Federation the total sum of ₦ 7, 298, 507, 709, 937 (Seven Trillion, Two Hundred and Ninety-Eight Billion, Five Hundred and Seven Million, Seven Hundred and Nine Thousand, Nine Hundred and Thirty Seven Naira) only, of which ₦ 419, 020, 648, 000 (Four Hundred and Nineteen Billion, and Twenty Million, Six Hundred and Forty-Eight Thousand Naira) only is for Statutory Transfers, ₦ 1, 663, 885, 430, 499 (One Trillion, Six Hundred and Sixty-Three Billion, Eight Hundred and Eighty-Five Million, Four Hundred and Thirty Thousand, Four Hundred and Ninety-Nine Naira) only is for Debt Service, ₦ 177, 460, 296, 707 (One Hundred and Seventy-Seven Billion, Four Hundred and Sixty Million, Two Hundred and Ninety-Six Thousand, Seven Hundred and Seven Naira) only is for Sinking Fund for maturing bonds, ₦ 2, 979, 151, 756, 196 (Two Trillion, Nine Hundred and Seventy-Nine Billion, One Hundred and Fifty-One Million, Seven Hundred and Fifty-Six Thousand, One Hundred and Ninety-Six Naira) only is for Recurrent (Non-Debt) Expenditure while the sum of ₦ 2, 058, 989, 578, 536 (Two Trillion, and Fifty-Eight Billion, Nine Hundred and Eighty-Nine Million, Five Hundred and Seventy-Eight Thousand, Five Hundred and Thirty-Six Naira) only is for contribution to the Development Fund for Capital Expenditure (exclusive of capital expenditure in Statutory Transfers) for the year ending on the 31st day of December, 2017 – *Second Reading, 2nd Allotted Day*
