# 4. Personal Explanation:

Rising on Rule 43, Senator Tijjani Y. Kaura (Zamfara North) drew the attention of the Senate to the complaints by Nigerians in the media, over the recent recruitment exercise by the Directorate of State Services (DSS). He assured Nigerians that the Committee on Federal Character and Inter-Governmental Affairs will comprehensively look into the matter and all other exercises with similar complaints.

# 5. Personal Explanation:

Rising on Rule 43, Senator Ahmad I. Lawan (Yobe North) drew the attention of the Senate to the mandate given to him by the Senate on Wednesday, 17th May, 2017 to investigate the issues surrounding the nomination of the Director-General of the National Lottery Commission by the President, Commander-in-Chief of the Armed Forces of the Federation, and his alleged resumption of duty without confirmation by the Senate as required by Section 8(1) of the National Lottery Act. He informed the Senate that the nominee has actually resumed duty. The Senate was further informed that the Executive had acknowledged the breach of due process and asked the nominee to vacate office forthwith until he is confirmed or otherwise by the Senate, according to the aforementioned National lottery Act.

notes that Order 1(b) of the Senate Standing Orders 2015 as amended states that in all cases not provided for hereinafter or by session or Order practice of the Senate, the Senate shall by resolution regulate its procedure; and

desirous to effect the amendments in the explanatory memorandum, arrangement of Sections-Part iv (S.13 & S. 20), Long Title, Section 2,5,7,10,12,13,14,15,16,17,19,20,25 and 26 of the Bill.
