**6. Privileges:**

Rising on Rules 14,15 and 16 of the Senate Standing Order, Senator Ahmad R. Sani (*Zamfara West*) drew the attention of the Senate to the earlier announced Executive Communication from the Acting President of the Federal Republic of Nigeria, requesting for confirmation of appointment of Mr. Lanre Gbajabamila, Director-General, National Lottery Commission. He recalled that relying on Section 171 of the Constitution of the Federal Republic of Nigeria 1999 (as Amended), The Acting President informed the nation that the Senate confirmation was not required in certain appointments, even when it is explicitly stated in the Act setting up the Institutions. He therefore sought to know, as his privilege, why the Executives will decide who should be confirmed by the Senate for appointment instead of following the Constitution and the Law of the Federation of Nigeria.

*Question:* That the Acting President, should immediately swear-in all Electoral Resident Commissioners confirmed by the Senate — *Negatived.*

**Proposed Resolution (iv):**

*Question:* That the Acting President should immediately respect the rejection of nominee(s) by the Senate — *Agreed to.*

**Amendment Proposed:**

*Insert additional Proposed Resolution as follows:*

“That the Acting President should withdraw without further delay, the statement credited to him, on the confirmation of appointments by the Senate” (*Senator Kabiru G. Marafa — Zamfara Central*).

- (ii) That the Acting President must respect the Constitution and the Laws enacted by the National Assembly as they relate to confirmation of appointments;
- (iii) That the Acting President should immediately respect the rejection of nominee(s) by the Senate; and
- (iv) That the Acting President should withdraw without further delay, the statement credited to him, on the confirmation of appointments by the Senate (*S/Res/005/03/17*).

**7. Privileges:**

Rising on Rule 14, Senator Dino Melaye (*Kogi West*) drew the attention of the Senate to the recall exercise orchestrated by the Government of Kogi State using forged One Hundred and Eighty-One Thousand (181,000) signatures as against One Hundred and Eighteen Thousand (118,000) Votes that brought him to the Senate. He informed the Senate that among the signatories were the names of over One Hundred and Twenty (120) dead constituents, evidence by Death Certificates issued by the National Population Commission (NPC) and further supported by affidavits sworn by the relatives of the deceased. He alerted the Senate that his only sin was calling on his Governor to pay Kogi State workers their 18 months salary arrears. The recall, according to him, was not initiated by his Constituents but by the Governor of Kogi State. Therefore, he urged the Senate to intervene with the view to stopping this injustice and impunity.

Oko (*Cross River North*) drew the attention of the Senate to a communal clash with great consequence which occurred on 26<sup>th</sup> June, 2017 between Wanilade and Wanihem communities of North Ukelle, Yala Local Government Area, Cross River State, which left many people dead and over 3,000 persons displaced. She sought and obtained the leave of the Senate to present the matter.

The crisis left many people dead, some displaced and cattle killed. He sought and obtained the leave of the Senate to present the matter.
