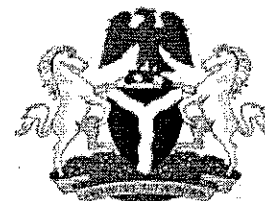
1. The Senate met at 10:29 a.m. The Deputy Senate President read Prayers.

4. Personal Explanation:

Rising on Rule 43, Senator Philip T. Aduda (*FCT*) drew the attention of the Senate to the Social Media Network relating to Mr. Michael Nwakwe, Corps Member serving in Nasarawa Academy Gusau, Zamfara State, who was allegedly brutalised by the parent of the student he punished in the course of his duty. He urged the Senate relevant Committees to look into the matter.

The Senate directed the Committee on Sports and Youth Development to investigate the matter and report within one (1) week.

5. Matter of Urgent Public Importance:

Rising on Rules 42 and 52, Senator Dino Melaye (*Kogi West*) drew the attention of the Senate to the Sun Newspaper publication of 9th March, 2017 captioned "Customs Dares Senate". He sought and obtained the leave of the Senate to present the matter forthwith:

The Senate:

notes that its passed a Resolution on 7th March, 2017 on the implementation of payment of duties on old vehicles in the country by the Nigeria Customs and directed the Agency to stop action on the payment of duties forthwith;

aware that Nigerians are totally not in support of this policy, and that Customs Officials aid the smuggling of vehicles into the country via different borders;

further aware that the policy is retrogressive and contravenes Section 4(9) of the 1999 Constitution (as amended) capable of subjecting the citizens of Nigeria into more hardship;

further notes that the stand by the Nigeria Customs is in total disregard and direct confrontation to the Principles of Separation of Powers as provided by the 1999 Constitution (as amended);

disturbed that if this policy is allowed, it can push Nigerians into taking arms against the Agency because Customs Duties were supposed to be paid by motor dealers/importers, and not by the end-users who purchased the vehicles from them locally;

further disturbed that Customs revenue has dropped from over ₦1 trillion to about ₦600,000 million annually due to unpleasant and unpopular policies introduced by the Customs; and

notes that the Comptroller-General of Customs needs to wear his rank uniform as a mark of respect to the Institution, and to guarantee leadership and diligence to the Service.

Accordingly resolves to:

invite the Comptroller-General of Nigeria Customs Services to appear in Plenary and in appropriate Uniform to defend the retrospective duty payment on vehicles in Nigeria, on Wednesday, 15th March, 2017.
