**SUPPLEMENTARY INPUT TO THE 2018 APPROPRIATION**  
**BILL: PURCHASE OF SUPER TUCANO AIRCRAFT FROM THE**  
**UNITED STATES GOVERNMENT**

*I wish to draw the attention of the Senate to the ongoing security emergencies in the country. These challenges were discussed with the State Governors and subsequently at the meeting of the National Economic Council on 14<sup>th</sup> December, 2017, where a Resolution was passed, with the Council approving that up to US\$1 billion may be released and utilised from the Excess Crude Account to address the situation.*

Subsequent upon this approval, we are preparing a comprehensive schedule of all the requirements for each of the Security Services for presentation to the National Assembly for consideration.

It would be recalled that, for a number of years, Nigeria had been in discussions with the United States Government for the purchase of Super Tucano Aircraft under a direct Government-to-Government arrangement. Recently approval was finally granted by the United States Government, but with a deadline within which part payment must be made otherwise the contract would lapse.

In the expectation that the National Assembly would have no objection to the purchase of this highly specialised Aircraft, which is critical to national security, I granted anticipatory approval for the release of US\$496,374,470.00. This was paid directly to the Treasury of the United States Government.

I am therefore writing, seeking approval of the Senate for the sum of US\$496,374,470.00 (equivalent to ₦151,394,421,335.00) to be included in the 2018 Appropriation Bill, which the National Assembly is currently finalising. The balance of the requirements for critical operational equipment is still being collated from the different Security Services, and will be presented in the form of a Supplementary Appropriation Bill, in due course.

The Honourable Minister of Defence and other appropriate officers will be available to provide further details, as may be required.

While thanking the Distinguished Senate for the usual cooperation, please accept Mr. Senate President, the assurances of my highest regards.

**5. Petition:**

Rising on Rule 41, Senator Theodore A. Orji (*Abia Central*) drew the attention of the Senate to two (2) petitions from:

- (a) Nwaoha L. Peter, against the Nigerian Airforce, over his wrongful dismissal from Service; and
- (b) Prince Udochi E. Ezem, against Union Home Savings and Loan Mortgage Bank, over non-release of his funds.

He urged the Senate to look into the matters.

**6. Privileges:**

Rising on Rules 14 and 15, Senator Matthew A. Urhoghide (*Edo South*) drew the attention of the Senate to the Executive Communication read by Senate President regarding the purchase of Super Tucano Aircraft from the United States Government amounting to US\$496,374,470.00. He stated that the action violates Section 80 of the 1999 Constitution of the Federal Republic of Nigeria (as amended) which is explicit on revenue and expenditure procedure on public fund. He further stated that the disbursement ahead of National Assembly's approval has impugned on his privilege.

*By the leave of the Senate, the Executive Communication would be referred to the appropriate Committee for further legislative action.*

**7. Matter of Urgent Public Importance:**

Rising on Rules 42 and 52, Senator Samuel N. Anyanwu (*Imo East*) drew the attention of the Senate to the arrest of Senator Dino Melaye on Tuesday, 24<sup>th</sup> April, 2018 by the Nigeria Police who treated him like a common criminal. He stated that some Distinguished Senators were prevented from seeing him at the National Hospital, Abuja by the Police. He observed that the inhuman treatment is a bad reflection on our democracy. He urged the Senate to consider the matter forthwith.
