



# SENATE OF THE FEDERAL REPUBLIC OF NIGERIA

## VOTES AND PROCEEDINGS

Wednesday, 8th March, 2017

1. The Senate met at 10:27 a.m. The Deputy Senate President read Prayers.

2. **Closed Session:**  
Closed Session — 10:29 a.m.

The Deputy Senate President reported that the Senate in a Closed Session reviewed the 2017 Budget consideration and the progress made so far. The Senate also considered the proposed visit to the South African Parliament over xenophobic attacks on Nigerians. In view of the House of Representatives desire to visit South Africa on the same purpose, the Senate decided to cancel the visitation to avoid multiple delegation to South Africa.

**5. Petitions:**

- (i) Rising on Rule 41, Senator David Umaru (*Niger East*) drew the attention of the Senate to a petition from Baba Shehu Ahmad & Co. on behalf of Habibu Adamu Habke, over illegal detention by the Nigeria Police. He urged the Senate to look into the matter.

*Petition laid and accordingly referred to the Committee on Ethics, Privileges and Public Petitions [Rule 41(3)] to report within two (2) weeks.*

- (ii) Rising on Rule 41, Senator Obinna J. Ogba (*Ebonyi Central*) drew the attention of the Senate to a petition from Dr. Patrick Ifeanyi Uba, over dispute between Capital Oil and Gas Industries Limited; the Asset Management Corporation of Nigeria (AMCON); and the Nigerian National Petroleum Corporation (NNPC). He urged the Senate to look into the matter.

*Petition laid and accordingly referred to the Committee on Ethics, Privileges and Public Petitions [Rule 41(3)] to report within two (2) weeks.*

**6. Matter of Urgent Public Importance:**

Rising on Rule 42, Senator Rose O. Oko (*Cross River North*) drew the attention of the Senate to the recent strike embarked upon by the Nigerian Union of Allied Health Professionals (NUAHP) over non implementation of agreement reached with the Federal Government in 2009. She urged the Senate relevant Committees to intervene.

*The Senate directed the Committees on Health; and Employment, Labour and Productivity to engage the Union with a view to ending the strike.*

8. **Motion:**

*International Women's Day; Theme "Women in the changing world of work: Planet 50:50 by 2030":*

*Motion made:* That the Senate notes that March 8, is the International Women's day, a day that honours the achievements and calls attention to the rights of Women;

*further notes* that the theme for this year's celebration is "Women in the Changing World of Work: Planet 50:50 by 2030" with particular focus on Women's empowerment. Many of the Sustainable Development Goals (SDGs) specifically recognize the need to empower women as both an objective and a key to sustainable development;

*recalls* that the International Women's day (IWD) was first officially recognized in 1911 and later recognized by the United Nations in 1975. In 1995, over 189 countries including Nigeria converged in Beijing, China for the 4th world conference on women and signed an action plan called "Beijing Declaration";

*observes* that in 2015, world leaders adopted the Sustainable Development Goals, placing gender equality and empowerment of all women and girls at the heart of the 2030 Agenda for Sustainable Development. This year's international Women's Day Focuses on Goal 8 of the SDGs: Decent Work and Economic Growth, which Challenges Governments around the World to achieve "Full and productive employment and Decent Work for all women, including young people and persons with disabilities, and equal pay for work of equal value.";

*further observes* that achievement of goals including ending poverty, promoting inclusive and sustainable economic growth, reducing inequalities within and between countries, and achieving gender equalities and empowerment of all women and girls, rest upon unlocking the full potential of women in the world of work;

*aware* that policies are needed to promote women's access to innovative technologies and practices, decent work and climate-resilient jobs and protect women from violence in work places;

*further aware* that the "Violence against Persons Prohibition Act" (the VAPP Act) that was signed into law in 2015 is yet to be domesticated in any state of the federation; let alone implement;

*concerned* that the implementation of policies that prohibits violence against women and girls are still very poor. Practices such as violence against women and girls in the public and private spheres, including trafficking, sexual and other types of exploitation, early child and forced marriage, female genital mutilation are still being practiced;

*further concerned* that women often bear the burden of unpaid care and domestic work, and when these unpaid hours are added to salaried work, women actually work very long hours in both developing and developed countries; and

*moreover* women are also significantly under-represented as Legislators, Senior Government Officials and Corporate Chief Executive/Managers.

*Accordingly resolves to:*

- (i) felicitate with Nigerian Women on this year's International Women's Day Celebration;
- (ii) call on Government at all levels to give women a quota in all elective offices; and
- (iii) mandate the Committee on Women Affairs to look into the Domestication of the Violence against Persons Prohibition Act in all the States of the Federation and report to the Senate (*Senator Binta Masi Garba — Adamawa North*).
