The Senate:

Notes that there are seven National Parks in Nigeria covering 20,156 km², which is about 3% of Nigeria's total area;

Also notes that the National Parks portray the success or failure of government environmental policies, the National Parks are especially critical in mitigating environmental threats;

Aware that the National Parks in Nigeria serve to protect the country's diverse flora and fauna thereby ensuring that the natural ecosystem remains intact;

Concerned that these National parks are becoming safe haven for criminal elements within the society, who often use parks as hide out. They come out to attack and return back there for safety;

Aware that the Security Agencies routine patrols does not cover the parks, and the Park Rangers are only trained to guide and protect the parks;

Worried that the National Park Service has no sufficient resources, Personnel and training to cope with the current security challenges the nation is facing;

Also worried that what is at the disposal of Park Rangers are obsolete and low caliber firearms and ammunitions such as Double Barrel Short Gun (DBSG), Pump Action, and Dane guns; and

Distressed that parks are now home to organized crime (banditry, kidnapping and cattle rustling) with resultant killing of Rangers and Commuters by Poachers/Herdsmen.

Accordingly resolves to:

- i. *Mainstream the National Park Service into the National Security architecture in line with the resolution of the 12th National Council on Environment (FMENV/!@th/NCE/FED/IG?123);*
- ii. *Give special training in fire arms and ballistics as well as surveillance & intelligence information gathering to Park Rangers;*
- iii. *Conclude the tripartite consultation (Ministries of Environment, Agriculture and Interior) on the presidential intervention; and*
- iv. *Involve other Security Agencies in park protection and surveillance.*
