

# SENATE OF THE FEDERAL REPUBLIC OF NIGERIA

# **VOTES AND PROCEEDINGS**

Wednesday, 26th February, 2020

1. The Senate met at 10:27 a.m. The Deputy President of the Senate read prayers.

#### 2. Votes and Proceedings:

The Senate examined the Votes and Proceedings of Tuesday, 25th February, 2020.

Question was put and the Votes and Proceedings were approved as amended.

#### 3. Petition:

Rising on Rule 41, Senator Abdullahi K. Barkiya (Katsina Central) drew the attention of the Senate to a petition by Alhaji Bashir Abdullahi and five (5) others, against MTN Group Limited and AIRTEL Nigeria, over telecommunications mask mounted at Oke-Agbe Street, Garki, Abuja. He urged the Senate to look into the matter.

Petition laid and accordingly referred to the Committee on Ethics, Privileges and Public Petitions [Rule 41(3)] to report within two (2) weeks.
