- (i) ***Need to Repair the Failing Sections and Complete the Construction of the East - West Road Particularly the Bayelsa - Rivers and Bayelsa-Delta Axis:***
Hon. Stephen Azaiki Sinikiem (*Yenagoa/Kolokuma/Opokuma Federal Constituency and Twenty Others*) introduced the matter and prayed the House to:

- (a) consider and approve the matter as one of urgent public importance; and
- (b) suspend Order Eight, Rule 4 (3) to allow debate on the matter forthwith.

Question that the matter be considered as one of urgent public importance — Agreed to.

Question that the House do suspend Order Eight, Rule 4 (3) to enable it debate the matter forthwith — Agreed to.

Need to Repair the Failing Sections and Complete the Construction of the East -West Road Particularly the Bayelsa -Rivers and Bayelsa-Delta Axis:

The House:

Notes that the East/West Road which was constructed decades ago, is one of the most important roads in Nigeria and its contribution to the economy and development of the country cannot be overemphasized;

Also notes that the East/West Road spans the five States of Rivers, Bayelsa, Delta, Akwa Ibom and Cross River, and is in the heart of the oil rich Niger Delta where the oil revenue is derived and hence very vital, thus its deplorable condition makes traffic very heavy all season;

Further notes that it is in recognition of the importance of the road, that the Administration of President Olusegun Obasanjo approved the construction of a second carriageway and the rehabilitation of the existing one, sadly, the road is yet to be completed;

Informed that a greater portion of the road in those States have failed even as the project contracted to SETRACO construction company has been abandoned, leaving the road to become a death trap that is causing nightmare to commuters who have to, unavoidably use the road;

Also informed that in particular, some sections of the road in Bayelsa State would be cut off in the coming days as the rains intensify and the situation can only be saved if the Federal Government intervenes without any further delay;

Believes that there is the need to urgently repair those failing sections of the road to avert more loss of lives and properties and also to ameliorate the hardships being experienced by road users and ensure that the entire road is completed;

Resolves to:

- (i) urge the Ministry of Niger Delta Affairs to direct the contractor, Messers SETRACO Nig. Ltd to immediately return to site and complete the construction of the road;
- (ii) also urge the Ministry to ensure that the Contractor immediately rehabilitates the most threatened sections in Rivers-Bayelsa and Bayelsa-Delta axis to avoid the cut-off of those portions of the road;
- (iii) further urge the Executive Arm of Government to redeem all liabilities owed contractors on the construction of the road; and
- (iv) mandate the Committee on Niger Delta Affairs to ensure compliance (*Hon. Stephen Azaiki Sinikiem — Yenagoa/Kolokuma-Opokuma Federal Constituency and Twenty Others*)..

Agreed to.

Also recalls that the dehumanisation to which the Nigerian people were subjugated left an indelible yearning to confront denial, discrimination and oppression of any form but particularly on account of the colour of skin;

Aware that for the aforementioned reasons, on attainment of independence, Africa became the centre piece of Nigeria's foreign policy;

Mindful that one (1) in every four (4) black men on the surface of the earth is a Nigerian;

Also aware that the apartheid policy in South Africa was the most compelling instance of racism of its time and in spite of her "infancy" as a sovereign State, Prime Minister, Alh. (Sir) Abubakar Tafawa Balewa directed that a letter Ref. PPS. 27 dated 4 April, 1961 be written to the African National Congress (ANC) assuring it that on his part, the battle against apartheid had just begun" and so began the dismantling of apartheid after more than one hundred (100) years of its reign in South Africa;

Notes that true to the words of (Sir) Abubakar Tafawa Balewa, Nigeria lobbied for the expulsion of South Africa from the Commonwealth of Nations in 1961; boycotted and organised the boycott by many sovereign states of the Olympic Games in 1976 and the Commonwealth Games in 1979 in protest against the depraved policy of apartheid and made available the annual subvention of \$5 million to the ANC and the Pan African Congress, the main political movements of the blacks in South Africa amongst many other fundamental contributions;

Nostalgic that back in those days on account of corporate and collective integrity that culminated in cross-border dignity, Nigeria did not slumber; Nigeria did not speak from both sides of her mouth; Nigeria roared and never whimpered in the community of sovereign states where the inalienable rights of her racial kind were an issue;

Bearing in mind that Nigeria rushed to sign every human rights treaty of the time like the International Covenant on Civil and Political Rights of 1966 that espoused equality and prohibited discrimination on account of race;

Cognizant that, as an attestation to these long held values of human rights, racial justice, equity and equality as well as African unity, the Constitution proclaims "dedicated to the promotion of inter-African solidarity" as the 1979 Constitution did as well as to the "promotion of African integration and support for African unity" and to "mutual respect among all nations and elimination of discrimination in all its manifestations" as the 1979 Constitution also did;

Concerned that there is the continuing and increasing dehumanisation of Nigerians, Africans and black people across the world particularly in the United States, Europe and Asia and that political independence and civil rights legislation do not mean uhuru yet for black people who continue to live in bondage;

Distressed that daily reports are coming in of the endless dehumanisation of black people across the world including being indiscriminately shot, dismembered and maimed in places like the United States by none other than agents of the State; being mauled, maimed and lynched by dogs being set upon them by private individuals and agents of the state in Asia particularly China; being subjected to monkey chants in stadia and other arena around Europe, etc. humiliations, dehumanisations and killings that neither time, money nor material can erase;

Also distressed that this incessant dehumanisation of black people across the world has compelled helpless black communities to start looking inwards towards resolving their challenges and that this has led to the ground breaking movement "Black Lives Matter" in the United States and that with the recent police killing of the black man, Mr George Floyd in Minneapolis, Minnesota and the resultant protests, the "Black Lives Matter" protests are slowly spreading, even if hindered by the COVID-19 pandemic, across continents;

Alarmed that if this trend of discrimination, annihilation, genocide and "racial cleansing" being perpetrated against Nigerians, Africans, and black people all over the world is not halted, there will cease to be a black population on earth in due course of time;

Conscious that foreign policy is dynamic and that the time has come to focus Nigeria's foreign policy towards its original goals of Afrocentrism as well as justice for all people particularly blacks;

Equally conscious of our foretasted history of intense agitation against apartheid and injustice in which massive resources were invested;

Determined that the time has come to put an end to the culture of discrimination, annihilation, genocide and "racial cleansing" being perpetrated against Nigerians, Africans, and black people all over the world; that the Black race must secure the same level of protection of which the Jewish precedent is an example; and that Nigeria must once again take the lead towards this objective if eternal shame is to be avoided;

Attacks on Two Villages in Gubio Local Government Area of Borno State by Boko Haram Insurgents:

The House:

Notes that on Tuesday, 9 June, 2020, Boko Haram insurgents attacked Foduma, Koloram and Ban Ngudorum villages in Gubio Local Government Area of Borno State and killed about 96 people;

Aware that the insurgents attacked the villages in a bid to rustle cattle but faced resistance from the villagers;

Informed that the insurgents later regrouped and invaded the villages in reprisal attacks, resulting in the mass killing of so many people;

Concerned by the renewed spate of attacks by the insurgents in recent time on the innocent, vulnerable and defenceless villagers in the affected communities;

Worried that the Security agencies seem to be overwhelmed by the renewed attacks by the insurgents in Borno State;

Resolves to:

- (i) call on the Chief of Defence Staff to ensure that the Armed Forces do intensify patrol in all the vulnerable communities in the hinterland and ensure the protection of such villages;
- (ii) urge the North- East Development Commission to provide the needed support for the affected villages;
- (iii) observe one-minute silence in honour of the people who lost their lives in the unfortunate attack; and
- (iv) mandate the Committee on Army to ensure compliance (*Hon. Usman Zannah — Kaga/Gubio/Magumeri Federal Constituency*).

- (iv) mandate the Committee on Army to ensure compliance (**HR. 185/06/2020**).

Aware of additional information available to the House on the subject matter relating to recommendation (iii) as adopted;

Resolves to:

Rescind its decision on recommendation (iii) of the Report and expunge "Petition the National Judicial Council (NJC) to investigate Justice Taiwo O. Taiwo and the circumstances surrounding the Order procured by Ikenga and CUPP" (*Hon. Abubakar Hassan Fulata — Birniwa/Guri/Kiri-Kasamma Federal Constituency*).

Agreed to.

13. **Need to Address the Ecological Challenges Occasioned by Erosion and Coastal Encroachment in Twon Brass, Bayelsa State**

Motion made Question proposed:

The House:

Notes that almost all the communities in Brass/Nembe Constituency of Bayelsa State are coastal communities located on the fringes of the Atlantic Ocean and River Nun;

Also notes that Twon Brass, the headquarters of Brass Local Government Area is home to one of the largest onshore crude oil terminal and a livewire of the nation's economic wellbeing;

Aware that Twon Brass is host to the Nigerian Agip Oil Company's crude oil exporting terminal through which over 40 percent of the nation's crude oil is exported on a daily basis and also host to the proposed \$12billion (dollars) Brass Liquefied Natural Gas plant;

Also aware that coastal erosion affects about 60 percent of communities in Brass/Nembe Federal Constituency and is exacerbated by the rising sea levels and activities of oil servicing companies that operate along the waterways;

Concerned that huge landmass on the coastal lines is washed away every year in Twon Brass, this means that in the next 20 years, Twon Brass and other communities may become extinct;

Also concerned that a large swathe of Twon Brass community is being wiped off from the face of the earth leading to migration of many people away from their ancestral homes;

Further aware that if not addressed, the situation could lead to tension and inter-communal conflicts between sister communities that have lived together in peace and harmony over the years;

Also worried that the long and deliberate neglect of those communities by the Niger Delta Development Commission (NDDC) will lead to an inevitable degeneration in the living conditions of the people;

Resolves to:

- (i) call on the Niger Delta Development Commission (NDDC) to commence the dredging of Twon Brass coastline to prevent the communities from avoidable extinction;
- (ii) mandate the Committee on Niger Delta Development Commission to investigate the current status of the Pre-qualification of Contractors or the award of contract for the construction of Jetty/Shore Protection in Twon Brass (*Hon. Israel Sunny-Goli — Brass/Nembe Federal Constituency*).

Agreed to.

14. **Need to Assist Communities in Buruku Local Government Area of Benue State Ravaged by Rainstorm**

Informed that the affected communities are now left at the mercy of adverse and inclement weather as the rains continue to threaten unabated;

Also informed that should such conditions continue without check residents of the affected communities will be in danger of contracting coronavirus diseases thereby threatening Government's efforts to stop the spread of COVID-19 pandemic;

Resolves to:

- (i) urge the National Emergency Management Agency (NEMA) to quickly make an assessment of the damage caused by the rainstorm of 31 May, 2020, and provide relief materials for the affected families and assist in rebuilding, places of worship and business to cushion the effects of the disaster;
- (ii) mandate the Committee on Emergency and Disaster Preparedness to ensure compliance (*Hon. Kpam Jimin Sokpo — Buruku Federal Constituency*).
