REPORT OF THE SENATE COMMITTEE ON TERTIARY INSTITUTIONS AND TETFUND ON A BILL FOR AN ACT TO PROVIDE FOR THE ESTABLISHMENT OF THE FEDERAL COLLEGE OF EDUCATION GIWA, KADUNA STATE; AND FOR OTHER MATTERS CONNECTED THEREWITH (SB. 121).

1.0 Preamble

The Senate on Wednesday 27th November, 2019, at its Plenary Sitting, debated on the general principles of the Federal College of Education, Giwa, Kaduna State (Establishment, Etc.) Bill, 2019 (SB. 121). After a far-reaching and in-depth deliberations, the Bill was read for the *Second Time* and referred to the Senate Committee on Tertiary Institutions and TETFUND, for further legislative action, vide *Senate Order of Referral dated 28th November, 2019,* to report back its recommendations.

The Bill was sponsored by *Distinguished Senator Uba Sani* (*Kaduna Central Senatorial District*). The Bill was read for the *First Time* on the Floor of the Senate on Tuesday 29th October, 2019.

2.0 Objectives of the Bill

The Bill, in a nutshell, seeks to among other things, make provision for the establishment of the Federal College of Education

Giwa, Kaduna State and for Related Matters. The objectives of the Bill in our view, are as follows:

- (a) to bring quality change in education by focusing on teacher education through teaching and learning innovations;
- (b) to develop and offer academic and professional programmes, leading to the award of certificates, with emphasis on planning, developmental and adaptive skills in Education, technology, applied science, agriculture, commerce, arts, science, humanities, management and professional disciplines;
- (c) to act as agents and catalysts for effective educational system, through research and innovations for effective and efficient economic utilisation and conservation of the country's human resources; and
- (d) to collaborate with other national and international institutions involved in training, research and development of education, with a view to promoting good governance, leadership and management skills amongst education managers.

3.0 Committee's Legislative Actions

The Committee, in furtherance of its legislative actions on this Bill, held series of meetings to further deliberate on the provisions of the Bill and painstakingly evaluated the views expressed by $\frac{1}{2} \log 2 = 2 \log 8$

Distinguished Senators during debates on the general principles of the Bill at the *Second Reading* stage. Consequently, the Committee resolved to conduct a Public Hearing in order to aggregate stakeholders' views on the legislative proposal in line with the Legislative Agenda of the 9th Senate. The Committee also consulted widely with relevant stakeholders on the merits of the Bill for possible enactment, as an Act of the National Assembly.

Mr President, Distinguished colleagues, the Committee in line with its Resolution and as part of its preparations towards the Public Hearing, placed advertisements in the print media and requested for submissions of memoranda from stakeholders and the general public on the proposed legislation. This was done in order to sensitise stakeholders and members of the public on the provisions of the Bill, ahead of the Public Hearing.

Expectedly, stakeholders responded to our call for submission of memoranda and a good number of them who submitted memoranda to the Committee, also made oral presentations before the Committee during the Public Hearing.

4.0 Public Hearing

Mr. President, Distinguished colleagues, to keep faith with the tradition of the Senate of carrying out all-inclusive Public Hearing in the law-making process, the Committee conducted its Public Hearing on this Bill on Monday 9th March, 2020. His Excellency, **Senator Ahmad Ibrahim Lawan, PhD, CON,** the President of the Senate, declared the Public Hearing open.

4.2 Highlights of Proceedings at the Public Hearing

It is pertinent to state here that stakeholders who were present at the Public Hearing, made exhaustive contributions in favour of the passage of the Bill. Below, is the highlight of their presentations in support of the Bill:

Firstly, stakeholders in their unilateral support for the passage of the Bill, stated that the educational system in Nigeria is in dire state and the situation is worst in the Northern part of the country, hence the need to frontally address this challenge for the country to move forward. According to them, a survey carried out by UNICEF recently reveals that the population of out of school children in Nigeria, has risen from 10.5 million to 13.5 million. This worrisome development is further exacerbated by the mass failures of students in WAEC and NECO examinations. And for those that pass their exams and are ready to further their education, securing admission is a herculean task due to limited space. Therefore, this Bill is among the interventions, intended to address these challenges in the best possible way.

Secondly, they decried the decline in the standard of the country's educational system, which they attributed to the quality of teachers in our primary and secondary schools. They maintained that in the past, priority was given to Teachers Colleges and Colleges of Education because of the realisation that a good educational system is structured on the quality of available competent teachers. However, with the ever-increasing focus on

private schools by the populace and lack of interest by government in developing teachers' training institutions, the dwindling fortune of our educational system has reached its highest ebb, hence the need for a legislation of this magnitude to bridge the gap to a certain extent.

Thirdly, they posited that every modern society or nation strive towards the provision of not only education but quality education for its citizens. This is in realization of the fact that education is key to development and crucial for the attainment of modernisation and sustainable development of every society or nation. And the attainment of sound educational system by the people is paramount, that is why this Bill was conceived to bring education closer to the people of Giwa Local Government and other neighbouring Local Governments and States of the Federation.

Fourthly, they stated that Giwa Local Government is strategically located and structured into eleven (11) political wards and three (3) traditional districts with 2,066 square kilometer and a high population density. The proximity of the town to one of the most prestigious Universities, Ahmadu Bello University, Zaria is also an added advantage. The Local Government also shares common borders with Katsina and Zamfara States. These, among others, are the reasons why Giwa is quite strategic and suitable for the establishment of the proposed Federal College of Education.

Finally, they maintained that the establishment of the College in Giwa town will definitely compliment the efforts of the Federal $${\rm Page}\,5{\rm of}\,8$$

Government in the provision of qualified and competent teachers, through the requisite innovative trainings in line with the agenda of the present administration. The establishment of the proposed College will no doubt, improve the quality of lives of not only the people of Giwa Local Government but the entire people of the country, by broadening employment opportunities and bring about economic and agricultural development of the area. On this note, they urged the Senate to pass the Bill because of its seeming advantage.

5.0 Legislative Summary

Mr. President, Distinguished colleagues, it is paramount to stress here that after clause-by-clause scrutiny and subsequent analysis of the provisions of the Bill after the Public Hearing vis-à-vis the presentations made by stakeholders, the Committee is of the view that the Bill conform to normative drafting styles. Therefore, it is our concerted view that this Bill be passed by the Senate to ensure the establishment of the proposed Federal College of Education in Giwa, Kaduna State.

6.0 Observations/Findings

Mr President, Distinguished colleagues, in line with the views canvassed by stakeholders and members of the public at the Public Hearing and our subsequent analysis of the presentations vis-à-vis the provisions of the Bill in our subsequent meetings, we hereby make the following observations/findings:

- 1. That the legislative intent behind the Bill is laudable and commendable as its passage by the Senate, will complement the Federal Government's efforts in bringing education closer to the people;
- That stakeholders were unanimous in their support for the passage of the Bill as there were no dissenting voice(s), opposing its passage;
- 3. That the establishment of the College will go a long way to address the perennial problem of shortage of teachers, which has affected the level of education in the country; and
- 4. That the passage of this legislative proposal, will no doubt, improve the quality of lives of the people, through broadening of employment opportunities and economic/agricultural development of the area.

7.0 Recommendation

The Senate Committee on Tertiary Institutions and TETFUND, to which this Bill was referred, having carefully considered same, recommends as follows:

"That the Senate do consider and pass the Federal College of Education Giwa, Kaduna State (Establishment, Etc.) Bill, 2020".
