A Bill for an Act to authorise the issue from the Consolidated Revenue Fund of the Federation the total sum of ₦13,082,420,568,233 (Thirteen Trillion, Eighty–Two Billion, Four Hundred and Twenty Million, Five Hundred and Sixty–Eight Thousand, Two Hundred and Thirty–Three Naira) only, of which ₦484,488,471,273 (Four Hundred and Eighty–Four Billion, Four Hundred and Eighty–Eight Million, Four Hundred and Seventy–One Million, Two Hundred and Seventy–Three Thousand Naira) only is for Statutory Transfers, ₦3,344,380,000,000 (Three Trillion, Three Hundred and Forty–Four Billion, Three Hundred and Eighty Billion Naira) only is for Debt Service, ₦5,649,872,137,888 (Five Trillion, Six Hundred and Forty–Nine Billion, Eight–Hundred and Seventy–Two Million, One Hundred and Thirty–Seven Thousand, Eight Hundred and Eighty–Nine Naira) only is for Recurrent (Non-Debt) Expenditure while the sum of ₦3,603,679,959,070 (Three Trillion, Six Hundred and Three Billion, Six Hundred and Seventy–Nine Million, Nine Hundred and Fifty–Nine Thousand, Seventy Naira) only is for contribution to the Development Fund for Capital Expenditure for the year ending 31 December, 2021 (HB.1069) (*Leader*) – (*Second Allotted Day*) – *Second Reading*.
