CONSIDERATION OF A BILL

1. A Bill for an Act to authorize the issue from the Consolidated Revenue Fund of the Federation the total sum of =N=13,082,420,568,233 (Thirteen Trillion, Eighty-Two Billion, Four Hundred and Twenty Million, Five Hundred and Sixty-Eight Thousand, Two Hundred and Thirty-Three Naira) only, of which =N=484,488,471,273 (Four Hundred and Eighty - Four Billion, Four Hundred and Eighty - Eight Million, Four Hundred and Seventy-One Thousand, Two Hundred and Seventy - Three Naira) only is for Statutory Transfers, =N=3,344,380,000,000 (Three Trillion, Three Hundred and Forty-Four Billion, Three Hundred and Eighty Million Naira) only is for Debt Service, =N= 5,649,872,137,888 (Five Trillion, Six Hundred and Forty-Nine Billion, Eight-Hundred and Seventy-Two Million, One Hundred and Thirty-Seven Thousand, Eight Hundred and Eighty-Eight Naira) only is for Recurrent (Non-Debt) Expenditure while the sum of =N= 3,603,679,959,070 (Three Trillion, Six Hundred and Three Billion, Six Hundred and Seventy-Nine Million, Nine Hundred and Fifty-Nine Thousand, Seventy Naira) only is for contribution to the Development Fund for Capital Expenditure for the year ending on the 31st day of December, 2021 (SB. 523) – *Second Reading (1st Allotted day)* Sen. Abdullahi, Yahaya Abubakar (*Kebbi North-Senate Leader*).
