#### 6. Matter of Urgent Public Importance:

Rising on Orders 42 and 52, Senator Biodun C. Olujimi (*Ekiti South*) drew the attention of the Senate to the #EndSARS: Need for comprehensive and holistic reforms. She sought and obtained the leave of the Senate to present the matter forthwith:

#### The Senate:

notes that Police brutality in Nigeria can be traced to the colonial era when force was mainly used to suppress dissent against colonial rules, force the people to obey draconian policies and thwart protests against colonial repression;

further notes that some of the documented police brutalities in Nigeria during the colonial era are: the killing of twenty-one miners and wounding of fifty workers during the Enugu Colliery strike of 1949; suppression of the women's riot (December 1929-January 1930) in the Eastern parts of the country, which led to the death of fifty-five women and serious injury to more than fifty others and the quelling of the Tiv riot of 1960 where 19 civilians were allegedly killed and 83 injured;

aware that despite the constitutional provisions establishing the police force based on Section 214 (1) of the 1979 and 1999 Constitutions, Police brutality continued during the post-colonial era. The police was used as an instrument of oppression by politicians in the first and second republics, in other to harass the operation and keep themselves in power. During military rule the Police was used to suppress popular protest and agitations against military dictatorship;

further aware that the Special Anti-Robbery Squad (SARS) was created in 1992 as a unit of the Nigerian Police Force to deal with crimes such as robbery, motor vehicle theft, kidnapping amongst others;

concerned that in June 2020, Amnesty International in a report; Time to End Impunity, documented that between January 2017 and May, 2020, there were 82 cases of torture, ill-treatments and extra-judicial killings of Nigerian citizens by the Special Anti-Robbery Squad (SARS);

*further concerned* that the latest #EndSARS protest, which has assumed a global dimension, began on 3 October, 2020, when the video of a SARS officer who allegedly shot a young Nigerian in Ughelli, Delta State, surfaced online;

worried that despite the disbandment of the SARS unit by the Inspector General of Police, Mohammed Adamu and the promise of implementing the demands of the protesters towards reforming the Police and ending brutality, the address by President Muhammadu Buhari on October 10, 2020 and the appeal of the Senate President, Distinguished Senator Ahmad Lawan to the protesters, the protests have increased in intensity and violence with socio-economic activities paralysed across Nigeria with some compatriots allegedly losing their lives in the ensuing melee;

further worried that the protests have now grown beyond the initial agitation to #EndSARS and #Endpolicebrutality to include the demands for good governance, accountability of government, reforms of key governmental institutions like INEC, Judiciary, Health, Power amongst others; and

accepts that as political leaders, we have a responsibility of protecting, providing succour and guiding our youths. We must therefore address the issues of emplacing appropriate policies that ensure economic growth, wealth creation and employment generation on the front burner.

#### 7. Matter of Urgent Public Importance:

Rising on Orders 42 and 52, Senator Sandy O. Onor (*Cross River Central*) drew the attention of the Senate to the Communal Clashes between Bordering Communities of Cross River and Ebonyi States and The Flood Disaster in Osopong 1 & 2 of Obubra LGA, Cross River State. He sought and obtained the leave of the Senate to present the matter forthwith:

#### The Senate:

notes that the long stretch of border between Cross River State and Ebonyi State is populated on either side by people with a long history of socio-cultural, economic and political affinities. However, over time, the growing scarcity of land and the changing dynamics of politics as well as the increasing challenges of economic survival have conspired to alter the peace and good neighbourliness that hitherto characterised life in these border areas;

further notes that border skirmishes and full blown clashes and wars have now become a common occurrence along this border stretch. Beginning from the South where the Biase of Cross River are in constant war with the Eda of Ebonyi, to the central where the Adadama group of villages are embroiled in clashes with the Ndi-Amagu of Ebonyi State, and the Izzi of Ebonyi are in permanent altercation with the Eja, Appiapumtet and Ijibolo, of Osopong, Obubra Local Government Area, also in Central Cross River State; these interminable wars leave in their wake, tales of blood, tears and destruction. Northern Cross River is not isolated from these ugly occurrences as the Izzi of Ebonyi and their Ukelle neighbours have been enmeshed in long periods of bitter cross boundary community wars;

*aware* that the war that is currently raging is between the Izzi of Ebonyi and the Osopong peoples of Obubra, Central Cross River;

*further aware* that the Osopong people are currently groaning under the weight of two fatalities, viz, a devasting flood that has ravaged their rich farmlands and habitations and this unending war with their Izzi neighbours;

worried that the peace and harmony as well as the agricultural potency of the Osopong group of villages, being landlords to a rich and vast swathe of land suitable especially for rice cultivation, fishing and other economic activities is threatened by the furious flood and the disturbing activities of these unending wars; and

also worried that unless a functional solution is sought and mutual agreement reached between aggrieved parties across the boundaries, the area may remain engulfed in attacks and retaliatory attacks with attendant brutal and unwholesome consequences for all and sundry.

Accordingly resolves to:

- (i) condemn in totality the killings, kidnappings and destruction of properties in the areas covering the entire stretch of boundary between peoples of Ebonyi and Cross River States and in particular, the current mayhem being perpetuated in the area inhabited by the Izzi people and the Osopong communities in Ebonyi and Cross River States respectively;
- (ii) appeal to the Cross River and Ebonyi State Governments to initiate and/or heighten the peace processes in the aforementioned areas;
- (iii) urge the National Boundary Commission, to accelerate, as a matter of National
