Akpan (*Akwa Ibom North-East*) drew the attention of the Senate to a petition from his constituent, Captain Emmanuel Ekpe Owen, against the Chief of Naval Staff, Vice Admiral Ibok Ette Ibas, over alleged victimization of his person and career. He urged the Senate to look into the matter.

Petition laid and accordingly referred to the Committee on Ethics, Privileges and Public Petitions [Order 41(3)] to report within four (4) weeks.
