- (ii) Prof. Chike Mbakwe, against the Accountant General of the Federation, Director of IPPIS of the Office of the Accountant General of the Federation for alleged failure to declare savings made from IPPIS capturing running to several billions of naira loss to the Federal Government of Nigeria and connivance with the Directors of Human Resources and Administration of MDAs and Syndicates operating with IPPIS Office to capture candidates with fake letters of employment purportedly issued by the Federal Civil Service Commission and MDAs into the Payroll of the Federation unchecked over the years;
- (iii) Chief Kayode Akintomide, against Gata Trading Company, a subsidiary of Dansa/Dangote Holdings for alleged breach of Contract with Fraudulent intent;
- (iv) Dr. Samuel Oluwaoromipin and Pharm. Abosede Idowu Adekola to redress the unjustifiable exclusion of other critical healthcare stakeholders by Federal Ministry of Health in NEMTC/SEMTC;

- (x) Yayaha Oladebo Oladosu requesting for his unpaid 17 years and 2 months Pensions and Arrears out of 23 years from Nigerian Army as instructed to Military Pension Board, via letter dated 17th July, 2007 and Army Headquarters approval letter dated 10th June, 2009;

(b) Rising on Order 41, Senator Francis A. Alimikhena (*Edo North*) drew the attention of the Senate to a petition by his constituent, RC Khanoba Aliyu Yunusa, against the Federal Road Safety Corp, over alleged wrongful termination of appointment. He urged the Senate to look into the matter.

Petition laid and accordingly referred to the Committee on Ethics, Privileges and Public Petitions [Order 41(3)] to report within two (2) weeks.

#### 6. Matter of Urgent Public Importance:

Rising on Orders 42 and 52, Senator Muhammad A. Adamu (*Kebbi Central*) drew the attention of the Senate to the Need to Protect Nigerian Indigenous Airlines from Extinction. He sought and obtained the leave of the Senate to present the matter forthwith:

#### The Senate:

aware that the Airline Operators of Nigeria (AON) is the Association of Domestic Scheduled and Charter Airline Operators of both fixed (airplane) and Rotary Wings (Helicopter) operators in Nigeria;

also aware that the association represents the interest of its collective members and the aviation industry in general;

*notes* that airlines are the pivot and catalyst of the Nigerian economy and are at the forefront of providing critical support for the Nigerian Micro/Macro economy;

further notes the immense contribution of the association to job creation, nation's Gross Domestic Product (GDP) and sustainable environment for investors in the sector;

worried that despite the significant contributions to the growth and development of the Nigerian economy, domestic airlines in the country are faced with multiplicity of challenges that threaten their continuous existence:

*observes* that there are some pertinent issues that have continued to negatively plague the industry and affecting airline operations in the country which include but are not limited to the following:

- (1) Non-implementation of the Executive Order on zero customs duty and zero VAT on importation of commercial aircrafts and aircraft spare parts.
- (2) Non-implementation of the Executive Order on the Removal of VAT from Air Transportation and Inability to access forex.
- (3) High cost of capital and lack of single digit interest rate for airlines.
- (4) Replacement of NCAA 5% Ticket Sales Charge (TSC) with a fixed charge similar to FAAN Passenger Service Charge (PSC).
- (5) Multiplicity of Taxes, Fees and Charges.

- (6) Urgent review of NAICOM Act on Aviation Insurance and exceptional permission to grant the externalization of insurance placements for domestic airlines in the country on an exceptional basis in the interest of air transport safety due to inability of Nigerian Insurance Companies to cover aviation risks.
- (7) Multiple Entries and Multiple Frequencies Granted to Foreign Airlines and depletion of the domestic airline market with loss of jobs.
- (8) Unnecessary delays for weeks in clearing of Aircraft on Ground (AOG) spares parts.
- (9) High Operating Cost (continually rising cost of JetA1).
- (10) Lack of Business Friendly and Enabling Regulatory Frameworks.

- (11) Over-Regulation of Domestic Airlines.
- (12) Inadequate and Decaying infrastructure.

#### Accordingly resolves to:

- (i) urge the Federal Government to fully implement the Executive Order on zero customs duty and zero VAT on importation of commercial aircraft and aircraft spare parts and also implement the Executive Order on the removal of VAT;
- (ii) urge the Central Bank of Nigeria to make foreign exchange readily and easily accessible for the sector and make the interest rate a single digit for airlines which will reduce the cost of capital;
- (iii) urge the Federal Government to eliminate multiple taxes, fees and charges;

#### 7. Matter of Urgent Public Importance:

Rising on Orders 42 and 52, Senator Biodun C. Olujimi (*Ekiti South*) drew the attention of the Senate to the #EndSARS protests: Urgent need for the Federal Government to assist Lagos State Government in rebuilding its infrastructure.

She sought and obtained the leave of the Senate to present the matter forthwith:

#### The Senate:

*notes* that the #EndSARS protest, which assumed a global dimension, began on 3<sup>rd</sup> October, 2020, when the video of a SARS officer who allegedly shot a young Nigerian in Ughelli, Delta State, surfaced online;

*further notes* that on Wednesday, 7<sup>th</sup> October, 2020, youths in Lagos state set out for a three-day protest to call for the disbandment of the Special Anti-Robbery Squad (SARS) unit of the Nigeria Police Force, as part of the push for reforms in the unit;

aware that  $7^{th}$  October, 2020 was the start of a 14-day protest in Lagos that eventually turned violent and hijacked by hoodlums;

further aware that at about 6:45pm on Tuesday, 20<sup>th</sup> October, 2020, several media accounts revealed that peaceful protesters were allegedly shot at by the Nigerian military at the Lekki toll

gate;

concerned that the alleged shooting of protesters further infuriated protesters and tension flared with consequent violent protests and the beginning of wanton looting and destroying of public and private assets all over the country and particularly Lagos, the epicenter of the protests;

worried that private and public assets destroyed by hoodlums in Lagos was estimated to be in the region of over 1 trillion naira by the Governor of Lagos State - Babajide Sanwo-Olu;

further worried that the long list of destroyed public and private properties in Lagos are: Ajeromi Ifelodun Local Government Secretariat, Palace of the Oba of Lagos; Lagos High Court, Igbosere; Oyingbo BRT terminus; Ojodu Berger BRT terminus; Vehicle Inspection Office, Ojodu Berger; Lagos State Public Works Corporation, Ojodu Berger; Lagos City Hall and Circle Mall, Lekki; numerous luxury shops in Surulere, The Nation Newspaper, TVC and Shoprite Lekki including 27 BRT vehicles estimated to cost \$200,000 each and another 57 BRT vehicles estimated to cost \$100,000 each, all totalling about ₹3.9 billion; and

alarmed that 25 police stations were reportedly burnt in Lagos: Orile, Amukoko, Layeni, Ilasamaja, Ikotun, Ajah, Igando, Elemoro, Makinde, Onipanu, Ebute Ero, Pen-Cinema, Isokoko, Alade, Cele, Igbo Elerin, Shibiri, Gbagada, Onilekere, Makoko, Daleko, Asahun, Makinyo, Amuwo-Odofin, Anti-Kidnapping, Surulere. Other Police stations that were vandalised but not burnt were Ojo, Ojodu, Mowo, PPL and Morogbo.

#### Accordingly resolves to:

- (i) urge the Federal Government to set up a visitation panel to assess the level of destruction of public and private assets in Lagos State;
- (ii) urge the Federal Government to commit to assisting Lagos State in rebuilding the state after the wanton destruction of lives and properties by giving 1% of VAT collection to Lagos State; and
- (iii) mandate the Senate Committee on State and Local Government Affairs to monitor compliance;

worried that despite the 24-hour curfew, a group of vandals on the next day being 24th October invaded over 120 properties in Calabar and vandalized, looted, burnt down some high value properties belonging to individuals, the State Government and Federal Government;

further worried that the Department of Petroleum Resources (DPR) Office, West African Examination Council (WAEC) Office, Federal Inland Revenue Service (FIRS) Office, the brand new state of the art Calabar International Convention Centre (ICC), the sprawling Tinapa Business Resort, the Federal Neuro Psychiatric Hospital, the Infectious Diseases Hospital amongst many others and private residences mostly of past and present Federal lawmakers were vandalized, looted or burnt;

convinced that the mayhem of 24th October was an invasion of the sovereignty of the Federal Republic of Nigeria, it was premeditated, selective and targeted at highly valued Federal and State Government infrastructure and Federal lawmakers;

aware that the intervention of the military bases and security installations like the 13 Amphibious Brigade Calabar, Eastern Naval Command Calabar, NNS Victory Calabar, 207 Special Mobility Airforce Unit Calabar and Zone 6 Police Command Calabar prevented the mayhem from spreading;

further aware that Cross River State being a predominantly civil service state may not overcome

the effects of the invasion since the destroyed state infrastructure were built from lean state resources over the years;

Accordingly resolves to:

- (i) condemn the attacks on private and public properties in Calabar on the 23rd and 24th October, 2020; and
- (ii) mandate the Committees on National Security and Intelligence; Defence; Police Affairs; and Judiciary, Human Rights and Legal Matters to investigate the invasion of the ancient city of Calabar on the 24th day of October, 2020.

Versatile Igwe Alex Ezoba Nwokedi also left his indelible foot-prints in the corporate boardroom arena as a non-executive director of the United Bank for Africa (UBA) PLC and the Anambra State Broadcasting Corporation;

Igwe Nwokedi completed his shinny comprehensive cycle of excellence when he ascended the Royal throne as the Uthokoneze of Achalla kingdom and also made it as the Chairman of the Anambra State Council of Traditional Rulers for some years; and
