#### REQUEST FOR RESOLUTION OF THE NATIONAL ASSEMBLY FOR APPROVAL OF THE REIMBURSEMENT OF \$148.14BN THROUGH THE ISSUANCE OF PROMISSORY NOTES TO BAYELSA, CROSS RIVER, ONDO, OSUN AND RIVERS STATE GOVERNMENTS FOR FEDERAL ROAD PROJECTS EXECUTED BY THE STATES

The Senate may wish to be informed that the Federal Executive Council (FEC), at its meeting of June 3, 2020 approved the reimbursement of N148, 141,969,161.24 through the issuance of Promissory Notes to the Bayelsa, Cross River, Ondo, Osun and Rivers State Governments for Federal Road projects executed by the States. The Extract from the Conclusion of the meeting referenced EC 11 (2020) 4 is attached as Appendix 1.

2. The approval by FEC was subsequent to the recommendation of an Inter-Ministerial Committee which reviewed the requests for reimbursement made by the State Governments for the projects. The Committee reviewed the documents submitted and carried out physical inspection and verification of the projects in the respective States before making its recommendation to FEC. The summary of the amounts approved for each of the five (5) States is stated in the table below:

#### PRESIDENT OF THE SENATE

#### SPEECH BY THE PRESIDENT OF THE SENATE, DISTINGUISHED SENATOR AHMAD IBRAHIM LAWAN, PhD, CON, AT SENATE RESUMPTION, SENATE CHAMBER, NATIONAL ASSEMBLY COMPLEX, THREE ARMS ZONE, ABUJA, SEPTEMBER 29, 2020.

#### PROTOCOL

Distinguished Colleagues, I heartily welcome us all back from our Annual Recess. This Recess unlike the previous ones, was observed in the period of COVID-19 Pandemic. All of us were largely involved in different undertakings to provide interventions and reliefs to the myriad of challenges brought about by the pandemic over various Senatorial Districts. I commend us all for being responsive.

You will recall that all distinguished Senators have donated Fifty percent (50%) of their salaries to the national efforts at fighting the pandemic for the entire period of the COVID-19 Pandemic in our country. I must also commend us all for this show of compassion and empathy.

The pandemic is still very much with us. We therefore need to continue to work with the Health authorities in the education, enlightenment and sensitization of our people, on the need to observe the protocols established by the Presidential Task Force (PTF) and other relevant authorities.

Let me take this opportunity to commend PTF and our health workers at all levels of government for the great job they have been doing since the outbreak of the pandemic in our country.

I also commend our various committees for undertaking oversights during the Recess. These oversights are necessary activities of this Senate to ensure that the Executive implements government programmes and projects with efficiency and effectiveness. Also worthy of our commendation is the engagement of our Joint Committee on Finance and National Planning with Federal Ministry of Finance, Budget and National Planning on the 2020-2022 Medium Term Expenditure Framework and fiscal Strategy Paper (MTEF/FSP) during the Recess. The Committee interacted with over 300 MDAs over the issues of Revenue Generation and Remittances to the Federal Government. The Joint Committee will present its report to the Senate Plenary today for consideration. This is a precursor to the presentation of the 2021 Budget Estimates by the Executive Arm of Government soon. I am aware that the executive will be presenting the 2021 Budget Estimates by next week.

Similarly, our Joint Committee on Petroleum Resources (Downstream), Petroleum Resources (Upstream) and Gas have had some preliminary engagements with the Federal Ministry of Petroleum Resources, the Nigerian National Petroleum Industry Bill (PIB). The PIB has been conveyed to the Senate for consideration.

The COVID-19 Pandemic had disrupted our budgetary plans, requiring the review of the 2020 Budget. We must carry out oversights to ensure that the revised 2020 Budget is properly implemented. The oversights are even more imperative as the Revised 2020 Budget is targeted at addressing the specific challenges occasioned by COVID-19 Pandemic.

The Senate needs to pay particular attention to the implementation of the Federal Government Economic Sustainability Plan. This strategic Plan is an essential means of revamping our economy, as it provides interventions in the Mass Agricultural Programme, Infrastructure, Mass Housing Programme, Investments in Healthcare Infrastructure, amongst others.

We were confronted with an over \$14billion revenue gap and the grim reality of an unwholesome overdependence on Oil. We cannot overemphasize the need to focus on other important sectors like Agriculture, Solid Minerals, and Steel Development and manufacturing, with a view to diversifying our economy. We need to work with relevant stakeholders to prevent our economy going into recession, stimulate the economy, save and create more jobs through a sustainable multiplier effect.

Distinguished Colleagues, the Senate will provide a one month window for Budget defense by Ministries, Departments and Agencies. Like last year, the month of October, 2020 will be dedicated for this exercise. Subsequent months of November and December will be dedicated to the internal processing of the budget by National Assembly. The various MDAs are therefore advised to ensure that they avail themselves the opportunity of the budget defense window to appear with all relevant and necessary information to defend their Budget Estimates.

Distinguished Colleagues, our 1999 Constitution as amended needs to be reviewed from time to time to improve the quality of governance and ensure stability in our polity. The Senate Committee on the Review of the Constitution has already invited Memoranda from citizens and organizations alike. The Senate will ensure speedy work on the review exercise. Also, the Electoral Reform Amendment Bills will be treated with despatch. We must ensure that we make amendments that will enhance free, fair, transparent and credible elections in our country.

Distinguished Colleagues, the security situation in our country is not what we want it to be. We want a security situation that guarantees protection of lives and property of citizens. Today, our country is bedeviled by multifaceted security challenges. We therefore need to continuously seek enduring measures to arrest the situation.

Abaribe (*Abia South*) drew the attention of the Senate to the letter from Mr. President, Commander-in-Chief of the Armed Forces of the Federation requesting the confirmation of a nominee as the Director General of National Pension Commission (NPC). He informed the Senate that the last Director General of the Commission did not complete her tenure and any nomination should be from the same zone of the previous Director General in line with section 17(2) of the Act. He stated that the nomination is in breach of the Act and the Constitution.

Point of Order noted by the Senate.

#### 9. Personal Explanation:

Rising on Rule 43, Senator Philip T. Aduda *(FCT)* drew the attention of the Senate to the letter from Mr. President, Commander-in-Chief of the Armed Forces of the Federation requesting the confirmation of the nominees as Ambassadors of the Federal Republic of Nigeria and the exclusion of indigenes of the Federal Capital Territory which had been the practice since 1999. He urged the Senate to intervene.

Point of Order noted by the Senate.

#### 10. Matter of Urgent Public Importance:

Rising on Rules 42 and 52, Senator Mohammed S. Musa (*Niger East*) drew the attention of the Senate to the urgent need to intervene and compel the Electricity Distribution Companies (DISCOs), Transmission Company and their regulatory authority to provide and ensure safety measures around our electrical facilities and installations. He sought and obtained the leave of the Senate to present the matter forthwith:

The Senate:

*notes* that over the years, Nigerians have to live with incidents of Electrocution and Electrical injuries at both homes and work places largely not as a result of unknown engineering principles, but system protection equipment failures, absence of protection devices in some cases, poor and aging transmission lines and poles, aging distribution networks, lack of fencing of Transformers, pitiable response to complaints of damaged facilities and lines by operators and managers of the Transmissions Company (TCN) and Distribution Companies (DISCOs) as well as non-compliance to safety rules and guidelines, non-enforcement of safety standards by regulatory agencies, unrelenting existence of inferior materials, schemes and distribution systems, unwillingness of the Discos to improve on obsolete assets inherited;

*further notes* that a lot of the industrial and domestic accidents are not the product of unknown engineering principles, but are mostly caused by the failure or wrong application of these principles as most of the operators have relegated Health & Safety Standard to mostly the issue of tariff;

*observes* that because of the frequency and alarming rate of the incidences at both rural and urban cities, there is no exact figures of incidents and deaths, but available estimated records have shown high increase. However, as some reports show, we have a continuously growing accidents; for the period from 2018 to first and second quarters 2019, 1,085 incidences occurred, 126 injuries and about 259 deaths were recorded;

*aware* that in December 2019 alone, about six inmates serving various prison terms at Ikoyi Correctional Centre, Lagos, died of electrocution following electricity surge that led to an explosion of cables while several inmates were also injured;

further aware that even this year 2020, many incidences of electrocution were recorded in most

parts of the country and Abuja, the Federal Capital of Nigeria was not spared considering the most recent incident that cut short the life of a young and promising boy named Suleiman (Ramadan) whose sad event occurred on 25th September, 2020;

*worried* that the Nigerian Electricity Regulatory Commission (NERC) which is the regulatory authority in the power sector lamented in its report for the second quarter of 2019 that no fewer than three persons were electrocuted every week, but despite the report, no concrete measure was taken to address the disastrous trend which when it happened, put the entire families of the deceased victims in a state of mourning;

*further worried* that as we speak today, in several places across the country, there are many old and broken down wooden and concrete electricity poles, some with naked wires dangling overhead, it only takes a serious rainfall or heavy wind to blow off some of the poles, and in such a situation, inhabitants of the affected areas live in constant fear of instant death;

*regrets* that Nigerian Electricity Regulatory Commission's second quarter report that was released at the tail end of 2019, underpins the systemic rot in the power sector and it calls to mind the legendary disregard for the sanctity of human life here, where Nigerians die cheaply from a myriad of avoidable occurrences; and

*concerned* that if these catastrophic and avoidable incidents are not addressed and the Senate and indeed the National Assembly do not rise to the occasion and mandate the Regulatory Commission to get tougher with all those industry operators, the incidences of electrocution will be second to insurgency in casualty figures.

#### Accordingly resolves to:

(*i*) mandate the relevant Committee to urgently interface with the Nigerian Electricity Regulatory Commission (NERC) with a view to compel the operators to invest seriously in their equipment, giving them a firm deadline to replace all the worn-out wires, poles, fence all transformers, provide adequate transformer installation and earthing system, and other basic equipment;

#### 11. Matter of Urgent Public Importance

Rising on Rules 42 and 52, Senator Chukwuka G. Utazi (*Enugu North*) drew the attention of the Senate to the Alleged Illegal Arrest, Detention, Rape, Torture and Extra - Judicial Killing of Miss Ifeoma Abugu by Operatives of the Special Anti-robbery Squad, Federal Capital Territory, Abuja. He sought and obtained the leave of the Senate to present the matter forthwith:

The Senate:

*notes* with grief and sadness, the recent extra-judicial killing of 28 year old Miss Ifeoma Abugu sometime in the second week of September, 2020 by Operatives of the Special Anti-Robbery Squad (SARS), Federal Capital Territory Police Command, Abuja which sad event was widely reported in electronic and print media;

*recalls* that on the 10th day of September, 2020, SARS Operatives FCT Police Command, Abuja reportedly arrested the late Miss Abugu in place of her fiance, Mr. Afam Agwunwa contrary to section 7 of the Administration of Criminal Justice Act and whisked her away from her fiance's apartment at Wumba village, Lokogoma, Abuja where she was allegedly detained, raped, tortured and extra-judicially killed while in their custody, FCT Police Command, Abuja;

*further recalls* that since the extra -judicial killing of Miss Abugu by SARS operatives in the second week of September, 2020, the FCT Police Command has to the disappointment of relatives and concerned family members of the deceased engaged in a blame game in a desperate bid to either exonerate the SARS operatives who were involved in the illegal arrest, torture and killing of the deceased or callously blame the incident on alleged drug overdose or other causes attributed to the deceased;

*notes* that until her untimely and gruesome murder by Operatives of SARS, the deceased, Miss Abugu had through dint of hard work and sheer determination received her tertiary education at the Institute of Management and Technology (IMT) and had reportedly concluded her National Youth Service Corps (NYSC) as well as her marriage introduction with her fiance, Mr. Afam Ugwunwa at her country home, Ugbaike, Igbo-Eze North Local Government Area of Enugu State;

*observes* that the gruesome murder of Miss Abugu has once again brought to national limelight, reported cases of misconduct ranging from harassment, extortion, assault, rape and extra-judicial killings attributed to men and officers of the Special Anti - Robbery Squad (SARS) in the recent past;

*further observes* that before this unfortunate gruesome murder of Miss Abugu, there has been persistent complaints by the general public including reports in print and electronic media on the atrocities of operatives of the Special Anti-Robbery Squad (SARS) that border on high-handedness and allegations of human rights violations including illegal arrests, detention and extra-judicial killing of Nigerians under very questionable and controversial circumstances;

*recalls* that sometime in 2018, the Federal Government in response to public outcry and media reports on the unlawful activities of SARS set up a Presidential Panel on the Reform of SARS and the report of the Panel formed the basis for the Presidential directives on the overhaul of the activities of SARS to ensure that the special squad is intelligence-driven, human rights sensitive and restricted to the prevention and detection of heinous crimes such as armed robbery and kidnapping, and apprehension of offenders linked to the stated offences;

*notes* that inspite of all efforts to reform SARS, the notorious squad has remained brutal in its operations, having little or no regard to the observance of human rights of suspects contrary to its scope of activities and the Presidential directives regarding its operations and has rather veered away from its core mandate to participate in debt recovery, recovery of premises and other civil matters;

*further notes* that the sad and unfortunate arrest of Miss Ifeoma Abugu allegedly in place of her fiance Mr. Afam Agwunma and her subsequent detention, rape and extra-judicial killing by SARS operatives and the entire disposition and contradictory official response of the FCT Police Command to this unfortunate incident as widely reported smacks of total disregard for extant laws and regulations relevant to their operations including section 7 of the Administration of Criminal Justice Act and the Presidential Directive on the re-organization of SARS; and

*convinced* that there is an urgent need for the Senate to investigate the alleged illegal arrest, detention, rape, torture and extra - judicial killing of Miss Ifeoma Abugu by operatives of the Special Anti-robbery Squad, Federal Capital Territory, Abuja in order to ensure that justice is

given to the family of the deceased and to also establish the status of SARS reforms in the light of recent public outcry over atrocities perpetrated by SARS Operatives.
