

# SENATE OF THE FEDERAL REPUBLIC OF NIGERIA VOTES AND PROCEEDINGS

Tuesday, 8th December, 2020

1. The Senate met at 10:43 a.m. The Deputy President of the Senate read prayers.

#### 2. Votes and Proceedings:

The Senate examined the Votes and Proceedings of Thursday, 3rd December, 2020.

Question was put and the Votes and Proceedings were approved as amended.

#### 3. Petitions:

Rising on Order 41, Senator Patrick A. Akinyelure (*Ondo Central*) drew the attention of the Senate to Seventeen (17) petitions received from the Office of the President of the Senate as follows:

- (i) Barr. Yahaya Ibrahim of Maigari and Associates on behalf of their client, S. A. Ifabiyi & Co. Nigeria Limited, against the Asset Management Corporation of Nigeria (AMCON), over alleged injustice against the family of late Elder Samuel Ifabiyi;
- (ii) Usman Hamzah, against Trustfund Pensions PLC, over alleged persistent refusal to pay agreed agency fees in the sum of ₹35,894,799.95 on the roll-over of pension accounts from five organisations despite repeated demands;
- (iii) Inspt. Peter Okafor, against the Police Service Commission, in respect of the complaint on inability to curb alleged cheating/injustice in the Inspector to Assistant Superintendent of Police (ASP) promotion exercise;
- (iv) Oladapo V. and two others, against Conoil PLC, over non-payment of their final entitlements;
- (v) Joel Adighogu and 128 others, against Capital Oil & Gas Industries Ltd, over alleged 4 years of unpaid salaries and over 10 years of unpaid/unremitted Pension;
- (vi) Tejumola Abiola Oloke, on appeal for the reinstatement of SPR Durojaye James into the Nigerian Army Pursuant to Section 191 and 173 of the Armed Forces Act CAP A20 Laws of Federation of Nigeria 2004;
- (vii) R.O. Owan and 9 other dismissed Officers, against the Nigeria Customs Service, over alleged wrongful dismissal, nepotism, favouritism and degrading treatment;
- (viii) Olanrewaju Suraju and four others, on appeal for support of Nigerian Whistleblower, who exposed the leaked confidential information by Former Dutch Ambassador over Shell corruption, investigation and protest to Dutch Ministry of Foreign Affairs;

- (ix) Engr. Aliyu Garba & Dr. Welle Sylvanus, over the non-compliance and selective implementation of Presidential directives regarding PhD scholarship for 90 recipients of the 2012, 2013 and 2014 President's NYSC National Honours Awardees;
- (x) Dr. Emilia Anaedo and Oloruntoba, against Hajia Mariam Suleiman CEO/MD Famzhi Interbiz Limited over alleged default of payments, intent to defraud, acts of financial fraud, breach of trust, deceit and insensitivity to the plights of investors;
- (*xi*) Andrew Shola Okoro Esq., on alleged unfair dismissal by the Court of Appeal, over the sum of ₹52,414.03 (Fifty-two Thousand Four Hundred and Fourteen Naira, Three Kobo) Bankers Draft;
- (xii) Chief Emeh Gilbert, against the Commandant and top Management of Nigeria Police Academy, Kano, over alleged gross mismanagement of public funds through diversion and spending of Internally Generated Revenue (IGR) without appropriation and non-compliance with Fiscal Responsibility Act and illegal collection of gratification ranging between ₹1,500,000 ₹2,000,000 from innocent Nigerian candidates seeking admission into the Academy since 2016 to date;
- (xiii) Tunde Babalola, against the Nigeria Customs Service, for alleged continued illegal detention of a 2018 model Toyota Hilux-Diesel Engine Mini Truck, property of Peamynd Autos Nigeria Ltd., at the Nigeria Customs Service Facility, Benin, Edo State;
- (xiv) Rt. Hon. J. G. Lebo, Esq., against Beijing International for alleged violation of Rights, intimidation and breach of contract of Nigerian International Footballer Mr. Victor Anichebe;
- (xv) Kenneth Emeka Nwulu, against the Nigerian Export Promotion Council, over alleged unjust termination of his appointment;
- (xvi) Dr. Kola Balogun, on behalf of retired DSP Folorunsho Saudat Alolade, against Pension Transitional Arrangement Directorate (PTAD), over short-fall in pension payments; and
- (xvii) Olugbenga Adedugbe, on behalf of Inspector Adama Abdulazeez (AP No: 224507), over alleged abrupt and unjustifiable denial of salaries and benefits as an officer of the Nigeria Police Force.

He urged the Senate to look into the matters.

Petitions laid and accordingly referred to the Committee on Ethics, Privileges and Public Petitions [Order 41(3)] to report within two (2) weeks.

Musa — Niger East).
