4. Petitions:

- (i) Rising on Rule 41, Senator Uche L. Ekwunife (*Anambra Central*) drew the attention of the Senate to three (3) petitions from:
 - (a) Women's Organization for Gender Issues, against the Permanent Secretary, Sabi'u Zakari, Defence Headquarters, over the alleged victimisation of Dr. (Mrs.) Nkenke, Ojeme Karen;

- (b) Sub-contractors Forum, Petroleum and Natural Gas Senior Staff Association of Nigeria (PENGASSAN) Housing Scheme Abuja, against PENGASSAN for alleged refusal to pay sub-contractors the outstanding balance for the construction of PENGASSAN Site Three Staff Housing Scheme, Abuja already completed and occupied by the body; and
- (c) Mr. Kenneth Onyebuchi Osakwe, against the Central Bank of Nigeria (CBN), over alleged wrongful termination of his appointment.

Rising on Rule 43, Senator Emmanuel Bwacha (*Taraba South*) drew the attention of the Senate to the commencement of construction works on the Ibbi bridge in Taraba South Senatorial District. He stated that his entire constituency had written a letter of appreciation commending Mr. President, Commander-in-Chief of the Armed Forces of the Federation, for a promise kept. He added that over the past few months, many Traditional Rulers and District Heads have been gruesomely killed under suspicious circumstances without any one being arrested and prosecuted.

He stated that HRM Dr. Michael attended Saint Boniface Primary School, Idah and completed his primary education in 1960, after which he gained admission into Saint Augustine's College, Kabba in 1961 and graduated in 1967. He further stated that HRM joined the Nigerian Airforce in 1968 and was discharged in 1974 at his request. He was appointed the 27th Attah Igala on the 6th of March, 2013, under the Igala native law and custom. He urged the Senate to observe a minute silence in honour of the deceased.
