Further notes that between 3 and 7 September, 2018, the Bureau of Public Procurement expended public funds to conduct an induction training programme for the recruited procurement officers;

Concerned that rather than absorb all the inducted and trained recruited officers, the Bureau of Public Procurement selected a few among them for posting and rejected 35 persons, who were subsequently sent to the Head of Service for reposting to other Ministries and Establishments;

Informed that the victims and their dependents will be demoralized if urgent steps are not taken to provide relief materials with sustainable measures that will rehabilitate the destroyed market in such a manner that will forestall further reoccurrence;

### Resolves to:

- (i) urge the Federal Ministry of Humanitarian Affairs, Disaster Management and Social Development, the National Emergency Management Agency (NEMA) and other relevant Agencies to provide relief materials to the victims for their survival and business reactivation;

27. Call to Investigate the Sale of Sokoto Rima River Basin Development Authority's Housing Estate at Katsina State Area Office by the Presidential Implementation Committee on Federal Government Landed Properties

Motion made and Question proposed:

The House:

Notes that Sokoto Rima River Basin Development Authority (SRRBDA) is a parastatal under the Federal Ministry of Water Resources with its headquarters at Sokoto and covers four out of seven States in North-Western Nigeria, namely Katsina, Kebbi, Sokoto and Zamfara States;

Aware that the Authority's Katsina Area Office is located in a strategic area in Katsina State and is a fenced complex comprising both offices and residential accommodations for staff of the Authority;

Also aware that the Complex is made up of 17 units of Senior Staff Quarters, 12 nos intermediate Staff Quarters, 10 nos Junior Staff Quarters, 21 nos Boy Quarters, 2 nos Office Blocks. 1 fertilizer store and a fallow land of about 10 hectares;

Further aware that some of the houses were rented to Katsina State Government by the SRRBDA but the tenancy agreement between the Katsina State government and the Sokoto Rima River Basin Development Authority was revoked and a vacation order was issued to the tenants;

Worried that to date, the tenants have not vacated the houses and some of them are beneficiaries of a purported and unlawful sale of those properties;

Cognizant of the importance of Area Offices in the Authority's operations as they serve as the liaison between the headquarters and the State Government;

Further cognizant that the Katsina Area Office has been included in the inventory of the fixed assets of the Authority submitted to the Public-Private-Partnership Consultants working on the partial commercialization of River Basin Development Authorities;

Concerned that the Presidential Implementation Committee (PIC) on Federal Government Landed Properties may have, in 2015, acted beyond its mandate in defining the Katsina State Area Office Complex as an isolated property and went ahead to dispose of them without the consent of the Sokoto Rima River Basin Development Authority which is presently in possession of the Certificate of Occupancy of its Katsina State Area Office Housing Estate;

Also worried that some of the policies that guided the Presidential Implementation Committee are being grossly abused by a few individuals who have been given the responsibility of implementing them and it has been alleged that the Presidential Implementation Committee officials are involved through the allocation of lands and houses in the Area Office to themselves and their cronies;

Further worried that the appeal by the Sokoto Rima River Basin Development Authority to the Office of the Secretary to the Government of the Federation (SGF) through the Federal Ministry of Water Resources to direct the Presidential Implementation Committee to reverse the sale and return all the sold units to the Authority is not likely to yield any positive outcome as a result of the flippant posture of the Committee constituted to investigate the matter;

Mandate the Committee on Water Resources to investigate the matter with a view to reviewing the sale of Sokoto Rima River Basin Development Authority's Housing Estate at Katsina State Area Office by the Presidential Implementation Committee (PIC) on Federal Government Landed Properties and report back within four (4) weeks (Hon. Nasiru Sani Zangon Daura — Zango/Baur Federal Constituency)

Noted that Sokoto Rima River Basin Development Authority (SRRBDA) is a parastatal under the Federal Ministry of Water Resources with its headquarters at Sokoto and covers four out of seven States in North-Western Nigeria, namely Katsina, Kebbi, Sokoto and Zamfara States;

Aware that the Authority's Katsina Area Office is located in a strategic area in Katsina State and is a fenced complex comprising both offices and residential accommodations for staff of the Authority;

Also aware that the Complex is made up of 17 units of Senior Staff Quarters, 12 nos intermediate Staff Quarters, 10 nos Junior Staff Quarters, 21 nos Boy Quarters, 2 nos Office Blocks. 1 fertilizer store and a fallow land of about 10 hectares;

Further aware that some of the houses were rented to Katsina State government by the SRRBDA but the tenancy agreement between the Katsina State government and the Sokoto Rima River Basin Development Authority was revoked and a vacation order was issued to the tenants;

Worried that to date, the tenants have not vacated the houses and some of them are beneficiaries of a purported and unlawful sale of those properties;

Cognizant of the importance of Area Offices in the Authority's operations as they serve as the liaison between the headquarters and the State Government;
