A Bill for an Act to authorize the issuance from the Consolidated Revenue Fund of the Federation the total sum of =N=16, 391, 023, 917, 692 (Sixteen Trillion, Three Hundred and Ninety-One Billion, Twenty Three Million, Nine Hundred and Seventeen Thousand, Six Hundred and Ninety-Two Naira) only, of which =N=768, 276, 616, 043 (Seven Hundred and Sixty-Eight Billion, Two Hundred and Seventy-Six Million, Six Hundred and Sixteen Thousand, Forty-Three Naira) only is for Statutory Transfers, =N=3, 901, 952, 981, 550 (Three Trillion, Nine Hundred and One Billion, Nine Hundred and Fifty Two Million, Nine Hundred and Eighty- One Thousand, Five Hundred and Fifty Naira) only is for Debt Service, =N= 6, 829, 015, 483, 446 (Six Trillion, Eight Hundred and Twenty-Nine Billion, Fifteen Million, Four Hundred and Eighty-Three Thousand, Four Hundred and Forty-Six Naira) only is for Recurrent (Non-Debt) Expenditure while the sum of =N= 4, 891, 778, 836, 654 (Four Trillion, Eight Hundred and Ninety-One Billion, Seven Hundred and Seventy-Eight Million, Eight Hundred and Thirty-Six Thousand, Six Hundred and Fifty-Four Naira) only for contribution to the Development Fund for Capital Expenditure for the year ending on the 31st day of December, 2022 and for other matters connected thereto, 2021 (SB. 829) – *Second Reading (2nd Allotted Day)*.
