



# HOUSE OF REPRESENTATIVES FEDERAL REPUBLIC OF NIGERIA

## VOTES AND PROCEEDINGS

Thursday, 16 September, 2021

1. The House met at 11:23 a.m. Mr Speaker read the Prayers.
2. The House recited the National Pledge
3. **Votes and Proceedings**  
Mr Speaker announced that he had examined and approved the *Votes and Proceedings* of Wednesday, 15 September, 2021.

*The Votes and Proceedings was adopted by unanimous consent.*

4. **Mr Speaker's Clarification on his Previous Address**  
Mr Speaker referred to his Address of Wednesday, 15 September, 2021, in which he alluded to criminals and miscreants hiding under legitimate activities of agitators to perpetuate acts of criminality and other socio-economic vices. He noted that the Media tilted the matter towards ethnic connotations which he considered a deliberate misinterpretation of his Address. He therefore, urged the Press to be objective, cautious and report accurately, matters discussed on the floor of the House.

***Recent Attack by Unknown Gunmen on Dumna Ward, Boshikiri District, Guyuk Local Government Area of Adamawa State:***

Hon. Gibeon Goroki (*Guyuk/Shelleng Federal Constituency*) introduced the matter and prayed the House to:

- (a) consider and approve the matter as one of urgent public importance; and  
 (b) suspend Order Eight, Rule 4 (3) to allow debate on the matter forthwith.

*Question that the matter be considered as one of urgent public importance — Agreed to.*

*Question that the House do suspend Order Eight, Rule 4 (3) to enable it debate the matter forthwith — Agreed to.*

**Recent Attack by Unknown Gunmen on Dumna Ward, Boshikiri District, Guyuk Local Government Area of Adamawa State:**

The House:

*Notes* with grave concern the recent attack of the people of Dumna Ward, in Boshikiri District of Guyuk Local Government Area of Adamawa State by unknown gunmen;

*Also notes* that the attackers besieged the Dumna Community in a most barbaric manner, using what appeared to be dangerous chemicals causing carnage and destruction on the farm lands and crops;

*Worried* that the persistent attacks and devastation of farmlands in the area causing hunger, starvation and untold hardship to the inhabitants of that community;

*Concerned* that if drastic actions are not taken to restore sanity and peace in Dumna Community, there is palpable fear of its extinction and the citizens migrating to other communities or States;

*Resolves to:*

- (i) urge the Inspector General of Police (IGP) to deploy Mobile Police patrol officers and men to the area to forestall future attacks; and  
 (ii) call on the National Emergency Management Agency (NEMA) to as a matter of urgency, send relief materials to the people of Dumna Community in Boshikiri, Guyuk Local Government Area of Adamawa State (*Hon. Gibeon Goroki — Guyuk/Shelleng Federal Constituency*).

*Debate.*

*Motion made and Question proposed:*

The House:

*Aware* that in compliance with the resolution of the House dated February 25, 2020, the President, on April 28, 2020 appointed the Chairman and Commissioners of the Federal Character Commission;

*Also aware* that the current Secretary of the Commission was appointed as a substantive Secretary to the Commission in March 2017, whose tenure was expected to end on April 7, 2021, but was re-appointed by the President on 7 April, 2021 for a second term;

*Cognizant* that the current Chairman of the Commission and the re-appointed Secretary are from the same Zone;

*Also cognizant* that the Chief Commissioner of the Public Complaints Commission and the Secretary of the Commission are also from the same part of the country;

*Notes* that the Federal Character Commission is one of the Agencies of the Federal Government with responsibility to promote, monitor and enforce compliance with the principles of proportional sharing of all bureaucratic, economic, and political positions at all levels of government;

*Further aware* of the Principle of Federal Character, as contained in the Act governing the Commission, to the effect that leadership positions must be equally distributed between zones;

*Resolves to:*

- (i) urge the Executive Arm of Government to comply with the principle of Federal Character;
- (ii) mandate the Committee on Federal Character to ensure compliance (*Hon. Unyime Idem — Ukanafun/Oruk Anam Federal Constituency*).

**12. Need to Ensure Compliance with the Community Development Agreements by Mining Companies Exploring Coal in Awo, Olukwu, Okobo and Onupi in Ankpa Local Government Area of Kogi State**

*Motion made and Question proposed:*

The House:

*Notes* that exploration and mining of Coal is being carried out by Companies such as Dangote and Eta Zuma operating in 828 different locations including Awo, Olokwu, Okobo and Onupi communities in Ankpa Local Government Area of Kogi State;

*Aware* of the attendant health hazards and implications of coal mining to host communities, like air and water pollution, and social dislocation arising from the activities of the Mining Companies;

*Also aware* of the provisions of Section 116 of the Nigeria Minerals and Mining Act, 2007 which stipulates that Community Development Agreements must be signed by the mining companies granted operational licenses;

*Worried* that mining companies operating in Ankpa Local Government Area have not lived up to such agreements, thereby depriving the host communities of maximum benefits of exploration and mining of mineral deposits in such communities;

*Also worried* that such deprivations are potential dangers capable of causing crises between host communities and companies operating in the area;

*Desirous* of a legislative intervention to address the seeming anomalies and injustices to people of such communities;

*Resolves to:*

- (i) urge the Federal Ministry of Mines and Steel Development to ensure that the Mining Companies live up to environmental obligations and standards enshrined in Section 116 of the Nigeria Minerals and Mining Act, 2007;
- (ii) mandate the Committee on Solid Minerals to ensure that companies involved in Mining activities comply with the Community Development Agreements;
- (iii) also mandate the Committee on Legislative Compliance to ensure compliance (*Hon. Abdullahi Ibrahim Ali Halims — Ankpa/Omala/Olamaboro Federal Constituency*).

*Debate.*

*Agreed to.*

The House:

*Noted* that exploration and mining of Coal is being carried out by Companies such as Dangote and Eta Zuma operating in 828 different locations including Awo, Olokwu, Okobo and Onupi communities in Ankpa Local Government Area of Kogi State;

14. **Need to Rehabilitate the Failed Portion of Ugbogui Bridge Along the Lagos-Ore-Benin Expressway, Ovia Local Government Area of Edo State**

*Motion made and Question proposed:*

The House:

*Notes* that the Lagos-Ore-Benin highway is one of the busiest roads in the country and also a gateway to other parts of the country for private and commercial vehicular movements;

*Also notes* an unending gridlock on the road which spans into kilometers arising from a caved-in section of Ugbogui Bridge in Ovia Local Government Area, along the Lagos-Ore-Benin Express road with an imminent fear of the total collapse of the bridge, if urgent steps are not taken;

*Aware* that the caved-in portion and the vibrations from the bridge are visible as motorists struggle through the narrow section of the road;

*Also aware* that the road serves as a route for transportation of goods to and fro various Ports in the Southern parts of the country and the current state of insecurity and challenges of kidnapping being experienced by travellers plying the road, call for rehabilitation of the failed portion of the Bridge;

*Resolves to:*

- (i) urge the Federal Roads Maintenance Agency (FERMA) to commence rehabilitation of the caved-in section of the Ugbogui Bridge to ease the hardship and danger being faced by commuters plying the road;
- (ii) also urge the Nigeria Police Force to provide security along the stretch of the road to ensure safety of road users;
- (iii) mandate the Committee on Legislative Compliance to ensure compliance *Hon. Dennis Idahosa — Ovia North East/South West Federal Constituency*).

*Agreed to.*

15. **Call on the Executive Arm of Government to Curtail the Spread of Cholera in Jigawa State**  
*Motion made and Question proposed:*

The House:

*Notes* that the mandate of the Federal Ministry of Health, among others are, to manage outbreaks of diseases in Nigeria, formulate policies on all activities relating to disease management and coordinate the plans and programmes for efficient and effective response to disasters at all levels of Government while making concrete efforts to cater for the health needs of Nigerians;

*Also notes* that within one month of the Cholera outbreak in Jigawa State has recorded over 2,000 cases of the disease and over 30 deaths, thus causing financial burden on the State Government as all its resources have been channelled to addressing the disease;

*Worried* that Mallam Madori and Kaugama Local Government Areas are surrounded by water which aided the spread of Cholera, a water-borne disease, thus calling for intervention of the Federal Ministry of Health, the National Primary Health Care Development Agency and other relevant health-related Authorities;

*Concerned* that the Cholera Outbreak is not easing in the Local Government Areas despite the efforts by the State Government as the statistics have risen to over 10,000 cases in the last four (4) months with over 295 deaths recorded in Jigawa State;

*Resolves to:*

Mandate the Committee on Health Care Services to liaise with the Federal Ministry of Health and other health-related agencies to take immediate steps to protect the lives of the people of Mallam Madori and Kaugama Local Government Areas in Jigawa State from further deaths as a result of the outbreak (*Hon. Abubakar Makki Yalleman — Mallam /Madori/Kaugama Federal Constituency*).

*Debate.*

*Question that the amendment be made — Agreed to.*

"Urge the Federal Ministry of Water Resources through its existing framework of the World Bank PEWASH (Partnership for Expanded Water Supply and Sanitation and Hygiene) programme to intervene in the affected communities by the provision of adequate water supply and sanitation facilities backed by effective sensitization on the importance of an Open Defecation Free (ODF) environment" (*Hon. Ahmed Mohammed Munir — Lere Federal Constituency*).

*Question that the amendment be made — Agreed to.*

(iii) Insert a new Prayer (iii), as follows:

"Urge the Nigeria Centre for Disease Control to complement the efforts of various State Governments through the supply of cholera containment commodities" (*Hon. Mansur Manu Soro — Darazo/Ganjuwa Federal Constituency*).

*Question that the amendment be made — Agreed to.*

*Question on the Motion as amended — Agreed to.*

The House:

*Noted* that the mandate of the Federal Ministry of Health, among others are, to manage outbreaks of diseases in Nigeria, formulate policies on all activities relating to disease management and coordinate the plans and programmes for efficient and effective response to disasters at all levels of Government while making concrete efforts to cater for the health needs of Nigerians;

*Also noted* that within one month of the Cholera outbreak in Jigawa State has recorded over 2,000 cases of the disease and over 30 deaths, thus causing financial burden on the State Government as all its resources have been channelled to addressing the disease;

- (iii) also urge the Nigeria Centre for Disease Control to complement the efforts of various State Governments through the supply of cholera containment commodities (**HR. 59/09/2021**).

**16. Invasion and Attacks by Suspected Herdsmen on Obiaruku Communities in Delta State**

*Motion made and Question proposed:*

The House:

*Notes* that since the first week of July 2021, suspected herdsmen have been invading, attacking and taking over communities' farmlands and other landed properties in Obiaruku, Umuebu, Eziopkor, Obinomba, Owah-Abbi, Ebedei and Umutu Communities in Ndokwa and Ukwuani Local Government Areas of Delta State;

*Also notes* that the herdsmen barricaded the major entrance leading to the communities' farmlands, thereby depriving members of the communities from accessing their farms which is their main source of livelihood;

*Worried* that women who manage to enter their farms are being raped on a daily basis by the Herdsmen who continue to destroy economic trees, farm produce and other staple crops such as yams, cassava, maize, vegetable products etc in the communities;

*Also worried* that the indiscriminate and sporadic shootings in the communities by the suspected herdsmen have resulted in the death of hundreds of people and some of the corpses are presently in the mortuary while others have been buried;

*Concerned* that at the moment, people of the affected communities can no longer go to farm as usual and have to pay Vigilante Groups to escort them to their farm on specific announced days;

*Also concerned* that as a result of the attacks, there have been a rise in prices of foodstuff which is causing untold hardships on the people;

*Cognizant* that Section 44 (1) of the Constitution of the Federal Republic of Nigeria, 1999 (as amended) provides that no movable property or any interest in an immovable property shall be taken possession of compulsorily and no right over or interest in any such property shall be acquired compulsorily in any part of Nigeria except in the manner and for the purposes prescribed by a law;

*Also cognizant* that section 14 (2) (b) of the Constitution of the Federal Republic of Nigeria, 1999 provides that the security and welfare of the people shall be the primary purpose of government;

*Resolves to:*

- (i) urge the Executive Arm of Government to mobilize security personnel to dislodge the invading suspected herdsmen in Obiaruku Communities and intensify efforts at ensuring that peace is restored to the Communities;
- (ii) also urge the National Emergency Management Agency (NEMA) to provide relief materials to the victims at Obiaruku, Umuebu, Eziopkor, Obinomba, Owah-Abbi, Ebedei and Umutu Communities in Delta State.
- (iii) mandate the Committee on National Security and Intelligence to visit Obiaruku Communities with a view to investigating and ascertaining the security situation and the extent of damage on the communities and report back within two (2) weeks (*Hon. Ossai Nicholas Ossai — Ndokwa East/Ndokwa West/Ukwuani Federal Constituency*).

*Debate.*

*Agreed to.*

The House:

*Resolved to:*

- (i) urge the Executive Arm of Government to mobilize security personnel to dislodge the invading suspected herdsmen in Obiaruku Communities and intensify efforts at ensuring that peace is restored to the Communities;
- (ii) also urge the National Emergency Management Agency (NEMA) to provide relief materials to the victims at Obiaruku, Umuebu, Eziopkor, Obinomba, Owah-Abbi, Ebedei and Umutu Communities in Delta State.
- (iii) mandate the Committee on National Security and Intelligence to visit Obiaruku Communities with a view to investigating and ascertaining the security situation and the extent of damage on the communities and report back within two (2) weeks (HR. 60/09/2021).

**17. Call on the Federal Government to connect Kanamma Town in Yunusari Local Government Area of Yobe State to the National Grid**

*Motion made and Question proposed:*

The House:

*Notes* that Kanamma with an estimated population of 271,303 is the headquarters of Yunusari Local Government Area of Yobe State which was created in 1989 and shares borders with Niger Republic;

*Concerned* that Kanamma is the only Local Government headquarters among the seventeen (17) Local Government Headquarters in Yobe State that is not connected to the National Grid;

*Worried* that the lack of power supply to Kanamma has grounded economic activities in the area and even healthcare facilities have become non-functional, thus exposing the people to the risk of not having access to health care services and basic facilities that require electricity supply;

*Resolves to:*

- (i) urge the Federal Ministry of Power to ensure that Kanamma in Yunusari Local Government Area of Yobe State is linked to the National Grid;
- (ii) mandate the Committee on Power to ensure compliance (*Hon. Lawan Shettima Ali — Bursari/Geidam/Yunusari Federal Constituency*).

*Agreed to.*

(HR. 61/09/2021).

*Motion referred to the Committee on Power, pursuant Order Eight, Rule 9 (5).*
