FORWARDING ADMINISTRATIVE STRUCTURE AMENDMENTS TO THE PETROLEUM INDUSTRY ACT (PIA) 2021 I wish to forward to the House of Representatives, the attached Administrative Structure Amendments of the Petroleum Industry Act (PIA) 2021 for your kind consideration and approval please.

2. Having carefully reviewed the administrative structure of both the Commission and the Authority; I would like to propose the following amendments to the PIA 2021:

(a) APPOINTMENT OF NON-EXECUTIVE BOARD MEMBERS

The Petroleum Industry Act 2021 provided for the appointment of two non-executive members for the board of the two regulatory institutions. I am of the view that this membership limitation has not addressed the principle of balanced geopolitical representation of the Country. I therefore, pray for the intervention of the 9th Assembly to correct this oversight in the interest of our national unity. Needless to add that this amendment will provide a sense of participation and inclusion to almost every section of the Country in the decision making of strategic institutions such as the oil industry.

If this amendment is approved, it will now increase the number of the non-executive members from two to six that is: one person from each of the six geopolitical zones of the Country.

(b) REMOVAL OF THE MINISTRIES OF PETROLEUM AND FINANCE FROM THE BOARD OF THE TWO INSTITUTIONS

The proposed amendment will increase the membership of the board from nine (9) to thirteen (13) members that is representing 44% expansion of the board size. This composition would strengthen the institutions and guarantee national spread and also achieve the expected policy contributions.

The two ministries already have constitutional responsibilities of either supervision or inter-governmental relations. They can continue to perform such roles without being in the board. It is also important to note that administratively, the representatives of the ministries in the board will be Directors — being the same rank with the Directors in the institution. This may bring some complications in some decision making especially on issues of staff related matters.

(c) APPOINTMENT OF EXECUTIVE DIRECTORS

The Act has made provision for 7 Departmental Heads in the Authority to be known as Executive Directors. Their appointment will also be subject to Senate confirmation. This category of Officers are civil servants and not political appointees.

The House is invited to note the need to exempt serving public officers from the established confirmation process for political appointments. This will ensure effective management of the regulatory institutions through uniform implementation of public service rules for employees of the Authority. In the future, these positions will obviously be filled by the workers in the Authority through career progression in conformity with the rules and regulations of the Federal Civil Service.

3. The proposed amendments to the Petroleum Industry Act, 2021 which is strictly about the administrative structure of the institutions is aimed at laying sound administrative structures governed by simple operational laws that will ensure smooth take-off and consequent growth of the two institutions. It is also in line with this administration's commitment to carry-out petroleum industry reforms. Find attached Annex "1".

4. While I request for your kind consideration and amendment of the Petroleum Industry Act to reflect this important national aspiration. Please accept, Mr Speaker, the assurances of my highest consideration.

Need to Arrest Frequent Attacks by Bandits on Villages and Towns in Rogo Local Government
Area of Kano State:

- (a) consider and approve the matter as one of urgent public importance; and
- (b) suspend Order Eight, Rule 4 (3) to allow debate on the matter forthwith.

Need to Arrest Frequent Attacks by Bandits on Villages and Towns in Rogo Local Government Area of Kano State:

The House:

Notes that ensuring security and welfare of the people is the primary purpose of government as clearly provided under section 14 (2) (b) of the 1999 Constitution as amended;

Also notes that Rogo and Karaye Local Government Areas, share borders with Katsina and Kaduna States which for quite sometime have been bedeviled by the nefarious activities of armed bandits, kidnappers and cattle rustlers;

Further notes that as a result of the military operation against bandits in Zamfara and Katsina States, the bandits are now fleeing into other States including Kano, Kogi and Abia States;

Disturbed that in the last few weeks, these bandits had attacked towns and villages in Rogo Local Government Area including Jajaye, Zarewa, Ruwan-Sago, Sari, Falgore, Dutsen- Sari and Hawan-Gwamna (Fulatan), where they kidnapped people (men and women) who are still mostly in their captivity and are demanding several millions of Naira for their release:

Recalls that in the month of March 2020, the House considered and approved a similar motion to check the likely infiltration of bandits into the border Local Government Areas of Kano State;

Disturbed that if urgent measures are not immediately taken to stop the activities of these bandits in Rogo Local Government Area, other border Local Government Areas of Kano State, and other States above, their nefarious activities could spread to other Local Government Areas of Kano State, and the country in general, thereby upsetting the relative peace enjoyed by the States;

Resolves to:

- (i) urge the Executive Arm of Government to set up a well- equipped Joint Security Taskforce with the mandate to operate along the border lines between Katsina, Kaduna and Kano States to address these frequent attacks by armed bandits in Rogo Local Government Area and other affected border Local Government Areas of Kano State:
- also urge the Executive Arm of Government to step up efforts to consolidate the gains recorded in the military operation against armed bandits in Zamfara and Katsina State by expanding the operation in a co-ordinated and simultaneous manner to cover all other affected States to prevent the movement of the bandits from one place to the other; and
- (iii) mandate the Committees on National Security and Intelligence, Army, and Police Affairs to ensure compliance (Hon. Haruna Isa Dederi Karaye/Rogo Federal Constituency).

Also notes that at the moment as a result of improved security situation, inhabitants of Gazau, Tozai, Modachi, Tsullawa, Kalage, Lugu, Dan-zanke, Modachi, Bargaja, Satiru, and Shalla towns/villages in Isa Local Government as well as inhabitants of Gidan Buta, Kalage, Kyara, Garin Idi, Burkusuma, Tara, Ganji, Dakura, Rambadawa, Lajinge, and other Villages in Sabon-Birni Local Government have returned;

Concerned that due to unavailability of food, shelter, farmland and business premises which were destroyed by insurgents, the returnees in Isa and Sabon Birni Local Government Areas are living in abject poverty and suffering untold hardship which could continue if urgent intervention is not provided by the appropriate authorities;

- 17. Need to Relocate the Yola Correctional Centre from Modibbo Adama Way, Yola South Local Government Area to Its Permanent Site in Yolde Pate, Yola South Local Government Area of Adamawa State

Motion made and Question proposed:

The House:

Notes that the Nigerian Prison Service, Yola now known as the Correctional Centre was established in 1914 to rehabilitate inmates and facilitate their training for eventual reintegration into the society;

Als tes that the Correctional Centre has the capacity to accommodate 500 inmates but currently accommodates over 1,000 inmates representing an excess of over 200%, thus overstretching the facilities in the Centre thereby exposing inmates to infectious diseases especially under COVID-19 Pandemic;

Informed that a new Correctional Centre of 1,000 inmates capacity was built in Yolde Pate, Yola South Local Government Area, an area that is strategic and the Centre is equipped with standard and modern facilities and quarters for the personnel of the Centre;

Aware that the old Correctional Centre in Yola town creates a lot of inconveniences for residents and visitors due to frequent road block especially in times of rampage by inmates or anticipated attack by insurgents;

Also aware that the sewage system is directly connected to the Yola South Central Mosque, Yola South Local Government Headquarters and the Palace of His Royal Highness the Lamido of Adamawa which exposes the residents to health hazards especially in the event of epidemic outbreak given its proximity and drainage linkages;

Regrets that the convenience and peace of residents of Yola will continue to be disturbed as long-as the Correctional Centre is not urgently relocated to its permanent site;

Resolves to:

- (i) call on the Federal Government to relocate the Correctional Centre from its present location at Modibbo Adama Way, to its new site at Yolde Pate, Yola;
- (ii) urge the Comptroller- General of the Nigeria Correctional Service to stop the 9:00 pm closure of the main Yola town road due to the location of the Centre; and
- (iii) mandate the Committee on Reformatory Institutions to conduct verification visit to Yola Correctional Centre and report back within four (4) weeks for further legislative action (Hon. Jafaru Suleiman Ribadu Yola North/Yola South/Gire Federal Constituency).

Agreed to.

18. Need to Enforce Compulsory Teaching of Moral Lessons and Orientation Subjects/Courses in Nigeria's Educational Curricula

Order read; deferred by leave of the House.

19. Need to Address the Falling Standard of Education in Nigeria

Motion made and Question proposed:

The House:

Notes that quality education is a crucial tool for economic growth of any country, thus Goal 4 of the United Nations Sustainable Development Goals (SDGs) is focused on ensuring inclusive and equitable quality education and promoting life-long learning opportunities for all;

Also notes that Section 18 of the Constitution of the Federal Republic of Nigeria, 1999 (as amended) provides that the Government shall direct its policy towards ensuring that there are equal and adequate educational opportunities at all levels;

Aware that the Nigeria's education system within the last decade has been on a steady decline, ranging from influx of illegal institutions of learning as well as unqualified teachers in the system to poor funding, overcrowding and plethora of decaying infrastructure in schools across the Federation;

Also aware that according to the United Nations, Nigeria has one of the largest populations of out-of-school youth in the world, with more than ten million Nigerian children, 60 per cent of them girls, not in school and will therefore not have the skills they need to get jobs and build secured and stable future;

Acknowledges that Nigeria has achieved some progress in expanding access to school under the Millennium Development Goals (MDGs) and the domestic Universal Basic Education (UBE) Scheme, however, the expansion has not resulted in improved learning, as the flat learning curve in Nigeria is a proof that getting children to school does not automatically translate to adequate infrastructure, qualified teachers, conducive learning environment, frequent attendance, grade progression, effective classroom governance and more importantly, learning;

Concerned that the adverse effects of falling standard of Education to a nation is very grave, and the fall in educational standard in Nigeria implies a continued decline in its level of economic growth;

Also concerned that with the current population of about 200 million, 45 per cent of which are below 15 years, there is high demand for learning opportunities translating into increased enrolment which has created challenges in ensuring quality education since resources are spread more thinly;

Worried that the burden on education in Nigeria has become even more overwhelming, resulting in more than 100 pupils to one teacher as against the UNESCO benchmark of 35 pupils per teacher; culminating in students learning under trees for lack of classrooms and other harsh conditions;

Cognizant that if no urgent action is taken, the problem will gravely affect the young and future generations as well as stifle economic and social developmental prospects of the country;

Resolves to:

- urge the Federal Ministry of Budget and National Planning to give further considerations to Education in the subsequent budgetary allocations in order to attain the UNESCO projection by 2030;
- (ii) mandate the Committees on Tertiary Education and Services, Basic Education and Services, Youth Development and Appropriations to liaise with relevant stakeholders with the aim of providing lasting solutions to falling standard of education in Nigeria, and report back within four (4) weeks (Hon. Ganiyu Abiodun Johnson Oshodi Isolo II Federal Constituency).

Debate.

Agreed to.

The House:

Noted that quality education is a crucial tool for economic growth of any country, thus Goal 4 of the United Nations Sustainable Development Goals (SDGs) is focused on ensuring inclusive and equitable quality education and promoting life-long learning opportunities for all;

Also noted that Section 18 of the Constitution of the Federal Republic of Nigeria, 1999 (as amended) provides that the Government shall direct its policy towards ensuring that there are equal and adequate educational opportunities at all levels;

Aware that the Nigeria's education system within the last decade has been on a steady decline, ranging from influx of illegal institutions of learning as well as unqualified teachers in the system to poor funding, overcrowding and plethora of decaying infrastructure in schools across the Federation;

Also aware that according to the United Nations, Nigeria has one of the largest populations of out-of-school youth in the world, with more than ten million Nigerian children, 60 per cent of them girls, not in school and will therefore not have the skills they need to get jobs and build secured and stable future;
