MOTIONS

13. Need to Reopen the National Youth Service Corps (NYSC) Permanent Orientation Camp, Maiduguri: Hon. Usman Zannah:

The House:

Notes that over ten years, the National Youth Service Corp permanent Orientation Camp in Maiduguri was shut down following killings by the Boko Haram Terrorists in Borno State;

Also notes that the past Director-General of the NYSC, Mr Suleiman Kazaure reiterated that the Camp would be reopened as soon as the Internally Displaced Persons are relocated from the premises;

Aware that the Borno State Government had relocated over 8, 000 Internally Displaced Persons (IDPs) taking refuge in the NYSC Orientation Camp to houses provided by the government at Auno, while others were relocated to Bama and Danboa Local Government Areas;

Informed that the Governor of Borno State, Professor Babagana Umara Zulum wrote letters to the Director-General of NYSC to reopen the Camp but to no avail;

Also informed that the Borno State Government has made adequate arrangements to ensure the safety of the and wellbeing of Corp members posted to the State;

Worried that corps members posted to Borno State would have to travel to Kastina State to undergo orientation at the Nigeria Security and Civil Defence Corps (NSCDC) Training School, Kastina, despite the state of insecurity in the entire North West;

Also worried that the high rate of insecurity in Kastina State is capable of affecting Corp member's psychology and exposed them to the danger of being attacked by bandits while travelling to Kastina;

Disturbed that the state of insecurity in Kastina State is already a threat to lives and property which necessitated the shutting down of telecommunication services, hence making communication very difficult;

Resolves to:

- (*i*) Mandate the Committee on Youth Development to investigate the refusal of the National Youth Service Corps (NYSC) to reopen the permanent orientation camp in Maiduguri despite the peace in the State;
- (*ii*) also mandate the Committee on Legislative Compliance to ensure implementation.

14. Need to Apply Stringent Measures to Curtail the Excesses of Online Loan Providers: Hon. Akin Alabi:

The House:

Notes that the coronavirus (COVID–19) pandemic's far–reaching impact on the global economy has been significant, with evidence across all sectors of the economy;

Also notes that to cushion the impact of the pandemic, a rising number of Nigerians have resorted to digital lenders to sort out urgent financial needs as access to loans from the traditional financial institutions is often a long and painstaking process;

Further notes that there is a growing increase in the number of digital lending service providers who have seemingly simplified the lending process and increased access to loans remotely and quickly;

Concerned that several lending platforms are operating outside the principles of lawful processing of personal data as required under the Nigeria Data Protection Regulation and other relevant provisions on data protection in Nigeria;

Also concerned that many online loan providers are exploiting the growing need for financial assistance and engaging in unfair collection practices by subjecting Nigerians to situations where their contacts are besieged with unsolicited messages from the loan providers in a bid to force the borrowers to pay;

Disturbed that the online loan providers have resorted to a pesky habit of shaming as a tactic to get their customers to pay and taking actions that are tantamount to privacy violation, intimidation, and harassment;

Also disturbed that some online lenders operating in the country do not have a privacy notice while some privacy notice of those who have is often not comprehensive enough to explain how a user's data is processed;

Worried that the recovery agents for the lending firms are mostly unprofessional and often apply unethical methods including impersonating lawyers and security officers, in a bid to recover borrowed funds from defaulting clients;

Cognizant that the Nigerian Data Protection Regulation was established due to the government's recognition that information must be safeguarded, regulated and protected against atrocious breaches;

Resolves to:

(*i*) Urge the Central bank of Nigeria to make feasible regulations to curb the extremism of unscrupulous online loan providers in Nigeria;

(ii)	also urge State Governments to ensure more stringent regulations that protect the interest of third- party individuals from receiving unsolicited messages;
(iii)	further urge the National Information Technology Development Agency (NITDA) to ensure strict adherence to the Nigerian Data Protection Regulation by all online loan providers;

(iv) mandate the Committee on Human rights to ensure compliance.

15. Need to License Private Security Outfits for Protection of Politically Exposed Persons: Hon. Emmanuel Ukpong-Udo:

The House:

Notes the need to ensure the safety of Expatriates, Politically Exposed Persons and Very Important Persons, Celebrities, Executives and individuals exposed to personal risk due to their status, association or geographical location by providing adequate security measures;

Also notes that executive form of protection is a specialized field within the-Private Security Industry which requires risk assessment and encompasses proactive intelligence to identify both probable and possible threats from persons and groups of interest;

Worried that the Nigerian Security Agencies are overstretched, understaffed couple with the increased security challenges facing the country;

Also worried that the Nigerian population is fast increasing with an estimated size of 220 million people compared to the personnel strength of the Nigeria Police Force which stands at 370,000 with over 140,000 attached to Exposed Persons and Very Important Persons;

Concerned that the number of both the Armed Forces and the Paramilitary in Nigeria is less than 1,000,000 personnel to secure the country, which poses a grave challenge to the lives of citizens who are victims of insecurity in the country;

Resolves to:

- (*i*) urge the Nigeria Civil Defence Corps to grant licenses to Private Outfits so as to maximize the security architecture in Nigeria;
- (*ii*) mandate the Committee on Interior to ensure compliance.

16. Need to Streamline the Services Being Rendered to Nigerians by Nigerian Embassies and High Commissions Abroad: Hon, Obinna Chidoka:

The House:

Notes that Nigerian Embassies and High Commissions are the nation's flagship territories abroad and as such should project the best image of Nigeria's pride and the best example of the values placed on citizens;

Also notes that the Embassies and High Commissions are safe havens for Nigerians in diaspora, whether living abroad or travelling abroad;

Further notes the deplorable level of services rendered by Nigerian Embassies and High Commissions around the world to Nigerians, particularly those in South Africa, the United Kingdom and the USA in the area of Passports, National Identity Card issuance, renewals and ancillary services;

Concerned that the treatment meted out on Nigerian citizens abroad by officials of the Nigerian Embassies and High Commissions have not only affected the lives and businesses of the concerned citizens, it has brought shame and disgrace on Nigeria's image and the psyche of our citizens;

Also concerned also that there have been reported incidences of extortion and fraudulent intimidation by Embassy and High Commission officials in the past;

Further Concerned that unless an urgent measure is taken to put a permanent halt to this trend, the nation's Embassies and High Commissions will become a terror to the people they were established to serve and;

Determined to address this menace and bring succour to Nigerians living or travelling abroad, and to uplift the nation's national pride knowing that with simple automation most of those embarrassing issues can be resolved;

Resolves to:

- (*i*) Urge the Federal Ministry of Interior through the Nigeria Immigration Service, the National Identity Management Commission and other relevant Agencies to fully automate the processes of Passport and National Identity Card issuance to:
 - (*a*) reduce the incidences of physical attendance;
 - (b) reduce the waiting period for fresh Passport issuance and for Renewals to a maximum of ten (10) working days or less; and
 - (c) ensure that only statutory charges are payable for services through officially designated channels.
- (*ii*) also urge the Federal Ministry of Foreign Affairs to streamline the activities of the nation's Embassies and High Commissions towards efficient service delivery to Nigerians abroad;
- (*iii*) mandate the Committees on Foreign Affairs and Diaspora to investigate the allegations and report back within two (2) weeks.

17. Need to Upgrade Kaltungo Snake Bite Center to a National Snake Bite Research and Treatment Centre: Hon. Karu Simon Elisa:

The House:

Notes that the Kaltungo Snake Bite Center is the only Centre in the North East among the few in the country that provides treatment and referral services to victims and experts on the poisonous and venomous snakes in Nigeria;

Also notes that the Kaltungo Centre has afforded researchers, experts and companies on tropical medicine the environment to conduct research and feasibility studies for establishment of study Centers and venom collections deposits:

Further notes that the EchiTab study groups in collaboration with the federal ministry of health has advanced interest towards the establishment of an anti-snake venom training and management Centre to serve students from the West African sub-region:

Aware that the Federal Ministry of Health has provides budgetary allocations for medical supplies and management of snake bites cases in the Centre:

Also aware that the North-East Development Commission has also provide periodic medical supplies and provisions to the Centre to augment growing demand for services of proper anti-snake bite management;

Concerned that the current status of the Centre's personnel and medical equipment is inadequate to sustain the growing demands for such services from the North Eastern Region and neighbouring countries;

Worried that the growing rate of casualties and deformities resulting from snakebite has contributed to the loss of jobs, increase in the poverty rate and consequently affecting socio-economic lives of the people;

Resolves to:

- (*i*) Urge the Federal Government to upgrade Kaltungo Snake Bite Center to a National Snakebite Research and Treatment Center and put in place modalities for the manufacturing of anti-snake venom at Kaltungo;
- *(ii)* also urge the North East Development Commission to facilitate sustained support in the provision of medical supplies and training of personnel;
- (*iii*) mandate the Committees on Health Institution and Legislative Compliance to ensure compliance

18. Urgent Need to Curb Incessant Kidnappings in Lagos and Other States Across the Country: Hon. Mufutau Adewale Egberongbe:

The House:

Notes that almost on a daily basis, Nigerians are faced with news of abduction of persons in different parts of the country;

Also notes that according to reports in the Vanguard Newspaper of September 29, 2021, there is a resurgence of kidnapping in Lagos state as many people were reported to have been kidnapped within a few weeks, with the kidnappers demanding huge ransoms;

Concerned that the kidnappers always escape with their victims through the waters and hide in the creeks as they wait for ransom

Disturbed that the kidnappings cut across all areas of the country as there have been several reports of the kidnappers blocking highways and attacking unsuspecting commuters;

Worried that when victims are taken into the various hideouts, the female victims are mostly raped while some victims are killed and their corpses abandoned in the bush;

Resolves to:

- (*i*) Urge the Federal Government to deploy special forces in the Nigeria Police Force, the Nigerian Army and the Nigerian Navy on a rescue mission to free the kidnap victims in Lagos and other parts of the country;
- *(ii)* also urge the Federal Government to carry out training of special Forces across the security agencies who will be mandated to patrol waterways, creeks and highways across the country;
- (*iii*) mandate the Committees on Police Affairs, Army and Navy to ensure compliance.

19. Urgent Need to Connect Kaura Local Government Area of Kaduna State to the National Grid: Hon. Mukhtar Zakari Chawai:

The House:

Notes the efforts of the Federal Government to reduce poverty by improving power infrastructure nationwide as over half of the country's population lacks access to stable power;

Also notes that the establishment of off-grid Power substations is a cost-saving short term solution by the Federal Government to provide the immediate energy needs of Nigerians;

Aware that lack of provision of basic amenities raises feelings of disaffection among the populace and leads to crime and insecurity;

Cognizant of the need to provide electricity to communities across Kauru Local Government Area of Kaduna State in order to boost employment opportunities, investments and engage the teeming youths;

Resolves to:

- (*i*) Urge the Rural Electrification Agency to intervene by installation of a Solar Mini-Grid Power System in Kauru Federal Constituency and the neighbouring communities;
- *(ii)* also urge the Transmission Company of Nigeria (TCN) to complete connection of transmission lines in the zone to the National Grid;
- (*iii*) mandate the Committee on Power to ensure compliance.

20. Need to Review Tertiary Institutions and Basic Education Curriculum to Meet Current Realities: Hon. Kolawole Taiwo Musibau

The House:

Notes the present Administration's towering efforts at improving access to basic education through the Universal Basic Education Programme as well as revamping the tertiary educational system;

Concerned that one of the major contributors to the high rate of youth unemployment in the country and its resultant effects is the non-functional educational system which appears not to prepare youths for gainful employment;

Also concerned that although most countries have realized the flaws in their educational system and are either changing or have adopted the fresh initiative to create a system that prepares youth for work and entrepreneurship, Nigeria's educational system seems to be stuck in a rut;

Worried that scholars, educationists and education administrators are either reluctant or unaware of the need to take urgent steps to improve on Nigeria's educational curriculum to positively impact the productivity of the country's youth;

Resolves to:

- (*i*) Urge the Minister of Education to direct all relevant agencies and institutions under its jurisdiction to update and develop functional educational curriculum for schools at all levels;
- *(ii)* mandate the Committees on Basic Education and Services and Tertiary Education and Services to ensure compliance.

Urge the Managing Directors/Chief Executive Officers of FCMB, GTBank, UBA and Zenith Bank to each pay Mrs Ikah Florence the sum of \aleph 1, 000, 000 only being the total amount fraudulently transferred from her account into various accounts of their customers whom the banks could not account for.

"That the House do consider the Report of the Committee on Public Petitions on the petition by Igahachi Development Association (IDA) against the Vice–Chancellor, Federal University, Lokoja, Kogi State on Non–Recognition as the Bonafide Host Community and Non–Compliance with the Corporate Social Responsibility to the Igahachi Community by the Institution and approve the recommendations therein" (*Laid: 9/11/2021*).

- (*i*) urges the House to uphold the Judgement of the Kogi State High Court sitting at Koton–Karfe Local Government Area of Kogi State in Suit No. HC/KK/02CV/2012 which awarded the disputed land to Igahachi Community;
- (*ii*) also urge the Vice Chancellor, Federal University, Lokoja, Kogi State and Director–General, Lands Kogi State Ministry of Works and Housing to implement the Court Judgement on the above subject–matter and to ensure due recognition is granted to the people of Igahachi Community on the on–going Corporate Social Responsibilities as per employment and compensation;
- *(iii)* further urge the Inspector–General, Nigeria Police Force to ensure immediate enforcement of the Court Judgment of the above subject–matter;

Minister of State for Petroleum Resources and Director, Department of Petroleum Resources and Petralon Energy Limited on Dawis Island Marginal Field and the Revocation of their Field License in April 2020 for failure to bring the Field into Production and approve the recommendations therein' (*Laid*:21/9/2021);

- (*i*) Urge the Hon. Minister of State for Petroleum Resources and the Executive Director of Department of Petroleum Resources to review the revocation process of Eurafric Energy Limited operating licence and proffer an amicable solution that will take care of all the parties involved in the Joint Operating Agreement in the production and development of the oil field in question;
- (*ii*) that for justice, fairness and equity to prevail in the Joint Operating Agreement among the parties involved, the Federal Ministry of Petroleum Resources, through the Department of Petroleum Resources should ensure that the Field in question be awarded to both existing parties in the Joint Agreement.
