Observes that some fundamental issues which require fresh legislative action on the Clause and in order to give Nigerians an enduring Electoral Act emerged; and

Relying on order 1(b) and order 52(6) of Senate Standing Order, 2022 as amended.

Accordingly resolves to:

Rescind its decision on the affected Clause of the Bill as passed and re-commit same to the Committee of the Whole for re-consideration and passage.
