MOTION FOR RE-COMMITAL

1. Re-Committal of the National Transport Commission (Establishment) Bill, 2022 (SB. 427) to the Committee of the Whole.

Sponsor: Sen. Abdullahi, Yahaya Abubakar (*Kebbi North-Senate Leader*).

The Senate:

Recalls that the National Transport Commission (Establishment) Bill, 2022 was passed by the Senate and the House of Representatives and sent to the President C-in-C but Assent was withheld with observations;

Observes that after critical examination of the observations by the Technical Team of the National Assembly and critical Stakeholders;

Desirous of the need to address these observations and make necessary amendments in order to rejig the transport sector of the economy; and

Relying on order 1(b) and 52(6) of Senate Standing Order, 2022 as amended.

Accordingly resolves to:

Rescind its decision on the Bill as passed and re-commit same to the Committee of the Whole for consideration and passage.
