*Considering* that Mr. President, C-in-C has since approved the establishment of the Federal Polytechnic Orogun, Delta State, and the institution is in the process of commencing academic activities; and

*Accordingly resolves to:*

*Rescind* its decision on the Bill as passed and re-commit same to the Committee of the Whole for re-consideration and passage.
