## **MOTIONS**

59. Urgent Need to Re-construct Jama'are-Azare Roundabout Along Kano-Bauchi-Maiduguri Expressway:

Hon. Bashir Uba Mashema:

#### The House:

*Notes* that security and welfare of citizens is the primary purpose of government;

Also notes that the Jama'are roundabout in Bauchi State links Yobe and Borno States making it a very busy and essential route for the transportation of goods and services within and outside Bauchi State;

Further notes that in 2006, the Federal Government awarded a contract for dualization of 600km road in order to ease the movement of people and goods;

Concerned that lack of a well-constructed roundabout at Jama'are, which links to Azare, has resulted in incessant accidents around the spot;

Also concerned that the topography of the area around Jama'are roundabout is so low that motorists are unable to see the river ahead until it becomes too late to avert a disaster:

Worried that the roundabout has led to incessant loss of lives as there are no road bumps or adequate signs to alert unsuspecting motorists;

*Cognizant* of the need to find a lasting solution in order to save lives of commuters plying the Kano-Bauchi-Maiduguri road, especially around Jama'are;

#### Resolves to:

- (i) Urge the Federal Ministry of Works and Housing to reconstruct the Roundabout at Jama' Are-Azare along Kano-Bauchi-Maiduguri Expressway to avert further accidents and needless loss of lives in the area;
- (ii) mandate the Committee on Works to ensure compliance.
- 60. Need to Revamp the Iyake Suspended Lake at Ado-Awaye in Iseyin Local Government Area of Ovo State:

Hon. Shina Peller:

#### The House:

*Notes* that tourism is a strong pillar of growth for the Nigerian economy with a contribution of 3.20 percent to the National Gross Domestic Product (GDP) and providing 2.70 percent of total employment in 2013, and according to the World Travel and Tourism Council (WTTC), it is envisaged to rise by 6.1 percent per annum from 2014 to 2024;

*Also notes* that in 2014, the World Travel and Tourism Council recommended adequate security, increase investment in infrastructure and tourist centers to boost tourism activities in the country.

Aware that Ado-Awaye Hill is a tourist destination that is under-utilized and neglected as there are several attractions including the Iyake suspended Lake, Ishage Rock, Elephant Tree, Ese Awon Agba (footprints of the elders), Esekan Iku, Isata Hill, and the Iya Alaro Lake, among others;

*Concerned* that the Iyake suspended Lake in Ado-Awaye, a very rare natural occurrence that has the potential of attracting tourists all over the world annually has been abandoned;

#### Resolves to:

- (i) Urge the Federal Government to make budgetary provisions in the 2023 Appropriation estimates to revamp the Iyake suspended Lake in Ado-Awaye;
- (ii) mandate the Committee on Culture and Tourism to ensure compliance.

# 61. Call on the Nigeria Broadcasting Corporation and the National Film and Video Censors Board to promote Indigenous Cultures and Moral Values: Hon. Sulaiman Abubakar Gumi.

#### The House:

*Notes* that the mass media, especially television, has a great influence on the socialization of children, adolescents and even adults and as such, is capable of also influencing the attitude, character, lifestyle and culture of individuals either negatively or positively;

Also notes that in order to enjoy the positive gains of the mass media, the Federal Government established the Nigeria Broadcasting Corporation and the National Film and Video Censors Board to regulate Broadcasting as well as censor films and video works;

*Further notes* that Section 2 (i) of the National Broadcasting Commission Act provides, amongst other functions, that the Commission shall have the responsibility of promoting indigenous cultures, moral and community life through broadcasting;

Aware that the National Film and Video Censors Board Act mandates the Board to censor films and video works as well as regulate and control cinematographic exhibitions in Nigeria;

*Concerned* that despite the measures put in place by the aforementioned agencies to regulate the mass media, there is an increasing level of negative influence, mostly on children and youth who are persuaded by Nigerian films and video works depicting various forms of aggressive and violent acts;

Also concerned that the recent trend of local movies showing long scenes of illicit practices like banditry, kidnappings, terrorism and ritual killings do not only contravene the broadcast code or guidelines but also form part of the root causes influencing immoral acts and illicit behaviors among Nigerian youths;

Worried about recent confessions by some youths who were arrested for various crimes, affirming the fact that there is a growing number of home videos and satellite movies illustrating immoral messages in local languages, thus causing more harm than good to the psyche of the young viewers;

### Resolves to:

Mandate the Committee on Information, National Orientation, and Ethics and Values to liaise with the Nigeria Broadcasting Corporation and the National Film and Video Censors Board to investigate the rise in the broadcast of materials depicting illicit messages with a view to mapping out more efficient ways to utilize the mass media as a major means of inculcating the desired form of indigenous culture, morals, and community life in the country and report back within four (4) weeks for further legislative action.
