MOTION FOR RE-COMMITAL

1. Re-committal of Proceeds of Crimes (Recovery and Management) Bill, 2022

The Senate:

Recalls that Proceeds of Crime (Recovery and Management) Bill, 2022 was passed by the Senate on Wednesday, 9th March, 2022;

Observed that some fundamental issues which require fresh legislative action emerged after a critical analysis of the Bill;

Considering the amendment that was made to Clause 74 of the bill which placed the Burden of proof on the investigating Agencies but not on the Defendant which was the recommendation of the joint Committee and contrary to the provision of Article 12(7) of the United Nations Convention against Transnational Organised Crime (UNTOC) which provides as follows:

"(7) 'States Parties may consider the possibility of requiring that an offender demonstrate the lawful origin of alleged proceeds of crime or other property liable to confiscation;" and

Relying on Orders 1(b) and 52(6) of the Senate Standing Orders 2022 (AS amended).

Accordingly Resolves to:

Rescind its decision on clause 74 of the Bill as passed and recommit same to the committee of the whole for reconsideration and passage.
