Amendments Proposed:

The House:

Noted that on Friday, 25 March, 2022, there was a horrific armed banditry attack at the Kaduna International Airport, culminating in the death of a security guard of the Nigerian Airspace Management Agency (NAMA);

Recalled that about a year ago, armed bandits attacked the staff quarters of the Federal Airports Authority of Nigeria (FAAN), at the Kaduna International Airport and abducted about 12 persons;

Observed that a combined detachment of the military and other security agencies were deployed to the airport to confront the heavily armed bandits, numbering over a hundred;

Also observed that the military personnel at the airport were timely enough to repel the attack, chased away the bandits and seized some of their motorcycles;

Acknowledged that unauthorized persons have been using the route behind the perimeter fence of the airport, until the recent attack, which unfortunately resulted in the loss of a life;

Cognizant that the Managing Director of NAMA Matthew Pwajok, noted that, though the bandits attacked the navigational aids in the airport, killed the watchman while the technical staff ran for safety, the military that were alerted responded swiftly to secure lives and properties at the airport;

Concerned that the armed banditry attacks at Kaduna International Airport if not checkmated, may escalate to other airports across the country;

Worried that if positive steps are not taken on airport security including management to urgently safeguard the airports from banditry attacks in line with international standards and International Civil Aviation Organization (ICAO);

Resolved to:

- (i) urge the Executive Arm of Government through the National Security Adviser (NSA), the Chief of Defence Staff, the Inspector-General of Police and Heads of other security agencies, to holistically intervene by setting up a Special Security Task Force on Airports and railway lines across the country;
- (ii) also urge the Executive Arm of Government to:
 - (a) engage on diplomatic relations to solve the insecurity affecting the country,
 - (b) be more proactive by pursuing the terrorists at their den rather than being reactive on all the terrorists in the country,
 - (c) declare a state of emergency in the security sector;
- (iii) further urge the Federal Ministry of Aviation, Ministry of Transportation, FAAN and other security agencies to adopt a more proactive measure in securing the airports, including providing a modern security surveillance equipment on the perimeter fences in all our airports;
- (iv) mandate the leadership of the House and Chairmen of relevant Committees to invite Heads of security agencies, Minister for Aviation, Heads of Aviation Agencies, and Minister of Transportation for an urgent meeting to tackle the current challenges at our airports;

Also informed that while discussions were on-going, an Army officer attached to the Company brought out his AK-47 Rifle and shot the deceased — Cyril Obirche (who died on the spot). The actions of the Army Officer triggered spontaneous protests and demonstrations by members of the community which led to breakdown of law and order;

(v) also mandate the Committee on Aviation to conduct an enquiry on the security needs of the Airport and recommend a marshal plan for the funding of security and safety of all Airports and report within four weeks;

Worried why the Army Officer in apparent display of raw power shot dead a harmless citizen of this country with impunity and without legal justification;

Concerned that despite the spate of insecurity in the country, officers and men of the Nigerian Army are stationed at a peaceful community and attached to a private company, Presco Plc — a palm oil producing company that purchases fresh fruit bunches and palm kernel from farmers, whereas such officer(s) ought to have been deployed to trouble spots of the country requiring army personnel to help combat insurgency and secure the lives and property of the people;

Believes that unless appropriate machineries are put in place to unravel why officers and men of the Nigerian Army are posted to guard private companies when their services are urgently needed elsewhere and also thoroughly investigate the circumstances that led to the gruesome murder of Master Cyril Obruche by the said Army officer with a view to bring the culprit(s) to book, the security of lives and property of the once peaceful Ovre-Eko community in Ethiope East LGA of Delta State may no longer be guaranteed;

Resolves to:

- (i) urge the Chief of Army Staff to forthwith redeploy the officers and men of the Nigerian Army attached to Presco Plc in Ovre-Eko community in Ethiope East LGA of Delta State;
- (ii) also urge the Inspector-General of Police to ensure that the Presco Plc immediately remove the gate it erected across the farm access road in the affected community to forestall further breakdown of law and order;
- (iii) further urge the Management of Presco Plc to compensate the deceased family without delay;
- (iv) mandate the Committee on Army to appraise why officers and men of the Nigerian Army are drafted to guard a private company knowing fully well that they are overstretched to meet the security demands of the country and also investigate the circumstances that led to the gruesome murder of Master Cyril Obruche and report within two (2) weeks (*Hon. Ben Rollands Igbakpa — Ethiope East/West Federal Constituency*).
