MOTIONS

6. Re-Committal of Nigerian Maritime Security Trust Fund Bill: Hon. Abubakar Hassan Fulata:

The House:

Notes that the Nigerian Maritime Security Trust Fund Bill was passed by the National Assembly and transmitted to the President for assent;

Observes that some fundamental issues which require fresh legislative action by the National Assembly emerged after a critical analysis of the Bill by the Presidency;

Cognizant of the need to recommit the Bill to address the fundamental issues raised in the Bill;

Resolves to:

Rescind its decision on the Bill as passed and re-commit same to the Committee of the Whole for reconsideration.

7. Need to Address Flood and Erosion Activities in Misau/Dambam Federal Constituency in Bauchi State: Hon. Ibrahim Makama Misau:

The House:

Notes that Diya and Misau in Dambam Federal Constituency of Bauchi State are constantly devastated by flood and erosion due to the destruction of the Dam in the area;

Also notes that the communities of Jalam, Dagauda, Dambam, Zadawa, Tofu, Hardawa, Gwaram, Akuyam, Kafin Sule, Beti, Ajili/Gugulin and some parts of Misau have suffered from floodings in recent times with devastating effects on lives, properties and the environment;

Concerned that the constant flooding and erosions, persistent heavy rainfall may be a result of the global effects of climate change;

Worried that the cultural heritage of the annual fishing festival, which is already negatively affected by annual flooding and erosion may be lost completely if the situation is not addressed;

Resolves to:

- (i) Urge the Federal Ministry of Water Resources and the Federal Ministry of Environment to include the affected areas in their mapping of erosion-prone areas immediately;
- (ii) also urge the Hadeja/Jama'are River Basin to include the affected communities in its 2022 policy on the reconstruction of dilapidated Dams across the country and consider re-drainage of Diya Dam in Dambam Local Government and Maladumba Dam in Misau Local Government Area;
- (iii) further urge the Ecological Fund Office to immediately commence the reconstruction of the erosion site in the affected areas in Misau/Dambam Federal Constituency;
- (iv) mandate the Committees on Environment and Ecological Fund to ensure compliance.

8. Call for Rehabilitation of Afaha Obonmg-Iwuem Federal Road in Akwa Ibom State: Hon. Aniekan Umanah:

The House:

Notes that economic activities thrive more in communities where there are good access roads for the movement of farm produce, goods and services from one point to another;

Also notes that the 41 kilometers Afaha Obong-Iwukem is a Federal Road that traverses Abak and Etim Ekpo Local Government Areas in Akwa Ibom State and is also a major connection to Aba in Abia State and Port Harcourt in Rivers State;

Concerned that the road has collapsed around the vicinities of Uruk Ata Ikot Ekpo, Etok Nto Obo and Obo Ekpo Communities in Etim and has caused untold hardship as motorists and commuters spend long hours due to its dilapidated state;

Recalls that the road was reconstructed in 2009 by the Government of Akwa Ibom State after over 50 years of neglect by the Federal Government;

Worried that the deplorable condition of the road has brought untold hardships to the people who rely on it to transport their goods and services;

Concerned that the distance which would have been covered in less than 30 minutes now takes several hours, especially around the failed sections of the road;

Cognizant that if nothing is done urgently to rehabilitate the road, it would continue to deteriorate and pose security threats to the lives of commuters, thus hampering socio-economic activities and growth in the area;

Resolves to:

- (i) Urge the Federal Roads Maintenance Agency (FERMA) to urgently intervene and rehabilitate failed portions of the Afaha Obong-Iwukem road to ease the hardship experienced by the people;
- (ii) mandate the Committee on FERMA to ensure compliance.

"That the House do consider the Report of the Committees on Tertiary Education and Services and Navy on a Bill For an Act to Establish Admiralty University of Nigeria, Ibusa as Conventional University with Selected Programmes, Limited and Focused Faculties to Promote Scholarship, Research and other Means of Advancement of Knowledge and its Practical Application to Military hardware and software as well as Maritime, Arts, Science and Technology, and Provide an Opportunity for Acquiring a Higher and Liberal Education in Nigeria; and for Related Matters (HB. 1339) and approve the recommendations therein" (*Laid:* 7/4/2022).

13. Committee on Petroleum Resources (Downstream) Hon, Abdullahi Mahmud Gava:

"That the House do consider the Report of the Committee on Petroleum Resources (Downstream) on the Need to Investigate the Importation and Distribution of Adulterated Premium Motor Spirit (PMS) into Nigeria and approve the recommendations therein" (HR.47/02/2022) (*Laid: 16/3/2022*).

- (i) That the Hon. Minister of Petroleum Resources should expedite action for completion of the rehabilitation work and ensure upgrading of the major refineries at Warri, Port Harcourt and Kaduna to meet AFRI5 Specification to boost local refining and reduce over-dependence on imported PMS into Nigeria to avert reoccurrence;
- (ii) that the Hon. Minister of State, Petroleum Resources should initiate the adoption of the 2017 PMS Standard (NIS 116:2017) as approved by the Standards Organization of Nigeria (SON) which include testing for Methanol for future importation of the product into the country to mitigate reoccurrence;
- (iii) that the Federal Government should position the Standards Organization of Nigeria (SON) to implement its mandate to the latter by subjecting all imported white Petroleum and other products to the Offshore conformity assessment and also resume routine quality control of them and other products imported into the country at our various Seaports, Airports and Borders throughout Nigeria as shrined in the Standards Organization of Nigeria enabling Act of 2015. This will finally address the reoccurrence of the importation of off-specification PMS and other substandard goods into Nigeria;
- (iv) that based on the Nigerian National Petroleum Company Limited exoneration, the Four (4) Oil Marketers/Importers (Duke Oil, MRS Oil and Gas, Oando Oil and Emadeb, Energy/Hyde/AY Maikifi/Britannia-U Consortium) did not commit any offense, therefore not recommended for suspension;
- (v) that the Federal Government is to note that the Standards Organization of Nigeria (SON) mandate is also specifically enshrined in item 62 (d) of Part I of the Second Schedule (Exclusive Legislative List), to the 1999 Constitution;
- (vi) that the Regulatory Authority in this case Nigerian Midstream and Downstream Petroleum Regulatory Authority (NMDPRA) should ensure proper housekeeping by working with Depot and Petroleum Products Marketers Association of Nigeria (DAPPMAN), Major Oil Marketers Association of Nigeria (MOMAN) and the Independent Petroleum Marketers Association of Nigeria (IPMAN) in ensuring water is drained regularly out of the tanks in the Tank Farms, Tankers (trucks) and underground tanks at the service stations;
- (vii) that the Nigerian National Petroleum Cooperation (NNPC) Limited shall maintain local supply and distribution of 90 Million liters daily across the country until normalcy is restored.
