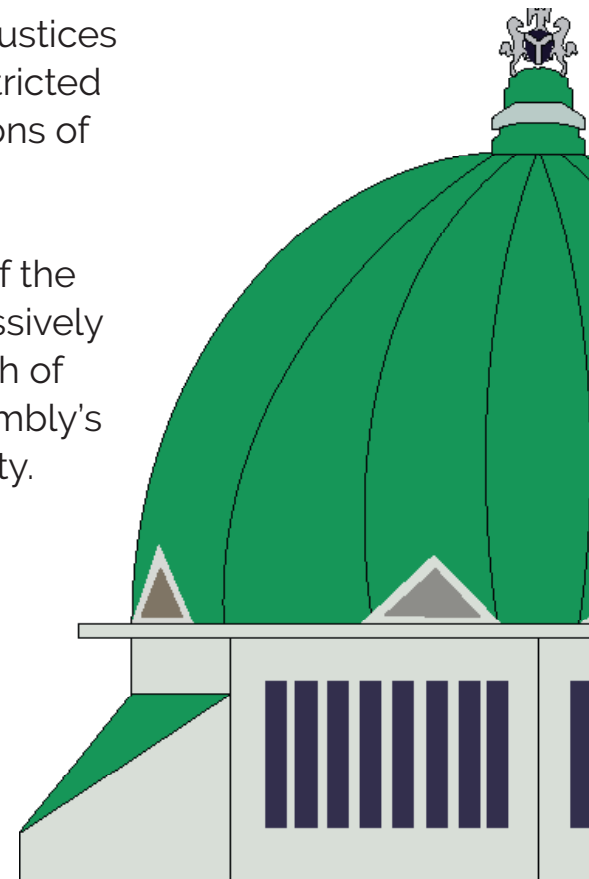


Introduction

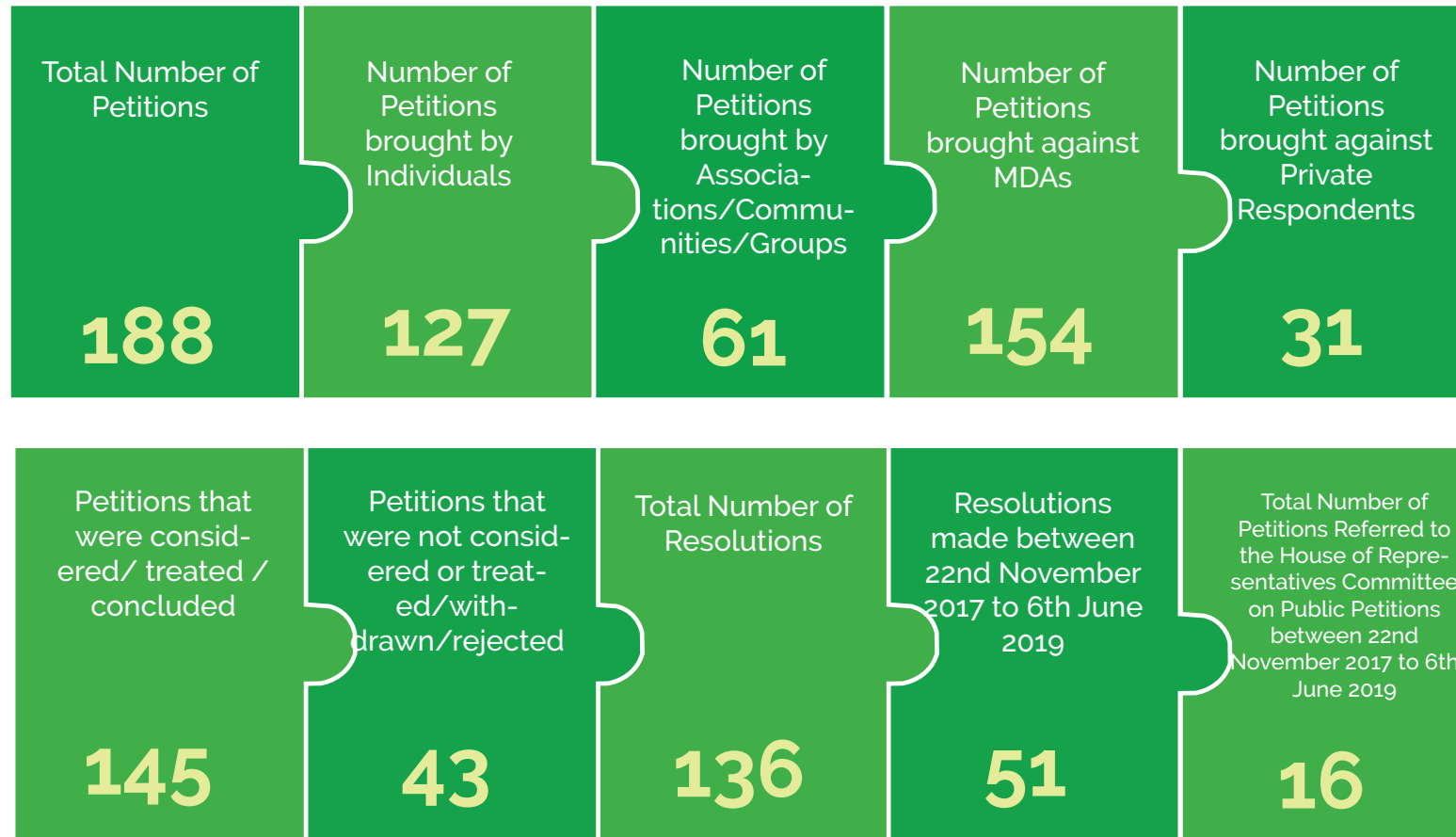
Since November 2017, Policy and Legal Advocacy Centre (PLAC) has supported the engagement of the House of Representatives Committee on Public Petitions with Nigerian citizens who have grievances against Ministries, Departments and Agencies of government (MDAs).

The Public Petitions Committee in the National Assembly is primarily established to receive petitions from members of the public who have suffered administrative injustices by MDAs and seek redress by the Committee. While the Committee is largely restricted to fact finding, its recommendations may be enforced where adopted as Resolutions of the House of Representatives.

This publication seeks to enrich the existing body of knowledge of the functions of the House of Representatives Committee on Public Petitions whose work has progressively increased to include petitions against private organisations /respondents in breach of citizens' fundamental rights. It is hoped that the analysis provided on the 8th Assembly's Resolutions will further increase citizen engagement and democratic accountability.



Analysis on House of Representatives Resolutions in the 8th Assembly



NOTE ON ANALYSIS:

- PLAC supported the 8th Assembly Committee on Public Petitions within the timeframe of 22nd of November 2017 to 6th June 2019.
- The compilation of Resolutions made by the 8th Assembly is from the electronic records emanating from the Committee.
- The Nigerian Liquefied Natural Gas Company (NLNG) (Petition Number 72), West African Examinations Council WAEC (Petition Number 112), and West African Portland Cement PLC (Petition Number 162) can not be classified as MDAs or Private Individuals. Thus, they were not included in the total number of Petitions against MDAs or Private Individuals.
- Petition Number 148 which is a petition against the Nigerian Police Academy was included when counting the number of petitions against the Nigerian Police Force.
- Petition Number 113 is against a private Respondent and three (3) MDAs. This was taken into account when calculating the number of petitions against Private Individuals and MDAs respectively.

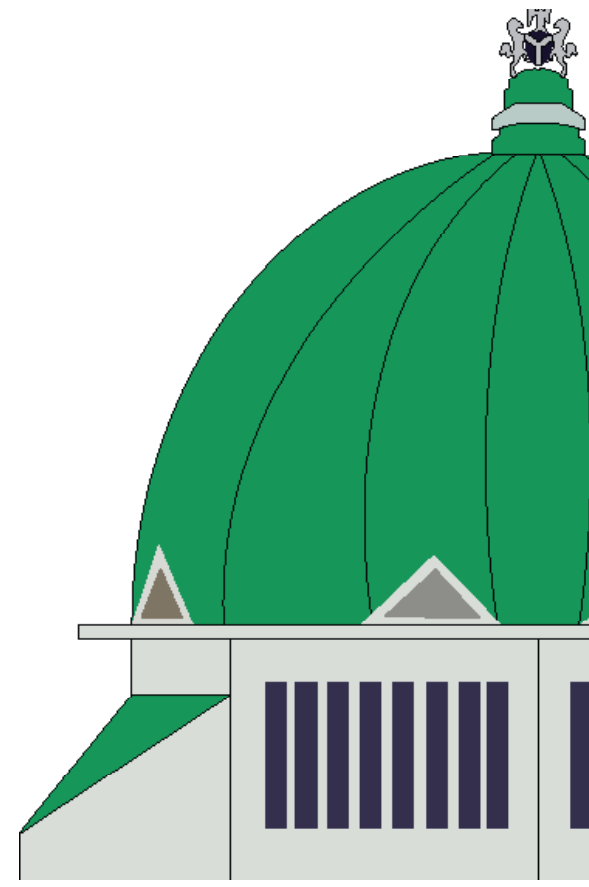
Conclusion
