# REPORT OF THE SENATE COMMITTEE ON INTERIOR ON NIGERIAN HUNTERS COUNCIL BILL (SB.477) 2022

#### 1.0 PREAMBLE

The Senate at its Plenary Sitting of Tuesday, 15th December, 2020, deliberated on the general principles of the Nigerian Hunters Council (Establishment, Etc.) Bill, 2020 **(SB. 477)** and referred same to its Committee on Interior for further legislative works. The Bill was sponsored by **Distinguished Senator Biodun Olujimi (Ekiti South)**.

### 2.0 OBJECTIVES OF THE BILL:

The objectives of the Bill include but not limited to:

- 1. Prevent and detect crimes and illegal activities going on in our Forests;
- 2. Work with Nigeria Police and other security agencies as forest securities network due to their knowledge of the terrains;
- 3. Make available relevant information on criminals' encroachment on Nigeria forests spaces to relevant authorities;
- 4. Partner with relevant stakeholders on Community policing.

# 3.0 COMMITTEE LEGISLATIVE ACTIONS:

In furtherance of its legislative action on the Bill, the Committee took the following decisions:

- i. Held meetings for the purposes of fashioning out modalities in carrying out the assignment;
- ii. Resolved to Conduct a Public Hearing on the Bill;
- iii. Convene a Meeting with the leadership of the organization;
- iv. Made publications in the Media (Prints, Electronic and Social) requesting for Memoranda as well as invitation to a public hearing;
- v. Conducted a one-day Public Hearing on the Bills.

## 3.1 PUBLIC HEARING:

On Tuesday, 18th May, 2021, the Committee conducted a Public Hearing which elicited the views of the Stakeholders and the general public on the merits and otherwise of the Bill. The Public Hearing was well attended even though restrictions were made to the number of persons in the hall as a form of adherence to COVID-19 protocol.

In a bid to ensure that interested persons were not left out; members of the public were encouraged to make written submissions available to the Committee through its Secretariat.

# 3.2 Memoranda Received During The Public Hearing:

The Committee received written Memoranda and Oral submissions from Government Agencies, Traditional Institutions, Religious Bodies, Academia, NGOs, other various interest groups and Individuals during the hearing.

One hundred and Sixty (160) written Memoranda and numerous oral submissions were received. Most of the written memoranda and oral presentations at the Hearing supported the establishment of the Nigerian Hunters Council.

The Ministry of Justice (Represented by the Solicitor General), in its presentation did not support the establishment of the Council. However, other Government Agencies present at the hearing overwhelming supported the Bill which was acknowledged as timely.

#### 4.0 CHANGE OF NOMENCLATURE:

The Committee in the course of its assignment, proposed an amended to the nomenclature of the organization which when adopted by the Senate will read the Nigerian Hunters and Forest Security Service (NHFSS), this is to reflect the present security realities.

# 5.0 OBSERVATION/FINDINGS:

The Committee made the following observations and findings in the course of its assignment:

- i. The core mandate and functions of the Council, among others, are to Prevent and detect crimes and illegal activities going on in our Forests;
- ii. The need to harmonize all hunters groups and associations in order to be captured and incorporated into this framework which will further foster peaceful coexistence and accountability of activities in our forests landscape;

- iii. Most Criminals such as bandits, insurgents, unknown gunmen etc operate within the city and return to hibernate in the forests;
- iv. Majority of the Stakeholders and the general public support the passage of the Bill into law in view of the enormous benefits the nation will derive;
- v. There are large expanse of our forests that are ungoverned or unprotected;
- vi. There is the need to develop comprehensive, multi-sectorial, multi-stakeholder and inclusive approaches in order to stem the trend of security challenges in the Country especially within the forest areas.

#### **6.0 RECOMMENDATIONS:**

The Committee's recommendations which reflect the majority of the memoranda and submissions received from the stakeholders and the general public during the public hearing are in the attached Bill.

The Committee having extensively considered the bill, recommends that the Senate do Consider and approve its recommendations as contained in the Bill attached to this report.

#### 7.0 CONCLUSION:

On behalf of the Senate Committee on Interior, permit me to appreciate the President of the Senate, **Distinguished Senator Ahmad Lawan, PhD, CON** and our Distinguished colleagues for the opportunity to serve the 9<sup>th</sup> Senate in this capacity and to humbly request that the Senate do consider and pass this Bill, accordingly.
