MOTION

1. Urgent need for the completion of the Junior Girls Model Secondary School Odu-Okpiyegede in Dekina LGA of Kogi State.

Sponsor: Sen. Isah, Jibrin (*Kogi East*)

Notes that the Fourth World Conference on Women, held in Beijing in 1995, identified the persistent discrimination against the girl-child and the violation of her rights as one of the 12 critical areas of concern, requiring urgent attention by the government and the international community, among which is the need for increasing girl-child education;

Further Notes that according to a recent World Bank Report, the female adult literacy rate (ages 15 and above) for Nigeria stands at 59.4% in comparison to the male adult literacy rate of 74.4%;

Aware that closing the gap in education and ensuring that more girls are educated is essential, not only for building a just society but also a pre-requisite for sustainable development;

Informed that education is the right of every girl-child, and a key to transforming her life and making her a responsible member of the society, without which she is denied the opportunity to develop her full potentials and play productive roles in the society;

Recall that in view of the significance of girl-child education, the Federal Government, in September 2014, commenced the process of establishing the Junior Girls Model Secondary School at Odu-Okpiyegede in Dekina LGA in Kogi State;

Further Recall that the contract for the construction works was awarded to LAMCO Nigeria Limited through the Kogi State office of the Sustainable Development Goals, and the construction work was completed in June 2016;

Cognizant that two blocks of twin hostels, comprising twenty four (24) rooms, with each room containing double-decker bed with capacity to accommodate 12 students per room, and 3 blocks of classrooms, comprising 13 classrooms, each containing 15 lockers for use of 30 students in a class on the basis of two students to a locker, as well as staff quarters of twin two-bedroom and three-bedroom flats, are all in place;

Regrets that despite the efforts of the Federal Government as indicated above, no attempt has been made since 2016 to ensure commencement of academic activities;

Further Regrets that some of the existing structures and facilities have started dilapidating, such as the collapse of the ceiling in almost all the classrooms, damage to some doors and windows as well as lockers, chairs, mattresses and pillows; and

Convinced that the completion of the school project and take-off of academic activities will boost the chances of the girl-child in accessing education in Dekina Local Government Area and the environ.

Accordingly resolves to:

Urge the Presidential Committee on Sustainable Development Goals to provide the required facilities, including the basic staff requirement for the take-off of the school in the next academic session.
