13. Discharge of Committees on Referrals on Bills, Pursuant to Order Seventeen, Rule 3(g) of the Standing Orders of the House of Representatives:

Hon. Abubakar Hassan Fulata:

The House:

Notes that the following Bills were read a Second time separately and referred to various Committees of the House for legislative actions, namely:

Aware that the Committees are yet to present Reports on the Bills, contrary to the provisions of Order Seventeen, Rule 3 (g) of the Standing Orders of the House of Representatives, to wit:

"Any matter referred to any Committee shall be treated within 30 days, otherwise the Committee shall stand discharged after 60 days and the matter committed to the Committee of the Whole for consideration."

Resolves to:

Discharge the Committees above mentioned from the Bills referred to them and commit same to the Committee of the Whole for consideration.

14. Need for Extension of the Mandate of the Special Ad-hoc Committee to Investigate the Petroleum Products Subsidy Regime (Pursuant to Order One, Rule1(2) of the Standing Orders of the House of Representatives:

Hon, Abubakar Hassan Fulata:

The House:

Notes that the *Ad-hoc* Committee on Petroleum Products Subsidy Regime was constituted on 31 June 2002 with the mandate to investigate the Petroleum Products Subsidy Regime in Nigeria to cover the periods from 2013-2021;

Also notes that the current administration has adopted a policy known as Direct Sales Direct Purchase (DSDP)/Swap Arrangement whereby crude oil is swapped for equivalent refined petroleum products while the other bye-products from the refined crude oil are not accounted for;

Concerned that the Committee's mandate was restricted to the periods 2013-2021 whereas most of the industry players claimed that they are not part of the DSDP arrangement within the periods of the Committee's mandate;

Disturbed that between January to June 2022, the government has spent about 1.545 trillion naira on subsidies, a period some of these industry players are involved in the DSDP contract;

Constraint that the Committee cannot extend the time to cover the periods outside its mandate;

Resolves to:

Extend the mandate of the *Ad-hoc* Committee on Petroleum Products Subsidy Regime to cover the period of 2013 to 2022 as well as Subsidy Payments and Forex Allocations from 2013 to date.

15. Need to Halt the Proposed Nationwide Ban on Commercial Motorcycles: Hon. Abubakar Makki Yallemen:

The House:

Notes that the security and welfare of the people shall be the primary purpose of government as clearly provided in Section 14(2)(b) of the Constitution of the Federal Republic of Nigeria, 1999 (as amended);

Concerned that the activities of bandits and kidnappings across the country have subjected members of victims' families to serious psychological trauma even as they are forced to part with their hard-earned money;

Aware that the proposed ban of Motorcycles across the country is aimed at cutting the supply of logistics to the terrorists in the country as disclosed by the Minister of Justice, Abubakar Malami SAN on 21 July, 2022 while addressing journalists;

Cognizant that while banning commercial motorcycle operations across the country as a means of curtailing security challenges, the welfare and wellbeing of the citizenry should be considered foremost, as the Federal Government has not offered palliatives measures to cushion the expected effects of the ban;

Worried that the proposed ban on motorcycle operations will render millions of Nigerians jobless, which could be catastrophic for a nation grappling with high unemployment and poverty rates;

Also worried that the ban will inflict untold hardships on the generality of Nigerians as it is a common means of transportation among the citizenry, and may provide the terrorists with a pool of desperate youths to recruit;

Disturbed that putting a sizeable number of the population out of work will only aggravate the security challenges in the country;

Commends the significant progress made by the Federal Government in tackling insecurity in the country as well as addressing corruption;

Resolves to:

- (i) urge the Federal Government to halt the proposed nationwide ban on Commercial Motorcycles and ensure that adequate palliative measures are put in place before such decisions are implemented;
- (ii) also urge the Federal Government to restrict the proposed ban to the Local Government Areas where the mining activities or banditry/terrorist activities take place;
- (iii) mandate the Committee on Legislative Compliance to ensure compliance.

16. Need to Adopt and Implement the "Silencing the Guns" Road Map: Hon. Ahmed Munir:

The House:

Notes that "Silencing the Guns 2030" is a flagship roadmap project adopted in Lusaka, Zambia in 2016 by the African Union with the aim of realising a Conflict-Free Africa by the year 2030;

Also notes that the concept of silencing the Guns is borne out of the observation that the African Continent is the scene of numerous violent conflicts that make the desired economic and political integration of the continent difficult. As part of the AU's Agenda 2063, the AU sought to ensure that Africa is characterised by peace, political tolerance and good governance;

Concerned that initially, the roadmap was to be achieved by 2020 of which the Continent fell short and the goal was further extended to 2030;

Cognizant that peace and security matters across Africa are interwoven and the Continent cannot afford to further miss the 2030 set target.

Resolves to:

- (i) urge the Federal Ministry of Foreign Affairs to fully embrace the report and ensure relevant Ministries, Departments and Agencies (MDA's) key into the roadmap;
- (ii) also urge the office of the National Security Adviser to fully adopt the report and cascade it down to other relevant Security Agencies;

(iii) mandate the Committees on National Security and Intelligence and Foreign Affairs to ensure compliance.
