MOTIONS

11. **Re-Committal of a Bill:**
Hon. Abubakar Hassan Fulata:

The House:

Recalls that the National Assembly Library Trust Fund (Establishment) Bill, 2020 was passed by the National Assembly and forwarded to the Directorate of Legal Services for further legislative action;

Notes that some observations were raised by the Directorate of Legal Services, National Assembly which require further legislative action by the House of Representatives;

Appreciates the need to recommit the Bill for reconsideration in order to address the observation raised;

Resolves to:

Rescind its decision on the Bill as passed and commit same to the Committee of the Whole for reconsideration.

12. Need to Complete the Construction of Ediene Abak-Ikot Ekan-Etinan Road Project:

Hon. Aniekan Umanah:

The House:

Notes that the 8.3 km Ediene Abak-Ikot Ekan-Etinan Road is a major link road between Abak, Etinan and other Local Government Areas in Akwa Ibom State;

Recalls that in 2012, the Niger Delta Development Commission (NDDC) awarded a contract for the reconstruction of the road, but was abandoned after minor earthworks at the Abak-Ediene end of the road;

Concerned that the deplorable state of the road has hampered the intra-state transportation system between Abak and Etinan Local Government Areas and the socio-economic livelihood of the people;

Informed that some miscreants and other criminal elements have taken advantage of the deplorable state of the road to rob innocent commuters of their hard earn valuables without any form of resistance;

Resolves to:

- (i) urge the Niger Delta Development Commission (NDDC) to ensure that work resumes on the site of the project;
- (ii) mandate the Committee on Niger Delta Development Commission (NDDC) to ensure compliance.

13. Need to Reconstruct the Collapsed Bridge in New Ndebiji and Calabar-Ekang Cameroon Highway, Cross River State:

Hon. Daniel Asuquo:

The House:

Notes that the bridge at New Ndebiji along the Calabar–Ekang–Cameroon Highway in Akamkpa Local Government Area of Cross River State had collapsed on August 28, 2022 resulting in a fatal accident and destruction of goods worth millions of naira;

Aware of the strong and undeniable nexus between road infrastructure and national and internal communication, integration and development;

Also aware that the bridge at New Ndebiji is one of the 20 bridges and culverts on the Calabar-Ekang-Cameroon Highway constructed by Costain Construction Engineering Company in 1956 and has outlived its lifespan and that is the third in the series of collapsed bridges on the Calabar-Ekang Road;

Worried that the Calabar-Ekang Road construction had enjoyed budgetary allocation for years without implementation and was re-awarded to Setraco Construction Company by President Buhari Administration and the company moved to site in mid-2021 but abandoned the project around March, 2022 after working on less than 3 kilometers of the road;

Disturbed that the collapsed bridge at New Ndebiji has cut off neighbouring communities in Akamkpa Local Government Area and equally cut off Nigeria from Cameroon via the Calabar-Ekang Road, with grim implications for commercial activities and livelihoods on both sides and grave security implications;

Cognizant of the need to reconstruct the collapsed bridge at New Ndebiji to forestall further loss of lives and destruction of properties to enable integration and resumption of commercial activities to eliminate the security threats the incidence has caused;

Revolves to:

- (i) urge the Federal Ministry of Works and Housing, and the Federal Roads Maintenance Agency (FERMA) to reconstruct the collapsed bridge;
- (ii) mandate the Committee on Works to investigate the circumstances surrounding abandonment of the construction of the Calabar-Ekang Road by Setraco Construction Company and report back within two (2) weeks for further legislative action;
- (iii) also mandate the Committee on Works to monitor the execution of the award for the full Re-construction of the Calabar-Ekang - Cameroon Highway.
